INDEPENDENT AUDITORS' REPORT

To the Trustees of
Apprentice FS, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Apprentice FS, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1 - Description of the Plan:

The following description of the Apprentice FS, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan established January 1, 2021, covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan allows for the employees of Apprentice FS, Inc. (the “Plan Sponsor” and “Company”) to participate in the Plan.

Plan Administration - The Plan is administered by the Plan Sponsor. The Plan’s assets were held by Matrix Trust Company from January 1, 2023 to February 12, 2024, and are held by Principal Trust Company (the “Custodians”) as of December 31, 2024 and from February 13, 2024 to December 31, 2024. The Custodians are responsible for the custody and management of the Plan’s assets.

Eligibility - Effective January 1, 2023, employees of the Company who have attained the age of 21 and obtained one month of service, except those covered by a collective bargaining agreement, a leased employee, or a nonresident alien, are eligible to participate in the Plan. Employees are eligible to participate in the employer safe harbor portions of the Plan upon completion of three months of service. The participant’s entry date is the first day of each month, upon completion of the eligibility requirements.

Effective February 1, 2024, employees of the Company who have attained the age of 21 and obtained one month of service, except those covered by a collective bargaining agreement, a leased employee, a nonresident alien, or an independent contractor who is later determined by the IRS to be an employee of the Company, are eligible to participate in the Plan. Employees are eligible to participate in the employer safe harbor portions of the Plan upon completion of one month of service. The participant’s entry date is the first day of each month, upon completion of the eligibility requirements. Employees may receive a qualified non-elective contribution of the Plan upon completion of one month of service and if they are active participants on the last day of the Plan year.

Contributions - Eligible employees may defer up to 100% of compensation as defined on a “pre-tax” basis and “after-tax” (Roth) basis subject to certain Internal Revenue Service (“IRS”) limitations. Participants who have attained age 50 by the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may elect to make discretionary matching contributions and safe harbor matching contributions. The Company will make safe harbor matching contributions equal to the sum of 100% of the amount of the participant’s elective deferrals for the first 1%, plus 50% of the participant’s elective deferrals not to exceed 6%. In addition, the Company may elect to make discretionary matching contributions to all employees meeting the eligibility requirements based on the ratio of the participant’s annual pay divided by the total annual pay of all participants receiving a contribution.

Safe harbor matching contributions totaled \$362,152 for the year ended December 31, 2024. There were no discretionary matching contributions for the year ended December 31, 2024.

Automatic Enrollment - All eligible employees are automatically enrolled in the Plan after meeting the eligibility requirements, unless otherwise indicated by the employee. Automatic enrollments set a pre-tax deferral contribution of 3% of an employee's compensation in the absence of an opt-out election or an otherwise completed enrollment form that the employee submits. The automatic pre-tax deferral shall increase by 1% annually, up to a maximum of 6%, unless a different deferral election is indicated by the employee.

Participant Accounts - Individual accounts are established for each plan participant. Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings/losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants maintain 100% vesting in their elective deferral contributions. Effective February 1, 2024, participants are always 100% vested in the part of their accounts resulting from safe harbor matching contributions and discretionary matching contributions.

Payment of Benefits - In most cases, upon termination of service due to death, disability, retirement or termination of employment, vested balances will be distributed to a participant or beneficiary either in the form of a lump-sum payment or installments directly from the Plan. A participant may request an in-service withdrawal upon attainment of age 59 ½.

Forfeitures - Forfeitures are created when participants terminate employment before becoming fully vested in their benefits under the Plan. Forfeitures may be used to pay plan administrative expenses or reduce the Company's employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$25,366 and \$24,782, respectively. During the Plan year ending December 31, 2024, the Company utilized approximately \$20,020 of forfeitures to pay for Plan administrative expenses.

Note 2 - Summary of Significant Accounting Policies:

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Cash and Equivalents - Cash and equivalents includes highly-liquid short-term investments purchased with maturities of three months or less.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan include recordkeeping fees, and administrator and investment advisory fees. Fees related to the administration of notes receivable from participants and withdrawals are charged directly to the participant's account and are also included in administrative expenses. Investment related expenses are included in net appreciation of the fair value of investments.

Payment of Benefits - Benefits are recorded when paid.

Hardship Withdrawals - The Plan provides for hardship withdrawals from the participants' vested balances. The withdrawal is not to exceed an amount required to meet an immediate need created by hardship, and then only to the extent that such immediate need cannot be satisfied by other sources reasonably available to the participant. Permissible circumstances for hardship withdrawals include medical expenses, purchase of a home, tuition payments, amounts necessary to prevent eviction from the participants' personal residence, and such other circumstances as the Plan Administrator may determine in accordance with IRS rules and regulations.

Risks and Uncertainties - Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan may have investments in funds with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage-backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

Concentration of Investment Risk - The Plan's investment in four and three funds comprises approximately 64% and 60% of total investments at December 31, 2024 and 2023, respectively.

Subsequent Events - The Plan Administrator has reviewed and evaluated all events and transactions from December 31, 2024 through October 14, 2025, the date the financial statements were available to be issued. The effects of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

Note 3 - Certified Investment Information:

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Custodians, qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment information included in the Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024, as shown on the ERISA-required supplemental schedule of assets (held at end of year).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

Note 4 - Fair Value Measurements:

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the closing price in the active market in which the fund is traded.
- *Common collective trusts*: Investments in regulated investment companies or other trust pooled funds are valued at the net asset per share/unit on the valuation date. The underlying assets of the trust are normally valued based on their closing sales price or, in the absence of sales, at their reported bid price. (See Note 5)
- *Pooled separate account*: Valued at its "accumulation unit value" ("AUV"). The separate account is valued daily as the number of accumulation units held multiplied by the AUV. There are no unfunded commitments at December 31, 2024 or 2023. Redemptions can be made daily and there are no other restrictions or penalties. (See Note 6)
- *Cash and equivalents*: Valued at the closing price in a similar market in which the fund is traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) In accordance with Subtopic 820-10, certain investments that were measured at either net asset value per share (or its equivalent such as accumulation unit value) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the Statements of Net Assets Available for Benefits.

Transfers Between Levels - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of level 1, 2, or 3.

Note 5 - Common Collective Trusts:

During 2024, the Plan entered into investment contracts through its common collective trusts ("CCT"). The CCT's fair value is a relevant measurement attribute. The CCTs held by the Plan are stable value investments which have an objective to preserve capital and to provide a competitive level of income over time that is consistent with the preservation of capital. To achieve this objective, the funds invest primarily in units of collective investment trust funds, affiliated investment companies and affiliated separate accounts. Redemptions are allowed for participants daily, however, in the event of a complete redemption, the Plan is subject to a one-year redemption notice period which may be waived by the Trustee. There are no unfunded commitments at December 31, 2024.

Note 6 - Pooled Separate Account:

During 2024, the Plan entered into a pooled investment contract with the Custodian. The Custodian maintains the contributions in a pooled account. The pooled account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses assessed by the Custodian. Redemptions are allowed for participants daily, however, in the event of a complete redemption, the Plan is subject to a one-year redemption notice period which may be waived by the Custodian. There are no unfunded commitments at December 31, 2024.

Note 7 - Notes Receivable from Participants:

Participants may borrow from their individual account balances in accordance with Plan provisions. The minimum loan is \$1,000, and the maximum amount of any loan shall not exceed the lesser of one-half of a participant's account balance, or \$50,000, and may not have more than one loan outstanding at any time. Loans are repaid via payroll deductions representing a combination of interest and principal sufficient to amortize the loans over their terms. Generally, repayment terms are not to exceed five years; however, if the loans are used to fund the purchase of a principal residence of the participant, the repayment period shall be no more than ten years. Loans bear a reasonable rate of interest as reflected by local banks and are collateralized by a participant's account balance.

Note 8 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain fully vested in their own contributions and in any employer contributions. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of such termination.

Note 9 - Tax Status:

The Plan was written on an IRS Non-Standardized Pre-Approved Document, which obtained its latest opinion letter on June 30, 2020 in which the IRS stated that the Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 10 - Party-in-Interest Transactions:

Certain Plan investment transactions are managed by the Custodian. The Custodian provides recordkeeping and administrative services to the Plan and, therefore, these transactions qualify as party-in-interest. Administrative expenses incurred by the Plan totaled \$35,275 for the year ended December 31, 2024.

Note 11 - Prohibited Transactions:

During 2024, the Company remitted participant contributions late to the Plan which totaled \$73,362. As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable, but in no event more than 15 business days following the end of the month in which the amounts are withheld from wages. The Company will take the proper corrective actions, in accordance with DOL regulations, to compensate those participants' lost earnings totaling approximately \$200 during 2025.

During 2022 and 2023, the Company remitted participant contributions late to the Plan which totaled \$375,898. As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable, but in no event more than 15 business days following the end of the month in which the amounts are withheld from wages. The Company will take the proper corrective actions, in accordance with DOL regulations, to compensate those participants' lost earnings totaling approximately \$1,000 during 2025.
