Independent Auditor's Report

To the Plan Trustees
UAW Retirees Health Care Plan

Opinion

We have audited the financial statements of UAW Retirees Health Care Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and plan benefit obligations as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits and changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

Note 1 - Plan Description

The following description of UAW Retirees Health Care Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established as of December 17, 2015 as a result of a court-approved settlement agreement (the "Settlement Agreement") between the International Union, United Automobile, Aerospace and Agricultural Implement Workers of America (UAW) and Staff Council of International Representatives; Office and Professional Employees International Union, Local Union 494; International Union, Security, Police and Fire Professionals of America Amalgamated Local 119; Staff Lawyers Union; and the Newspaper Guild/Communications Workers of America Local 34022 (collectively, the "Unions") in which the responsibility for providing postretirement benefits shifts from the prior UAW plan to the Plan. The Plan provides medical benefits to retirees who retired or who will retire in the future from the UAW with eligibility to receive postretirement benefits under the terms of the prior UAW plan and their eligible spouses, surviving spouses, and dependents and eligible surviving spouses and dependents of UAW employees who died or who die in the future prior to retirement and who are eligible for survivor medical benefits under the terms of the prior UAW plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2023, the UAW negotiated an early retirement incentive program for providing enhanced retiree medical benefits for members who elect to retire under the programs. As a result of this program, the UAW and the Plan agreed to an additional \$285,924 of funding in 2023 to the Plan to cover increased costs and expenses with respect to the revised eligibility provisions of the Plan.

Installment Note Receivable

The installment note receivable represented the remaining payments from the UAW under the Settlement Agreement. Subject to adjustment for accelerated payments, the installment note receivable was initially to be paid in equal quarterly installment payments of \$3,340,000, including interest, at an effective interest rate of 5.50 percent, over 15 years commencing on June 30, 2016. Under the Settlement Agreement, the installment note receivable is partially collateralized by certain assets of the UAW. Also, under the Settlement Agreement, the UAW can make discretionary accelerated payments at any time on the installment note receivable but is required to make accelerated payments annually with respect to sales of any real estate owned by UAW or its affiliated locals, as set forth in the Settlement Agreement. For each \$1 million in accelerated payments made by the UAW, the interest rate on the installment note receivable will be reduced by two basis points (0.02 percent).

During 2023, the UAW paid off the remaining note receivable balance in the amount of approximately \$79,000,000.

Health Benefits

The Plan provides health benefits (medical, hospital, surgical, prescription drugs, vision, and dental) to eligible retirees, spouses, surviving spouses, and dependents and reimburses certain participants for Medicare Part B premiums. The health coverage under the Plan for some participants is secondary to other coverage the participant may have from other UAW employers.

Termination

The Plan may be terminated at any time in writing by the committee, with a copy of such written instrument to be provided to the trustee. Upon termination of the Plan, the assets of the Plan shall be paid out at the direction of the committee in the following order of priority: (a) the payment of reasonable and necessary administrative expenses (including taxes); (b) the payment of benefits to participants entitled to payments for claims arising prior to such termination; (c) at the discretion of the committee, used in accordance with Section 501(c)(9) of the Internal Revenue Code and ERISA for the benefit of participants in such fashion as the committee determines; and (d) for charitable purposes.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Subsidies from U.S. Government

Since the prescription drug coverage offered by the Plan is considered creditable coverage or the actuarial equivalent of coverage offered under Part D of Medicare, the Plan participates in the Centers for Medicare & Medicaid Services' (CMS) Retiree Drug Subsidy (RDS) program. The RDS program offers subsidy opportunities to plan sponsors that provide prescription drug benefits to their Medicare-eligible retirees. For each qualifying retiree enrolled in the Plan during a plan year, the Plan will receive a subsidy of 28 percent of the allowable retiree costs in the plan year. Allowable retiree costs are determined by subtracting cost threshold reductions, cost limit reduction, and price concessions in order to arrive at an adjusted cost amount. The 28 percent subsidy is then calculated based on this adjusted cost amount.

RDS subsidies are recorded when earned as contributions from other sources in the statement of changes in net assets available for benefits. Amounts due that have not been received are recorded as a receivable in other assets in the statement of net assets available for benefits in the amount of \$906,611 and \$851,521 at December 31, 2024 and 2023, respectively.

Benefit Payments

Benefits are recorded when paid.

Refunds and Rebates

Prescription drug rebates and refunds due from the Plan's third-party claims processor are recorded when earned. Rebates and refunds due as of the financial statement date have been reported as a receivable in other assets in the statement of net assets available for benefits, with the offset being netted against claims paid in the statement of changes in net assets available for benefits.

Claims Incurred but not Reported

The Plan's liability for incurred but not reported (IBNR) claims is estimated by the Plan's actuary using payments made subsequent to year end in conjunction with historical trend and payment pattern information. IBNR is recorded in the accompanying statement of plan benefit obligations.

Note 2 - Summary of Significant Accounting Policies (Continued)

Postretirement Benefits

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to participants' service rendered to the date of the financial statements. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated participants and their beneficiaries and dependents and (2) active participants and their beneficiaries and dependents after retirement from service with the UAW. The postretirement benefit obligation represents the amount that is to be funded by existing plan assets, projected investment income, and participant self-payments. Prior to an active participant's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that participant's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The following prospective assumption for the annual rate increase is dependent on the type of coverage and benefits selected:

The annual rate of increase for 2024 ranged from 2.50 percent to 6.40 percent for pre-Medicare costs and from 1.50 percent to 6.90 percent for Medicare costs depending on the type of coverage and benefits, declining to an ultimate rate of 3.70 percent for both pre-Medicare costs and Medicare costs in 2074 and after.

The annual rate of increase for 2023 ranged from 5.80 percent to 11.70 percent for pre-Medicare costs and from 5.00 percent to 10.00 percent for Medicare costs depending on the type of coverage and benefits, declining to an ultimate rate of 3.70 percent for both pre-Medicare costs and Medicare costs in 2074 and after.

Other Changes

The decrease in the postretirement benefit obligation related to the change in actuarial assumptions of approximately \$22,400,000 for 2024 was the net result of a change in the discount rate and updates to the health care cost trend rate. The increase of approximately \$6,500,000 for 2023 was the net result of a change in the discount rate and updates to the health care cost trend rate. The impact of the Medicare Part D subsidy is a \$9,300,000 reduction in the postretirement benefit obligation at December 31, 2024 and a \$11,100,000 reduction at December 31, 2023.

Note 2 - Summary of Significant Accounting Policies (Continued)

The health care cost trend rate assumption has a significant effect on the amounts reported. If the assumed rates increased by 1 percentage point, it would increase the obligation as of December 31, 2024 and 2023 by approximately \$28,000,000 and \$34,000,000, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Risks and Uncertainties

The plan benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates, health care costs, and participant demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. It is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the financial statements.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 14, 2025, which is the date the financial statements were available to be issued.

Note 3 - Tax Status

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (the "Code"), and, accordingly, the trust's net investment income is generally exempt from income taxes. The trust has obtained a favorable tax exemption letter from the Internal Revenue Service, and the plan sponsor believes that the trust continues to qualify and to operate in accordance with applicable provisions of the Code.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Note 4 - Fair Value Measurements (Continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds and Money Market Fund

The mutual funds and money market fund are valued at quoted prices reported in active markets.

Common/Collective Trust Funds

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets.
