Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cold Spring Granite Company 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cold Spring Granite Company 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - DESCRIPTION OF PLAN

The following description of the Cold Spring Granite Company 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and Eligibility

The Plan is a defined contribution plan, under section 401(k) of the Internal Revenue Code (IRC), available to substantially all employees of the Cold Spring Granite Company (Coldspring) and participating employer Stone Panels International LLC (collectively referred to as the "Company") who are at least 18 years old and have completed 60 days of service beginning with the first date of employment. Plan entry dates are the first day of each month upon meeting the eligibility requirements. The Investment Committee is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2023, the Plan was amended for the following provisions:

1. Effective September 1, 2023, the Plan was amended to change the effective date of the annual auto increase to October 1st (previously December 1st).
2. Effective January 1, 2023, the Plan was amended to increase the automatic deferral enrollment to 10% (previously 9%). Participants who entered the plan prior to January 1, 2023, kept their current deferral.

Contributions

Participants may, after meeting eligibility requirements, contribute a percentage of their compensation up to 75%, subject to certain maximum individual limits. Effective January 1, 2023, participants were automatically enrolled to withhold 10% of their compensation if they have not completed a salary deferral agreement at the time they are eligible to make deferrals. The Plan automatically increases this percentage annually on October 1 (previously December 1) by 1% of their compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catchup contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

The Company may also make discretionary profit sharing contributions. Employees are generally eligible for an allocation of the profit sharing contribution if they are participating in the Plan, employed on the last day of the calendar year, and have completed 1,000 hours of service. No such contributions were made during 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Company's contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of the administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Employee contributions, including rollover contributions and investment earnings or losses on these contributions, are always fully vested. Participants become 100% vested in their Company matching contributions, profit sharing contributions, forfeiture amounts, and related investment earnings or losses upon attainment of one of the following conditions:

1. Reach age 65 and are still employed by the Company,
2. Termination of employment at an earlier age because of permanent disability,
3. Death,
4. Plan termination, or
5. Completing two years of service with the Company.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Forfeitures

Forfeitures attributable to matching contributions are used to reduce the Company's matching contribution in the year in which the forfeiture occurs. Forfeitures from profit sharing accounts are allocated to the profit sharing accounts of participating employees in the same way that other profit sharing contributions are allocated. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$88,570 and \$29,820, respectively. In 2024 and 2023, employer matching contributions were reduced by \$67,343 and \$70,729, respectively, from forfeited nonvested accounts.

Payment of Benefits

Participants may generally receive benefits from the Plan upon retirement, disability, death, or termination of service. Participants may elect to receive a lump sum amount equal to the value of their account or periodic installments. For account balances that are \$7,000 or less, the Plan administrator will authorize the benefit payment without the participant's consent. Participants may be entitled to receive in-service distributions also, if they incur a disability or are age 59½. In-service distributions are limited to one in any plan year.

Notes Receivable from Participants

Eligible participants may borrow against the value of their accounts. The maximum amount for any loan may not exceed the lesser of (1) \$50,000 less the difference between the participant's highest outstanding loan balance during the 12 month period ending on the day the loan was made and the participant's current outstanding loan balance on the day on which the loan was made or (2) 50% of the vested portion of the participant's account balance. The minimum principal amount for any loan is \$1,000. Only two loans may be taken in a calendar year and a participant may not have more than two outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reflected at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants valued as of the measurement date. The administrative committee and Plan administrator determine the Plan's valuation policies utilizing information provided by the Plan's investment advisor and trustees.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded using the accrual basis of accounting. Net appreciation represents the Plan's gains or losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Funding Policy

Company discretionary matching contributions are generally remitted to the Plan at the same time as employee deferrals. Any Company discretionary matching contributions relating to the "true up" are remitted to the Plan in the following year. Company discretionary profit sharing contributions are remitted to the Plan after the end of the Plan year as soon as administratively feasible.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The plan has evaluated subsequent events through October 15, 2025, the date which the financial statements were available to be issued.

NOTE 3 - CERTIFICATIONS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America, Empower Trust Company, LLC, Prudential Retirement Insurance and Annuity Company, and Prudential Bank & Trust, FSB, the trustees of the Plan.

On April 1, 2022, Empower Annuity Insurance Company of America (EAICA), formerly known as Great-West Life & Annuity Insurance Company, the parent company of Empower Retirement, LLC acquired the full-service retirement business of Prudential Financial, Inc. In connection with the transaction, EAICA acquired all shares of Prudential Retirement Insurance and Annuity Company and Prudential Bank & Trust, FSB, which are no longer affiliated with Prudential Financial, Inc. On October 3, 2022, Prudential Retirement Insurance and Annuity Company was renamed Empower Annuity Insurance Company. Effective March 31, 2023, Prudential Bank & Trust, FSB merged into Empower Trust Company, LLC, an Empower affiliate, and all services performed by Prudential Bank & Trust, FSB were assumed by Empower Trust Company, LLC.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 - FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Registered investment companies: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: valued at the NAV of units of the separate accounts at year-end. The NAV is used as a practical expedient to estimate fair value. There are currently no redemption restrictions on these investments. Participant transactions (purchases and sales) may occur daily.

NOTE 5 - TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated September 16, 2022, stating that the form of the pre-approved plan was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by the taxing jurisdictions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Empower Trust Company, LLC, Empower Retirement, LLC, and Empower Annuity Insurance Company of America (collectively, "Empower") provide certain administrative services. In addition, certain investments are shares of pooled separate accounts managed by Empower. These transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - PROHIBITED TRANSACTIONS

The Company failed to remit timely, certain employee deferrals and loan repayments to the Plan aggregating \$26,650 during 2024. The respective deferrals, loan repayments, and computed lost earnings were remitted to the Plan during 2024. The Department of Labor considers late deposits to be prohibited transactions.
