We have performed audits of the accompanying financial statements of Tata Communications 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of the Plan

The following description of the Tata Communications 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees, excluding residents of Puerto Rico, those covered by a collective bargaining agreement, leased employees and nonresident aliens not having United States source income, cooperative students or temporary employees, of Tata Communications, Net Foundry Inc. and Tata Communications (Guam) LLC (collectively the “Company” or “Employer”) and who have attained age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s assets are held in trust by Fidelity Management Trust Company (“Fidelity” or “Trustee”).

In January 2024, assets of \$13,583,769 were transferred in from The Switch Enterprises LLC 401(k) and in September of 2024 a portion of the assets of \$8,884,160 from the Insperty 401(k) Plan attributable to the employees of Kaleyra were transferred into the Plan.

Contributions

Each year, participants may contribute a portion of their eligible compensation on a pre-tax, Roth or after-tax basis, not to exceed 75% of their eligible annual compensation, as defined by the Plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Unless a participant elects otherwise, the Plan provides for automatic enrollment within the employee’s entry date at 5% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified plans.

Each plan year, the Company makes non-discretionary matching contributions. For the year ended December 31, 2024, the Company matched 100% of a participant’s contributions not to exceed 5% of eligible compensation.

In addition, the Employer may at its discretion elect to contribute an additional matching contribution and an additional non-elective contribution. For 2024, no additional matching or non-elective contributions were made.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings (losses). Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. All investments are participant directed.

Vesting

Participants are immediately vested in their contributions, Employer contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their account balance a minimum amount of \$1,000 up to a maximum amount of the lesser of 50% of their vested account balance or \$50,000 less the highest outstanding loan balance over the previous twelve months. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. The term of a loan can range from one to five years or up to ten years if the purpose of the loan is for the purchase of a primary residence. Principal and interest is paid ratably through payroll deductions.

Payments of Benefits

Upon termination of service due to death, disability, 59 1/2 or retirement, a participant may elect to receive either a lump sum amount, purchase an annuity or other annuity forms which may be available under the plan equal to the value of the Participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

Expenses

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net asset value ("NAV") of the respective investment vehicles and, consequently, those expenses are not separately reflected, but are a component of net appreciation in fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the NAV per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the pooled separate account which is valued at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The pooled separate account is valued at contract value, which represents contributions plus credited interest less participant withdrawals and fees. The Plan also offers a self-directed brokerage account in which participants may direct the purchase of shares of mutual funds and money market funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

Payment of Benefits

Benefits are recorded when paid.

Reclassifications

Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 presentation.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

4. Investments *(continued)*

The Plan invests in 17 common/collective trusts (the “Trusts”) with T. Rowe Price, Great Gray, MetLife and MFS. The NAV for each of these Trusts is determined each business day. Issuances and redemptions of units may be made on such days, based upon the NAV per unit as of the Trusts valuation date last proceeding the date on which such order to contribute or redeem assets is received. There are no unfunded commitments on the common/collective trusts at December 31, 2024 and 2023.

Pooled Separate Account

The New York Life Anchor Account (the “Account”) is a pooled separate account group annuity contract seeking to provide a low-risk, stable investment option. The Account offers participants competitive yields and limited volatility with a guarantee of principal and accumulated interest. Interest is accrued daily and credited monthly. The daily rate fluctuates based on the underlying separate account investments. The balance at contract value, at December 31, 2024 and 2023 amounted to \$3,896,228 and \$4,398,087.

No direct transfers from the Account to competing investment options are allowed. Competing options generally include money market funds, other guaranteed funds and bond funds with a duration of less than 3 years. Participants may deposit and withdraw on a daily basis at contract value.

Because the Account is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Account. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6. Income Tax Status

The Internal Revenue Service (“IRS”) issued an opinion letter to the prototype plan document preparer, FMR, LLC, dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the Internal Revenue Code (“IRC”). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Party-In-Interest Transactions

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan document and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

The Plan and Fidelity Management Trust Company entered into a revenue sharing arrangement whereby a portion of the revenue earned from certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay Plan expenses, the Plan created the Revenue Credit Account under the Plan. The Revenue Credit Account is a cash account within the Plan, similar in design to forfeiture accounts, and is used to record the redistribution of plan-generated fund revenue that exceeds the costs associated with Plan administration. The Revenue Credit Account balance was \$15,236 and \$6,402 at December 31, 2024 and 2023. During 2024, \$5,996 were used to pay Plan expenses from the Revenue Credit Account.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Employer at no cost to the Plan.

8. Prohibited Transactions

During the 2024 and 2023 Plan years, the Employer failed to remit to the Plan certain participants' contributions and loan repayments within the period described by the Department of Labor regulations. Delays in remitting the contributions and loan repayments to the Plan were due to administrative oversight. The Employer has made the necessary corrections for the delinquent participant contributions and loan repayments of \$136,281 by calculating and remitting lost earnings to the Plan.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
