NOTE A - SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: On March 1, 2024, the Genesis Networks Enterprises 401(k) Plan changed its name to Endeavor Managed Services 401(k) Plan (the "Plan"). The accounting records of the Plan are maintained on the accrual basis. These financial statements include participants who are employees of Genesis Networks Telecom, LLC, Genesis Networks Integration Services, Genesis Networks Global Services, LLC, dba WaveCrest, TeleSpace, LLC, Austin Tele-Services, LP, dba Genesis-ATS, Sova, Inc., and Endeavor Managed Services, Inc. (collectively, "Plan Sponsor").

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by investment advisers and the custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investments in guaranteed interest contracts are carried at contract value, which represents net contributions plus interest at the contract rate, less administrative expense. The contracts are fully benefit-responsive.

Participants' Notes Receivable: Participants' notes receivable are stated at their unpaid principal balance plus accrued interest. Interest is recognized as accrued. An allowance was not required at either year end. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the loan balance is reduced and a benefit payment to the participant is recorded.

Excess Contributions: Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions.

Payment of Benefits: Benefit payments are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the plan sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events: Subsequent events have been evaluated by management through the date of the independent auditor's report, the date the financial statements were available to be issued. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

Use of Estimates: The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements, and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

NOTE B - DESCRIPTION OF PLAN

The following description of the Endeavor Managed Services 401(k) Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and covers substantially all employees of the Plan Sponsor. Participants are auto enrolled in the Plan on the first day of the month following the completion of three months of service unless they formally opt out.

Plan Restatement: The Plan was restated effective June 1, 2022. The plan document has been amended with required regulatory changes including the most recent hardship distribution provisions and the SECURE, CARES, and CAA provisions.

Plan Amendment: Effective January 1, 2022, the Plan was amended to Include Endeavor Managed Services, Inc. as a participating employer of the Plan. The significant provisions of the Plan remained unchanged as a result of this amendment.

Termination: Although it has not expressed intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Contributions: Each year participants may elect to contribute 1% up to 90% of compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute (rollover) amounts representing distributions from other qualified defined benefit or defined contribution plans. Employees are automatically entered into the Plan with a deferral of 3% on the first day of the month following the date eligibility is met, unless the employee chooses not to participate. The deferral will be increased by 1% each year up to a maximum of 10% for those who do not opt-out or elect a different deferral rate. The Plan Sponsor may elect to contribute a matching contribution, the amount of which is determined by the Board of Directors and allocated based on each participant's contributions. The Plan Sponsor also may make QNEC contributions. Contributions are subject to certain limitations as defined by the Internal Revenue Service. No employer contributions were made in 2024 and 2023.

Participant Accounts: Investments are participant directed. Each participant's account is credited with the participant's contributions and allocations of (a) the Plan Sponsor's contributions and (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant contributions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after five years of credited service.

Investment Options: Upon enrollment in the Plan, a participant may invest in a number of mutual funds and change investment options daily at their discretion.

Participants' Notes Receivable: Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are collateralized by the vested balance in the participant's account, and bear interest between 4.25% and 9.50%. Principal and interest is repaid through payroll deductions with equal installments made each pay period.

NOTE B - DESCRIPTION OF PLAN (continued)

Payment of Benefits: On termination of service a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a period of time detailed in the Plan. Distributions are allowed at age 65, normal retirement age and in-service distributions are available to participants who are age 59 ½. Hardship withdrawals are also available subject to certain limitations.

SECURE 2.0: The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2024 and later. The Plan Administrator will determine the optional provisions to elect and amend the Plan document accordingly.

NOTE C - INVESTMENTS CERTIFIED BY THIRD PARTY (unaudited)

As permitted by Department of Labor CFR 2520.103-8, investments and participants' notes receivable at December 31, 2024 and 2023, and the related investment earnings and interest on participants' notes for the years then ended, were certified and held by Reliance Trust Company, the trustee, and were not audited by the independent auditor.

NOTE D - FAIR VALUE MEASUREMENTS

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in inactive markets
 - inputs other than quoted prices that are observable for the asset or liability
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means
 - if the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in methodologies used to determine fair value, nor transfers between levels. Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued based on quoted prices in an active market

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan has a benefit-responsive guaranteed interest contract, the Invesco Stable Asset Trust Fund (“the Trust”), with a balance of \$262,193 at December 31, 2024 and \$396,888 at December 31, 2023. The Trust maintains the contributions in a general account. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As the guaranteed interest contract is fully benefit-responsive, it is stated at contract value, the amount the participant would receive if they were to initiate permitted transactions under the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Contract value, as reported to the Plan by Reliance Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) full or partial plan termination, (2) a material adverse change to the provisions of the plan, (3) Sponsor elects to withdraw from a wrapper contract to switch investment providers or (4) if the terms of a successor plan do not meet the wrapper contract issuer’s underwriting criteria for issuance of a clone wrapper contract. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE F – INCOME TAX STATUS

The Plan sponsor adopted a plan which received a favorable opinion letter, issued to the document provider, from the Internal Revenue Service dated October 6, 2020, which states that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

GAAP requires Plan management to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

NOTE G - RELATED PARTY TRANSACTIONS AND TRANSACTIONS WITH PARTIES-IN-INTEREST

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees, fiduciaries, service providers, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers include the Plan custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the years ended December 31, 2024 and 2023, the Plan made direct payments to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

NOTE H - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE I - PROHIBITED TRANSACTIONS

As required by ERISA Section 2510.3-102, the Plan sponsor is required to segregate employee contributions and loan repayments to the Plan from its general assets as soon as practicable. For the years ended December 31, 2024, 2023, and 2022, the Plan Sponsor did not timely remit several participant contributions and loan repayments as outlined in the attached supplemental schedule of delinquent participant contributions. Contributions and loan repayments of \$7,446 in 2024, \$113,013 in 2023, and \$87,407 in 2022 were remitted late, and the lost earnings on the late remittances were corrected in August 2025.

NOTE J – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500
