## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Spray Products 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## 1. Description of Plan

The following description of the Spray Products 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan established October 1, 1997, and generally covers all employees except those covered by a collective bargaining unit. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Plan Administration** – Spray Products Corporation (the “Company”) is the Plan Administrator and is responsible for the general administration of the Plan.

**Plan Amendments** – Effective January 1, 2022 the Plan was amended and restated to bring the Plan into compliance with certain legislative and regulatory changes. Included for 2022 are changes to the hardship distribution and loan provisions of the Plan, including among other things, limiting participants to having only two loans currently outstanding, requiring a participant to certify eligibility conditions for a hardship distribution, and removing the requirement to: a) suspend contributions to the Plan after a hardship distribution; and, b) to first obtain a loan under the Plan before requesting a hardship distribution.

**Eligibility** – An employee becomes eligible to participate in the Plan after completing two consecutive months of service with the Company. An eligible employee who has satisfied the eligibility requirements noted above will become a participant in the Plan for all contribution types as of the first day of the month coinciding with or next following the date the eligibility requirements are satisfied.

**Contributions** – The Plan consists of a 401(k) salary reduction feature that allows participants to contribute a percentage of eligible compensation, as defined by the Plan, up to the maximum annual deferral allowed by the Internal Revenue Service (“IRS”) in the form of pre-tax and Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) from other qualified defined benefit or contribution plans.

The Company shall make a Safe Harbor matching contribution of up to 100% of the participant’s elective deferral contributions that do not exceed 6% of the participant’s annual eligible compensation, which shall be deemed the Employer’s Matching Contribution.

The Company, in its discretion and as determined by the Company, may also make profit sharing contributions to the Plan. There were no profit sharing contributions for the year ended December 31, 2024, in accordance with the Plan documents.

Participants direct the investment of their contributions into the various investment options offered by the Plan.

**Participant Accounts** – Each participant’s account is credited with the participant’s contributions, allocations of the Company’s contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** – Participants are immediately 100% vested in their deferral and rollover contributions plus actual earnings thereon. Subject to Safe Harbor requirements, participants are immediately 100% vested in the Company’s Safe Harbor matching contribution plus earnings thereon. Participants vest in discretionary non-elective employer and certain employer matching contributions as follows:

Participants will become fully vested upon death, disability or early retirement.

**Forfeited Accounts** – Any Company contributions forfeited may be used to reduce future Company contributions or to offset Plan expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$24, and \$-0-, respectively. For the year ended December 31, 2024, \$-0- in forfeitures were used to reduce employer matching contributions and \$-0- in forfeitures were used to off-set Plan administrative expenses.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participants account and bear a commercially reasonable rate of interest, which is commensurate with the local prevailing rates, as determined by the Plan Administrator. Loans are payable over a maximum period of five years unless the loan qualifies as a loan to purchase a residence, in which case a maximum thirty-year repayment plan is permitted. Principal and interest are paid ratably through bi-weekly payroll deductions.

**Payment of Benefits** – Upon termination of service due to, death, disability, retirement or early retirement, a participant may elect to receive a distribution of their vested account balance in the form of a lump-sum distribution, partial withdrawal, or as a substantially equal installment payment stream. In addition, participants may elect in-service withdrawals after reaching age 59-1/2 and participants are also permitted to make hardship withdrawals in certain cases of immediate and heavy financial need subject to limitations found in the Plan documents. Minimum required distributions for certain participants also apply per IRS regulations.

Terminated or deceased participants with a vested account balance equal to or less than \$1,000 shall be paid in a single sum as soon as administratively possible. Terminated participants with a vested balance greater than \$1,000 and less than or equal to \$5,000 shall be paid their vested interest in a direct rollover to an IRA designated by the Plan Administrator as soon as administratively feasible following severance of employment. As of January 1, 2024, terminated participants with a vested account balance greater than \$1,000 and less than or equal to \$7,000 shall be paid their vested interest in a direct rollover to an IRA designated by the Plan Administrator as soon as administratively feasible following severance of employment.

## 2. Summary of Significant Accounting Policies

**Basis of Accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – The Plan's investments are reported at fair value, see Note 4. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are reclassified as distributions based upon the terms on the Plan document.

**Payment of Benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. Expenses paid by the plan are reduced by forfeitures and amounts received for revenue sharing, see Note 1.

**Reclassifications** – Certain prior year amounts related to interest-bearing cash have been reclassified to conform to the current year presentation.

**CARES Act** – On March 27, 2020, President Trump signed into law the “Coronavirus Aid, Relief, and Economic Security Act” (“CARES Act”). The CARES Act, among other things, includes several relief provisions available to tax-qualified retirement plans and their participants. The Company has evaluated the relief provisions available to plan participants under the CARES Act and has implemented certain provisions for eligible participants. The Plan documents have been amended in order to incorporate the provisions of the CARES Act during 2023.

### 3. Information Certified by the Trustee

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, as an authorized representative of Ascensus Trust Company and Newport Trust Company LLC, a qualified institution.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the framework are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust Funds:* Units of common collective trust funds (“CCT”), including the stable value fund, are valued at their NAV, as a practical expedient to measure fair value, as determined by the issuers based on the fair value of the underlying assets within the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 6. Federal Income Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, however, the plan administrator and the plan’s tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Plan investments include a variety of investments that may directly or indirectly invest in securities with contractual cash flows. The value, liquidity, and related income of these securities are sensitive to changes in economic conditions and may be adversely affected by shifts in the market’s perception of the issuers and changes in interest rates.

## 8. Related-Party and Party in Interest Transactions

Certain plan investments are managed by the custodian and services are performed by affiliates of Ascensus, the recordkeeper of the Plan for which fees are charged; therefore, these transactions qualify as party in interest transactions. The Plan also holds notes receivable from participants, which qualify as related-party and party in interest transactions. Additionally, fees are paid to other services providers for investment advisory services. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA (exempt transactions).
