Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with U.S. GAAS, we:

1. Exercise professional judgment and maintain professional skepticism throughout the audit.
2. Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
3. Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
4. Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
5. Conclude whether, in our judgment, that there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule Of Assets (Held At End Of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that is agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

1. The form and content of the supplemental schedule, other than the information in the supplemental schedule that is agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
2. The information in the supplemental schedule related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by the institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following brief description of MHY Family Services 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

GENERAL

The Plan is a defined contribution plan covering eligible employees of MHY Family Services (the “Company”). Full-time employees and part-time employees, excluding non-resident aliens and students, may enter the Plan immediately for purposes of making salary deferral contributions. Participants are eligible to receive employer matching contributions when they have completed two years of service. Effective January 1, 2024, the Plan was amended to reduce the two years of service requirement to six months of service. Participants covered under a collective bargaining agreement are not eligible to receive an employer match contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

CONTRIBUTIONS

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan subject to limitations of the Internal Revenue Service. In addition, in any calendar year in which a participant is age 50 or above, an additional “catch-up contribution” (limited to \$7,500 for 2024) may be made. The Company makes a matching contribution each pay period to the Plan of 50% on the first 6% of compensation that a participant contributes to the Plan, for a maximum matching contribution of 3%. Effective January 1, 2024, the Plan was amended to make the matching contribution discretionary. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan.

Effective January 1, 2024, the Company may also make a discretionary nonelective contribution to the Plan as approved by the Board of Directors. To be eligible to receive a discretionary nonelective contribution, a participant must complete six months of service. There was no discretionary nonelective contribution made for the year ended December 31, 2024.

PARTICIPANT ACCOUNTS

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a person is entitled is the benefit that can be provided from the participant’s vested account.

VESTING

Participants are immediately vested in both their deferral contributions and the Company's matching contributions, as well as actual earnings thereon. Effective January 2024, the Plan was amended to implement a vesting period where participants are fully vested in the Company's matching contributions after four years of service.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow directly from The Teachers Insurance and Annuity Association of America ("TIAA") a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance in TIAA and College Retirement Equities Fund ("CREF"). The loans are secured by the balance in the participant's account in the TIAA Traditional Annuity Contracts. These loans are not shown on the accompanying statements of net assets available for benefits as these loans are not made from Plan assets and are therefore not considered Plan assets. Principal and interest are paid ratably by the participant to TIAA, and not through payroll deductions. There were no loans to participants collateralized by participant balances for the year ended December 31, 2024. Total loans to participants collateralized by participant balances were \$5,143 for the year ended December 31, 2023. As of December 31, 2023, \$5,143 of the loan balance was deemed in default.

Participants may also borrow from their fund accounts with TIAA a minimum of \$1,000 up to a maximum equal to or the lesser of \$50,000 or 50% of their vested account balance. If the loan is taken from the TIAA-CREF Annuity, the maximum loan amount is further limited to (1) 45% of the combined TIAA and CREF accumulation attributable to participation; (2) 90% of the CREF and TIAA Real Estate accumulation attributable to participation for Retirement Loans; or (3) 90% of the TIAA Annuity accumulation attributable to participation for a Group Supplemental Retirement Annuity loan. As of December 31, 2024, the rate on outstanding notes receivable was 4.25%. Principal and interest are paid ratably by the participant to TIAA, and not through payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence. Notes receivable are stated at their unpaid principal balance plus accrued unpaid interest. Delinquent participant loans are classified as distributions based upon the terms of the Plan document.

Participants may also borrow from their fund accounts with American United Life Insurance Company a minimum of \$1,000 up to a maximum equal to or the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the federal prime rate plus 2%. As of December 31, 2024, the rate on outstanding notes receivable was 5.25%. Principal and interest are paid ratably through bi-weekly payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence. Notes receivable are stated at their unpaid principal balance plus accrued unpaid interest. Delinquent participant loans are classified as distributions based upon the terms of the Plan document.

PAYMENT OF BENEFITS

Upon termination of service, disability, or retirement, a participant may elect to receive the vested interest in their account either in the form of a lump-sum payment, partial payments, installment payments not to exceed the life expectancy of the participant, or a life annuity. Participants may also elect to receive benefits from TIAA and/or CREF annuity accumulations. In addition, the Plan allows for hardship distributions if certain criteria are met.

ADMINISTRATIVE EXPENSES

Various administrative, accounting, and legal costs of the Plan are paid by the Company and are not allocated to the Plan, except for certain general administrative and maintenance fees.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The accompanying financial statements of the Plan are presented under the accrual method of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

INVESTMENT CONTRACT

The Plan holds an investment contract with American United Life Insurance Company (“AUL”) totaling \$95,941 for 2024 and \$79,082 for 2023. AUL maintains contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer. The interest rate is reviewed on a quarterly basis for resetting. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet financial obligations. The issuer’s ability to meet contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exempt under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

SUBSEQUENT EVENTS

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The Plan measures its investments at fair value on a recurring basis in accordance with accounting principles generally accepted in the United States of America. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework that authoritative guidance establishes for measuring fair value includes a hierarchy used to classify inputs used in measuring fair value. The hierarchy prioritizes the inputs used in determining valuations into three levels. The level in the fair value hierarchy within which the fair value measurement falls is determined based on the lowest level input that is significant to the fair value measurement.

The levels of the fair value hierarchy are as follows:

Level 1 – Fair value is based on unadjusted quoted prices in active markets that are accessible to the Plan for identical assets. These generally provide the most reliable evidence and are used to measure fair value whenever available.

Level 2 – Fair value is based on significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted market prices in active markets for similar assets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.

Level 3 – Fair value is based on significant unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- Registered investment companies (mutual funds) are valued at the quoted net asset value of shares held by the Plan at year end.

- TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to Plan participants. Each contract is fully and conditionally guaranteed by TIAA and CREF. The Traditional Annuity is offered through a variety of contract types, including Retirement Annuities (“RA”), Group Retirement Annuities (“GRA”), and Retirement Choice (“RC”) contracts which are non-fully benefit responsive. The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as guaranteed minimum interest rate, additional amount paid, the degree of liquidity of the participant’s account, and the options for receiving income upon retirement. Participants who have elected the Traditional Annuity contract have entered into non-fully benefit-responsive contracts with TIAA. TIAA maintains contributions in general accounts and accounts are credited with earnings on the underlying investments and charged with participant withdrawals and administrative expenses. TIAA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The non-fully benefit responsive contracts are reported at fair value. The contracts guarantee a 3 percent crediting interest rate. These contracts are subject to various restrictions, including surrender charges, timing restrictions, and withdrawals being required to be made in annual installments.
- Investments measured at net asset value (“NAV”): The pooled separate account is stated at fair value as determined in accordance with the policies and procedures reviewed by the investment committee of TIAA. The value of the units held in the pooled separate account is based on the market value of the underlying real estate holdings which are valued principally utilizing external appraisals and involve significant judgment. Appraisals can be subjective in certain respects and rely on a variety of assumptions and conditions at the respective property or in the market in which the property is located, which may change materially after the appraisal is conducted. The pooled separate account provides participants with a liquidity guarantee enabling the account to have funds available to meet participant redemption, transfers, or cash withdrawals. TIAA guarantees that participants can redeem their accumulation unit value determined after their transfer or cash withdrawal request is received in good order.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's assets are administered under contracts with TIAA and CREF and American United Life Insurance Company (the "Trustees"), parties-in-interest as defined by ERISA. Contributions are held and managed by the Trustees, who invest cash received. The Trustees invest investment income and make distributions.

Participants may borrow from their accounts and therefore these transactions also qualify as party-in-interest transactions.

Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA.

6. TAX STATUS

The Plan has been designed to qualify under section 403(b) of the Internal Revenue Code (“IRC”), and therefore, it is not currently eligible to receive a determination letter from the Internal Revenue Service. The Plan is required to operate in conformity with the IRC to maintain its qualification under section 403(b). The Plan Administrator believes the Plan is operating in accordance with the applicable requirements of section 403(b) of the IRC, and therefore, believes the Plan is qualified and the related custodial accounts are tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate Plan tax positions and recognize a tax liability (or asset) if the Plan has entered into an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Company analyzed the tax positions taken by the Plan, and possible recognition of a liability (or asset) or disclosure in the financial statements. Additionally, the Plan has not incurred any penalties by any taxing jurisdictions for any reason. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

7. INFORMATION CERTIFIED BY TRUSTEES

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2502.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, the Trustees have certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental schedule of Schedule H, Line 4(i) – Schedule Of Assets (Held At End Of Year) as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the year then ended. The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

8. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in various combinations of investment funds. Investment funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
