NOTE 1 - DESCRIPTION OF PLAN

The following description of 1618 Holding, LLC 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The plan administrator and trustee are responsible for the oversight of the Plan.

General

The Plan is a defined contribution plan covering all full-time employees of 1618 Holding, LLC (the “Sponsor”, “Company” or “Employer”) who are age 21 or older. The Plan was established in May 2010 and most recently restated and amended January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The plan trustee (Company officer designated in the Plan’s adoption agreement) is responsible for the oversight of the Plan.

Contributions

Subject to certain limitations, under Internal Revenue Code (“IRC”) Section 401(k), participants may contribute up to 60% of their annual compensation, subject to 2024 annual limits of \$23,000 and an additional \$7,500 for catch-up contributions for participants that are age 50 or older. Participants may also roll over amounts representing distributions from other qualified retirement plans. Participants may also contribute amounts representing distributions from other qualified retirement plans.

The Company makes discretionary matching contributions on a contributing participant’s elective deferrals as determined by the Company each year. In 2024 and 2023, the Company matched 100% of the elective deferrals up to a maximum of 3% of the participant’s eligible compensation and 50% of the elective deferral for greater than 3% and up to a maximum of 5% of the participant’s compensation.

Participant Accounts

Plan participants are offered a choice of various investment options and allowed to change their investment options daily. Each participant’s account is credited and/or reduced by the participant’s elective deferral contributions and distributions, the Company’s contributions, and an allocation of the Plan’s investment earnings/losses and investment fees and any administrative expenses paid out of the Plan. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided by the participant’s vested account balance.

Forfeited Accounts

Forfeitures occur when a participant terminates employment and has not fully vested in a portion of the Employer’s matching contribution amounts. Forfeitures may be used to reduce future Employer matching contributions or to pay plan expenses. As of December 31, 2024, the Plan did not have any forfeited non-vested account balances. The Employer did not use forfeitures to reduce their contributions for the plan year ended December 31, 2024.

Vesting

Participants are vested immediately in their contributions, any profit-sharing contributions and any matching contribution plus or minus actual earnings or losses thereon.

Investment Options

The participants direct the investment of their account balance and may select from various investment options maintained by ADP Retirement Trust Services, LLC. (“ADPRTS”), the custodian of the Plan. Participants may change their investment option selections on any business day, as defined by the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, not to exceed the lesser of 95% of half of their vested account balance or 95% of the total vested account balance excluding the Roth Election Deferral balance. The notes are secured by the balance in the participant’s account and bear interest at the prime rate plus 1% (8.50% at December 31, 2024), which corresponds with local prevailing rates as determined by the Plan’s administrator. The maximum note repayment period is five years, unless the note is for the purchase of a primary residence, in which case the repayment schedule may be for a term in excess of five years. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of Benefits

Upon termination of employment by reason other than disability or death, a participant is entitled to their entire account balance, which includes all of the vested Employer contributions allocated to the participant’s account and all gains or losses attributable thereto. If a participant terminates employment due to disability or death, the participant becomes fully vested and is entitled to their entire account balance as described above. Terminated participants may elect to receive a distribution of their vested benefits in a lump sum or in installments to satisfy required minimum distribution rules under the Plan. Participants should refer to the Plan document for a full description of the distribution methods offered by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of significant accounting policies followed in the preparation of these financial statements, which have been prepared in accordance with accounting principles generally accepted in the United States of America.

Basis of Presentation

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in cash and cash equivalents and mutual funds are stated at fair value. Investment contracts held by a defined contribution plan are required to be reported at fair value.

Notes Receivable from Participants

Principal and interest payments with respect to the notes are credited solely to the account of the borrowing participant from which the note was made. Participant notes receivable are measured at their unpaid principal balances plus any accrued interest, which approximates fair value. Delinquent notes are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain expenses incurred in the administration of the Plan are paid by the Sponsor. Expenses such as loan processing and investment transaction fees are charged directly to the participant's account. For the year ended December 31, 2024, administrative expenses incurred by the Plan totaled \$47,941.

Recently Adopted Accounting Standards

Effective January 1, 2023, the Plan adopted accounting standards update (ASU) 2016-13, Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments (FASB ASC 326), which significantly changed how entities measure credit losses for most financial assets. The most significant change in the standard is a shift from the incurred loss methodology to an expected loss methodology. Financial assets held by the Plan that are subject to the guidance in FASB ASC 326 were employer contributions receivable. There was no material impact to the financial statements as a result of the adoption of ASU 2016-13.

NOTE 3 – CERTIFICATION OF INVESTMENT INFORMATION

The Company has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA for 2024. ADPRTS, the custodian/trustee of the Plan has supplied the plan administrator with certifications as to the completeness and accuracy of all investment information reflected on the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, Fair Value Measurements and Disclosures, are described as follows:

Level 1: Quoted market prices in active markets for identical assets or liabilities.

Level 2: Observable market-based inputs or unobservable inputs that are corroborated by market data.

Level 3: Unobservable inputs that are not corroborated by market data.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Funds: These investments are public investment securities valued using the NAV provided by the Trustee. The NAV is quoted on a private market that is not active; however, the unit price is based on underlying investments, which are traded on an active market.

NOTE 5 - TAX STATUS

The Plan adopted a volume submitter plan which has received an opinion letter from the Internal Revenue Service (“IRS”), dated May 1, 2010, that the Plan is designed in accordance with applicable sections of the IRC. The Plan has not requested a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. The Plan administrator believes that the adopted and amended Plan continues to qualify and will remain exempt from federal income taxes under Section 401(a). As of December 31, 2024, with certain exceptions, the Plan is no longer subject to income tax examinations by U.S. federal taxing authorities for any tax years before 2021.

NOTE 6 - PLAN TERMINATION

The Sponsor reserves the right to modify, amend, or terminate the Plan at any time by resolution of its Board of Directors. In the event of termination of the Plan, all amounts credited to participants' accounts would be 100 percent vested and non-forfeitable (See Note 9). All participants would receive a total distribution of their accounts as described in the Plan.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. In 2024 and 2023, the Plan received its custodial/recordkeeping services from ADPRTS. As a result, the Plan holds investments managed by ADPRTS, the Plan custodian. These investments qualify as party-in-interest investments. The Plan's payments of custodian/trustee fees to ADPRTS during the year, as well as audit fees, qualify as party-in-interest transactions. Notes receivable from participants also represent party-in-interest transactions.

NOTE 9 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events and transactions that occurred after December 31, 2024 up to the date that the financial statements were available to be issued.

Management made an election in August 2025 to terminate the Plan. As of the report date, not all Plan assets have been fully distributed. At plan termination, all participant notes receivable balances will be offset against participant vested account balances. No change in accounting basis has been made to this report for this 2025 election.
