### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of RDR Utility Services Group 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### Note 1 – Plan Description

The following description of the RDR Utility Services Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of RDR Utility Services Group (the “Company”), formerly, RDR Energy Resources, LLC. Employees are eligible to participate in the Plan upon attaining age 21. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Contributions*

Each year participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, not to exceed the maximum allowable under the *Internal Revenue Code* (the “Code”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute Roth contributions or amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investments of all contributions into various investment options offered by the Plan.

The Company will make a safe harbor matching contribution equal to 100% of the participant’s elective deferrals that do not exceed 3% of the participant’s compensation, plus 50% of the amount of the participant’s elective deferrals that exceed 3% but do not exceed 5%. In addition to safe harbor matching contributions, the Company has the ability to make discretionary nonelective contribution to the Plan. To qualify for the discretionary nonelective contribution participants must have completed 1,000 hours of service in the Plan year and must be employed on the last day of the Plan year. The nonelective contribution is allocated among eligible participants based on a compensation ratio.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company matching contribution and (b) Plan earnings and losses, and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Vesting*

Participants are immediately vested in their elective contributions, rollover contributions, and safe harbor contributions plus actual earnings thereon. Vesting in the employer’s matching contributions and any discretionary contributions plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of service.

## Notes to Financial Statements

December 31, 2024

### *Payment of Benefits*

A participant, prior to separation from service, may elect a distribution of all or any portion (as permitted by the Plan) of a participant's account balance attributable to deferral contributions if the participant has attained the age of 65 or later of normal retirement age. On termination of service due to death, disability, retirement, or other, a participant is to receive a lump-sum amount equal to the value of the participant's vested account balance. A participant who has reached age 70 1/2 and is still employed may elect to commence retirement benefits as of that date. Additionally, the Plan requires involuntary cash-outs of \$5,000 or less upon termination of service.

### *Forfeitures*

Forfeitures are used to pay Plan expenses or to reduce future employer contributions. During 2024, \$35,248 of the forfeiture balance was used to reduce employer contributions. At December 31, 2024 and 2023, the forfeited account totaled \$1,062 and \$29,693, respectively.

### *Plan Amendment and Termination*

The Plan can be amended at any time provided such amendment does not permit the use of Plan assets for any purpose other than the benefit of Plan participants, reduce amounts credited to participant accounts, or allow Plan assets to revert to a contributing Company. The Company can terminate the Plan at any time. In the event the Plan is terminated, participants immediately become 100% vested in all amounts credited to their accounts.

### *Administrative Expenses*

Administrative expenses incurred by the Plan may be paid by either the Company or the Plan on a discretionary basis.

### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting.

## **Note 2 – Significant Accounting Policies**

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, the actual amounts could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investment bought and sold as well as held during the year.
