## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Trustee of  
Certified Languages International, LLC Employees Savings Trust  
Portland, Oregon

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Certified Languages International, LLC Employees Savings Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter — Supplemental Schedules Required by ERISA***

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Certified Languages International, LLC Employees Savings Trust (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan covering all employees of Certified Languages International, LLC (“the Company”), who are not nonresident aliens, leased employees, or residents of Puerto Rico, and who have completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Contributions consist of pre-tax and Roth elective deferrals, after-tax voluntary employee contributions, safe harbor matching contributions and discretionary employer nonelective contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Employee elective deferrals and the employer safe harbor matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Employees may voluntarily contribute up to the maximum amount allowed by law, limited to \$23,500 and \$22,500 in 2024 and 2023, respectively, as prescribed by the Internal Revenue Code (“IRC”). Participants aged 50 and older may elect to make additional catch-up contributions of \$7,500 annually. The Company made safe harbor matching contributions equal to 100% of each participant’s elective deferrals, not to exceed 3% of the participant’s eligible compensation, plus 50% of each participant’s elective deferrals that exceed 3% of the participant’s eligible compensation but do not exceed 5% of the participant’s eligible compensation. Participants who have completed one year of service and are employed by the Company on the last day of the Plan year are eligible for discretionary employer nonelective contributions, which are determined annually by the Company. In 2024 and 2023, the Company did not elect to make any discretionary employer nonelective contributions. In addition, contributions are subject to other limitations under the IRC.

**Participant Accounts** - A separate account is maintained for each participant, which is credited with the participant’s contributions, the Company’s contributions, and an allocation of Plan earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** - Participants are immediately vested in their voluntary contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company’s discretionary employer nonelective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. After two years of service, participants vest in the discretionary employer nonelective contributions at the rate of 20% per year of service and are 100% vested after six years of service. Participants are also 100% vested upon death, total and permanent disability or retirement.

**Payment of Benefits** - Upon termination of service or upon reaching retirement age, disability, or death, a participant may elect to receive a lump-sum amount, substantially equal installments, or partial withdrawals equal to the value of the participant's vested interest in his or her account. Upon reaching age 59½, participants may take in-service distributions of part or all of their elective deferral accounts. Additionally, prior to termination under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan from their elective deferral accounts. Account balances of terminated participants that are under \$1,000 may be automatically paid out at the discretion of the Company. Terminated participant balances between \$1,000 and \$7,000 may be transferred to an IRA, also at the discretion of the Company.

**Expenses** - Administrative expenses may be paid by the Company. Costs not paid by the Company are charged to participants' accounts. In addition, certain expenses of Plan administration, including computer services, professional fees, office supplies and payroll expenses of administrative and clerical personnel, are provided by the Company without charge to the Plan.

**Forfeitures** - Forfeited accounts generally are the result of the non-vested portion of discretionary employer nonelective contributions from terminated employees. The forfeitures are to be used to reduce future Company contributions. At December 31, 2024 and 2023 there were no forfeited non-vested accounts. Forfeitures of \$0 and \$1,936 were allocated to individual participant accounts in 2024 and 2023, respectively. There were \$0 of forfeitures used to reduce Company contributions in 2024 and 2023.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Investment Valuation and Income Recognition** - Investments are reported at fair value except for benefit responsive investment contracts, which are carried at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and management and operating expenses associated with the Plan's investments.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Benefit Payments** - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were no amounts payable to participants.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent Events** - The Plan's management has performed an evaluation of subsequent events through October 14, 2025, which is the date these financial statements were available to be issued.

### **NOTE 3 – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

#### **Basis of Fair Value Measurement**

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **NOTE 5 – GROUP ANNUITY CONTRACT WITH STANDARD INSURANCE COMPANY**

The Plan holds a group annuity contract with Standard Insurance Company (Standard). The Standard Stable Asset Fund D is a traditional fully benefit-responsive investment contract and accordingly is reported at contract value in the accompanying financial statements. Standard maintains the contributions in a general account. The group annuity contract provides for preservation of principal, maintains a stable interest rate, and provides daily liquidity at contract value for participant withdrawals and transfers in accordance with the provisions of the Plan. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

This contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of a contract issuer or otherwise. The contract value of the group annuity contract at December 31, 2024 and 2023, respectively, was \$372,868 and \$355,003. The crediting interest rate is based on a formula agreed upon with the issuer. The average yield was 2.11% and 1.83% for the years ended December 31, 2024 and 2023, respectively. On a quarterly basis, Standard declares a crediting rate for financial activity in the coming quarter.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) termination of the contract, (2) spin-offs, (3) divestitures, (4) layoffs, (5) corporate relocation, (6) partial or total plan termination, (7) retirement incentive programs, and (8) the liberalization of plan withdrawal or transfer rules. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The Plan may terminate the contract at any time with 30 days advance written notice to Standard. Standard may terminate the contract with 30 days advance written notice to the Plan for reasonable cause, which includes the Plan's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the Plan in a reasonable period of time. Upon termination by either party, the payout value may be subject to adjustment, either in a lump sum payment or in installment payments.

#### **NOTE 6 – NOTES RECEIVABLE FROM PARTICIPANTS**

The Plan makes loans to participants based on their vested account balances. Loans must be repaid within five years unless used to acquire a primary residence. Loans are payable through payroll deductions. Interest is charged at rates set by the Plan administrator commensurate with local prevailing rates and range from 4.25% to 9.50% at December 31, 2024. Loans are secured by the vested account balance of the participant.

#### **NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Standard Insurance Company. Standard Insurance Company is the recordkeeper and a custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for contract administration were \$4,360 and \$4,023 for the years ended December 31, 2024 and 2023, respectively.

#### **NOTE 8 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their discretionary employer nonelective contributions.

#### **NOTE 9 – CONCENTRATIONS, RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. There were three investments that individually represented more than 10% of the investments held as of December 31, 2024 and 2023. See the supplemental schedule of assets (held at end of year) for the complete listing of investments held as of that date.

#### **NOTE 10 – TAX STATUS**

The Plan document is an adoption of a non-standardized pre-approved profit-sharing plan sponsored by Standard Retirement Services, Inc. The Plan document obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since the opinion letter was issued, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 11 – PROHIBITED TRANSACTIONS**

During 2024, 2023, and 2022, employee withholdings and loan repayments totaling \$82, \$47,321, and \$163,938, respectively, were not remitted to the Plan within the appropriate time period required by the Department of Labor. These transactions constitute prohibited transactions as defined by ERISA. The Company is aware of the situation and has taken steps to correct 2023 and 2022 amounts totaling \$356 and \$98,542, respectively. The Company is also in the process of correcting the remaining 2024, 2023, and 2022 occurrences.
