## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Affiliated Plan Sponsors of  
**The Guardian Foundation, Inc. Retirement Plan**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of The Guardian Foundation, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (a "qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedules Required by ERISA**

The supplemental schedules, Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### NOTES TO FINANCIAL STATEMENTS

#### ( 1 ) Description of plan

The following description of The Guardian Foundation, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

**General** - The Plan is a defined contribution plan sponsored by The Guardian Foundation, Inc. ("Guardian") and the following organizations affiliated with Guardian for the benefit of their nonhighly compensated, nonunion employees who have completed three months of service and have reached age 21, as defined:

- Nassau Care Center, Inc. ("Nassau")
- Lighthouse of Revere, Inc. ("Lighthouse")
- Florida Care Properties, Inc. ("Florida Care")
- RBRC, Inc. ("RBRC")
- Pennsylvania LTC, Inc. ("PA LTC")
- Naamans Creek Care, Inc. ("Naamans")
- Central Florida Communities, Inc. ("CFC")
- Somerset Care, Inc. ("Somerset")
- AICC, Inc. (inactive)
- Health Systems, Inc. (inactive)
- Somerset Meadows, Inc. (inactive)
- Central Florida Group Homes, LLC ("CFGH")
- Progressive Rehab of PA, Inc. ("Progressive")
- CHR Consulting Services, Inc. ("CHR")
- Garden Health & Support Services, Inc. ("Garden")

Collectively, these organizations will be referred to as the "Affiliated Plan Sponsors." The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Guardian's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, may allow additional plan sponsors to participate in the Plan, and reports to Guardian's Board of Directors.

**Contributions** - Participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, up to the maximum dollar amount allowable by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated target date fund until changed by the participant. Automatically enrolled participants' deferral rates are increased annually by 1% up to a maximum of 10% unless the participant elects another deferral rate.

Each Affiliated Plan Sponsor may determine an employer matching and/or nonelective contribution formula for its employees who have completed six months of service, as defined. All Affiliated Plan Sponsors, with the exception of CFGH, have elected to contribute a minimum employer matching contribution of 25% of employee contributions up to 6% of compensation, as defined (CFGH pays no employer contributions).

( 1 ) Description of plan (continued)

**Contributions (continued)** - Certain Affiliated Plan Sponsors have elected to contribute employer matching contributions in excess of this minimum during the year ended December 31, 2024, as follows:

- One Affiliated Plan Sponsor matched 100% of participant contributions up to 8% of compensation, as defined.
- One Affiliated Plan Sponsor matched 30% of participant contributions up to 10% of compensation, as defined, for employees with over five years of service and matched 25% of participant contributions up to 10% of compensation, as defined, for all other employees.
- One Affiliated Plan Sponsor matched 100% of participant contributions up to 3% of compensation, as defined, plus 50% of participant contributions in excess of 3% but not greater than 5% of compensation, as defined.

Three Affiliated Plan Sponsors elected to make nonelective contributions equal to a fixed percentage of their employees' compensation, as defined, for the year ended December 31, 2024. Total nonelective contributions for these sponsors for the year ended December 31, 2024 were \$2,322,542, which were remitted to the Plan in July 2025.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**Participant investment account options** - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a fixed interest account as investment options for participants.

**Participant accounts** - Each participant's account is credited with the participant's contribution and allocations of: (a) the Affiliated Plan Sponsors' contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocation of the Affiliated Plan Sponsors' contributions is based on participant contributions and compensation. Allocations of Plan earnings and administrative expenses are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Except as described below, participants' contributions plus actual earnings are 100% vested immediately. Employer contributions are subject to the following vesting schedule:

All participants who were employees of the Affiliated Plan Sponsors prior to August 1, 2013, and were eligible to participate in the 401(k) or 403(b) plans previously sponsored by those entities, are subject to the vesting schedules of those plans. These vesting schedules range from immediate vesting of all contributions to a six-year graded schedule. Employer contributions become 100% vested immediately upon the occurrence of a participant's retirement, death, or disability, as defined.

#### ( 1 ) Description of plan (continued)

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are allowed to have a maximum of one loan outstanding. Loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits** - On termination of service due to death, disability, or retirement, as defined, a participant or their beneficiary(ies) may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account or annual installments over a specified number of years. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution. Account balances under \$7,000 for terminated participants can be distributed in a lump sum at the option of the plan administrator.

**Forfeited accounts** - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$902,003 and \$437,302, respectively. These accounts will be used to pay administrative expenses or reduce employer contributions. During the year ended December 31, 2024, \$68,885 of forfeited nonvested accounts were used to pay administrative expenses.

#### ( 2 ) Summary of significant accounting policies

**Basis of accounting** - The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value, except for the fixed interest account, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Guardian's Investment Committee determines the Plan's valuation policies utilizing information provided by the recordkeeper as agent for the custodian. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year ended December 31, 2024.

**Contributions** - Contributions from Plan participants and the matching contributions from the Affiliated Plan Sponsors are recorded in the year in which the participant contributions are withheld from compensation. Nonelective contributions are recorded in the year that they were declared effective by the Affiliated Plan Sponsors.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

#### ( 2 ) Summary of significant accounting policies (continued)

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses of the Plan are paid by the Affiliated Plan Sponsors and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

#### ( 3 ) Certified information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified by complete and accurate by Fidelity Management Trust Company ("FMTC"), the trustee of the Plan.

#### ( 4 ) Fair value measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, "*Fair Value Measurements and Disclosures*," provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include: quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

#### ( 4 ) **Fair value measurements (continued)**

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

As of December 31, 2024 and 2023, all of the Plan’s investments at fair value were mutual funds that are deemed to be Level 1 in the fair value hierarchy.

#### ( 5 ) **Group annuity contract with insurance company**

The Plan has a fully benefit-responsive group annuity contract with The Lincoln National Life Insurance Company (“Lincoln”). Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, the contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan); (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Affiliated Plan Sponsors or other Affiliated Plan Sponsors events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The plan administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with plan participants are probable to occur. The guaranteed investment contract does not permit the insurance company to terminate the agreement except under specified circumstances, which the Plan has not experienced through December 31, 2024.

#### ( 6 ) **Related-party transactions and party-in-interest transactions**

Certain Plan investments are managed by Fidelity Investments. FMTC, an affiliate of Fidelity Investments, is the trustee of the Plan. Transactions with the custodian and trustee qualify as party-in-interest transactions. Fees incurred by the Plan for these investment management services are included in net appreciation in fair value of investments. Fees incurred by the Plan to its parties-in-interest for recordkeeping services, audit fees, and investment advisory services during the year ended December 31, 2024, were \$236,706.

#### ( 7 ) **Plan termination**

Although it has not expressed any intent to do so, the Affiliated Plan Sponsors have the right under the Plan to discontinue their contributions at any time, and Guardian has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### ( 8 ) Tax status

The Internal Revenue Service (“IRS”) has determined that the prototype 401(k) profit-sharing plan is designed in accordance with applicable sections of the IRC and informed the recordkeeper of such in a letter dated June 30, 2020. The plan administrator has adopted the prototype plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that “more likely than not” would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan was transferred from Empower Trust Company, LLC to FMTC on November 15, 2023. There was an error in the mapping of investments between these custodians, and FMTC calculated and processed corrections and lost earnings owed to participant accounts that were invested in the incorrect target-date funds in April 2025. The plan administrator believes this matter will not impact the Plan’s tax status.

#### ( 9 ) Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

#### ( 10 ) Delinquent participant contributions

Plan sponsors are required to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer’s general assets. While the Affiliated Plan Sponsors remitted all employee contributions to the Plan, contributions of \$59,789 were not remitted within the required time period for the year ended December 31, 2023. The Affiliated Plan Sponsors have remitted all delinquent participant contributions to the Plan and remitted lost earnings in 2024.

#### ( 11 ) Operational failure

During 2024, the Company discovered an operational failure related to the incorrect mapping of investments by the recordkeeper. In November 2024, the Company switched recordkeepers resulting in the Plan establishing new target date fund investment elections. However, it was discovered that participants were not contributing to funds in alignment with their appropriate target retirement dates, resulting in incorrect benefit and earnings calculations for participants not contributing to the correct investment funds, which was considered a Plan operational failure.

In May 2025, the Plan reallocated forfeited accounts totaling approximately \$220,000 to impacted participants, and an additional correction payment of \$111,726 was paid by the recordkeeper to impacted participants to correct this operational failure. The Plan’s 2024 financial statements include the \$111,726 of other corrective contributions paid in May 2025 to correct this matter.

No provision of income taxes has been included in the Plan’s financial statements related to the foregoing matters because the Plan sponsor believes that the Plan continues to be qualified, and the tax status of the related trust continues to be tax exempt.

( 12 ) **Subsequent events**
