## INDEPENDENT AUDITORS' REPORT

To the Trustees  
Atlantic Medical Management, LLC 401(k) Profit Sharing Plan  
Jacksonville, North Carolina

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the **Atlantic Medical Management, LLC 401(k) Profit Sharing Plan** ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with U.S. generally accepted auditing standards (“GAAS”). **1 - DESCRIPTION OF PLAN**

The following description of the Atlantic Medical Management, LLC 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all full-time employees of Atlantic Medical Management, LLC, Jacksonville Children’s and Multispecialty Clinic, P.A., CCNC MM, LLC, and Coastal Carolina Neuropsychiatric Center, P.A., (“Company”), with the exception of non-resident aliens, independent contractors, and those covered by a collective bargaining agreement. Employees become eligible to make deferrals and receive related matching contributions once they have attained age 21 and have completed 300 hours of service during a three (3) month period, measured from their hire date, or successive three (3) month periods up until they complete 1,000 hours of service as defined in the Plan document. Plan entry dates are the first day of the month coinciding with or following the date the eligibility requirements are met.

**Contributions**

Plan participants may contribute to the Plan under a salary deferral arrangement. An eligible participant may elect to contribute up to 85% of pre-tax compensation to the Plan. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations. In addition, in any calendar year in which a participant is age 50 or above, an additional catch-up contribution may be made. The Plan also permits rollover contributions of retirement benefits received from other qualified plans and roth elective deferrals.

The Company has elected safe harbor nondiscrimination rules under the IRC and provides a non-elective contribution of 3% to the Plan based on eligible participant compensation.

The Company may provide discretionary matching and profit-sharing contributions as determined by the Company’s Board of Directors. Profit sharing contributions are allocated to participants based on their compensation as defined in the Plan document. Participants must be employed on the last day of the Plan year and have completed 1,000 hours of service to receive the discretionary matching contribution. There are no requirements for participants to be eligible to receive the discretionary profit-sharing contributions.

The Company did not make either a discretionary profit-sharing contribution or matching contribution in 2024 or 2023.

**Participant Accounts**

Participants direct the investment of their contributions and the Company’s contributions into various investment options offered by the Plan.

**Participant Accounts (Continued)**

Each participant's account is credited with their contributions, Company matching contributions, allocations of safe harbor contributions, discretionary profit-sharing contributions, and earnings thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions, safe harbor contributions, plus earnings thereon. Vesting in the Company's discretionary contributions, and earnings thereon are based on a five (5) year vesting schedule at 20% per year beginning upon completion of two (2) years of service.

**Notes Receivable From Participants**

Participants may request a loan from the Plan. The maximum amount that participants may borrow is equal to the lesser of \$50,000, reduced by prior outstanding loan balances, or one-half of their vested account balance. A participant may have two (2) loans outstanding at any time. The minimum amount a participant may borrow is \$1,000. Repayment terms generally may not exceed 5 years. Participant loans currently bear interest ranging from 4.25% to 9.50%. Participant loans are collateralized by the participant's vested account balance.

**Payment of Benefits**

Upon termination of service due to retirement, death, or other reasons, the participant's vested benefit is to be distributed in a manner, as defined in the plan document, chosen by the participant or beneficiary. If the participant's vested account balance is \$1,000 or less, payment is to be paid in a single sum. A terminated participant may also elect to retain their vested account balance with the Plan until required to take mandatory distributions at age 73.

Normal retirement age is 66; however, an active employee may begin to receive benefits at age 59½.

**Forfeited Accounts**

Forfeited balances of terminated participant's non-vested accounts may be used to reduce plan expenses or used to reduce the Company's contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts were not significant.

## **2 - SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Presentation**

The financial statements of the Plan are prepared on the accrual basis of accounting and are prepared in conformity with U.S. generally accepted accounting principles (“GAAP”) as promulgated by the Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”).

### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that may affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reported period. Actual results could differ from those estimates.

### **Cash and Cash Equivalents**

The Plan considers all short-term investments with initial maturities of three months or less to be cash equivalents. The Plan places its temporary cash investments with high credit quality financial institutions. At times, such investments may be in excess of the Federal Deposit Insurance Corporation (“FDIC”) insurance limit. The Plan has not experienced any losses in such accounts.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the investment advisors, the custodian, and the trustees of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### **Benefit Payments**

Benefits payments are recorded when paid.

### **Administration Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

**3 - FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024, and 2023.

*Self-directed Brokerage Accounts:* Accounts primarily consist of mutual funds that are valued on the basis of readily determinable market prices.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable Value Fund:* The Putnam Stable Value Fund, held in a collective trust fund, is comprised of fully benefit-responsive investment contracts, and is valued at the NAV of units of the collective trust. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**4 - CERTIFICATION OF FINANCIAL INFORMATION**

Alerus Financial, N.A., the custodian of the Plan, has certified that the following investment information included in the accompanying financial statements and supplemental schedule is complete and accurate:

**5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts. Any unallocated assets of the Plan will be allocated to participant accounts and distributed in such manner as the Company may determine.

**6 - TAX STATUS**

The underlying pre-approved plan provider received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the IRC. In accordance with IRS pronouncements, the Company has determined that it is eligible to, and has chosen to, rely on the current IRS opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its tax-exempt status. The Plan has been amended since receiving the opinion letter. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP prescribes rules for the recognition, measurement, classification, and disclosure in the financial statements of uncertain tax positions taken or expected to be taken in the Plan's tax returns. Management has determined that the Plan does not have any uncertain tax positions and associated unrecognized tax benefits that materially impact the financial statements or related disclosures. Since tax matters are subject to some degree of uncertainty, there can be no assurance that the Plan's tax returns will not be challenged by the taxing authorities and that the Plan will not be subject to additional tax, penalties, and interest as a result of such a challenge. Generally, the Plan's federal returns remain open for income tax examination for three years from date of filing.

**7 - RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect the participant's account balances and the amounts reported in the statements of net assets available for benefits.

**8 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Alerus Financial N.A. serves as custodian of the Plan's assets and, therefore, is a party-in-interest as defined by ERISA. The custodian provides custodial and recordkeeping services but does not exercise discretion over the investment of Plan assets. Fees paid by the Plan for these custodial services are included in administrative expenses and are either paid directly by the Plan or through investment income, as provided under the terms of the Plan. The custodian does not have discretionary authority over investment decisions or management of the Plan's assets.

**9 - DELINQUENT PARTICIPANT CONTRIBUTIONS**

In 2023, the Company failed to timely remit employee deferrals to the Plan in the amount of \$13,427. The Plan sponsor remitted \$2,500 to the Plan in 2024 and \$10,927 in 2025. The Company has computed the lost earnings on these deposits and contributed the lost earnings amount to the Plan during the 2025 plan year. The Plan did not record a receivable for these lost earnings as of December 31, 2024 or 2023, as the amounts were not significant.
