## Independent Auditor's Report

Plan Administrative Committee and Plan Participants  
Colorado River Indian Tribes Retirement Plan and Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Colorado River Indian Tribes Retirement Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS) and Government Auditing Standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS and Government Auditing Standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing the plan audit in accordance with GAAS and Government Auditing Standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

***Other Matter – Required Supplementary Information***

Management has omitted management's discussion and analysis that accounting principles generally accepted in the United States of America requires to be presented to supplement the basic financial statements. Such missing information, although not part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of the financial reporting for placing the basic financial statements in an appropriate operational, economic or historical context. Our opinion on the basic financial statements is not affected by the missing information.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental Schedule H, Part IV, Line 4i – schedule of assets held at end of year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS and Government Auditing Standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## 1) Description of Plan

The following description of the Colorado River Indian Tribes Retirement Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

### General

The Plan was established January 1, 1980, by the Colorado River Indian Tribes, a federally recognized Indian Tribe, and operates under the authority of Tribal Council. The Plan is a defined contribution plan covering all employees of the Colorado River Indian Tribes and its related enterprises (collectively the “Tribe”) who have satisfied the Plan’s service requirements and who are not independent contractors, collectively bargained or nonresident alien employees. For purposes of making elective deferrals and receiving employer contributions an employee enters the plan on the January 1<sup>st</sup> or July 1<sup>st</sup> that coincides with or follows the date on which the employee completes one year of eligibility service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Tribal Council serves as the Plan administrator of the Plan. As of December 31, 2024 and 2023, there were 1,102 and 1,072 participants, 1,071 and 1,042 of whom had account balances.

From January 1, 1980 through December 31, 2006, the Plan was documented and operated as a governmental plan in accordance with Section 414(d) of the Internal Revenue Code (IRC) and Section 3(32) of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2007, the Plan became subject to the provisions of Section 906 of the Pension Protection Act of 2006 (PPA). Although the Tribe maintains that the Plan continues to be entitled to governmental status following the passage of the PPA, the Tribe is operating the Plan as a nongovernmental plan effective January 1, 2007, pending further guidance from the U.S. Departments of Treasury and Labor. The Tribe is operating the Plan in accordance with its reasonable and good faith interpretation of the PPA, as required by IRS Notice 2006-89 and IRS Notice 2007-67.

### Contributions

Each Plan year, participants may contribute, subject to limits imposed under the Plan and the Internal Revenue Code, a percentage of their eligible compensation as a pre-tax or post-tax (Roth) contribution. Additional catch-up contributions may be made by participants who have attained age 50 before the end of the Plan year. Participants may also contribute rollover amounts from other qualified plans.

Effective January 1, 2024, the Plan was amended to change eligibility rules to provide that newly hired employees will enter the plan on the January 1st or July 1st that coincides with or follows the employee’s hire date.

The Tribe may make a discretionary matching contribution in any specific dollar amount and/or any specific percentage of a participant's elective deferral for a Plan year. Participants who have satisfied the service eligibility requirement are generally eligible for an allocation of the matching contribution for a Plan year if during the year they complete at least 1,000 hours of service and are employed on the last day of the Plan year. The Tribe elected to not make a matching contribution for the Plan years ended December 31, 2024 and 2023.

In addition, the Tribe may make a discretionary nonelective contribution to eligible participants for a Plan year. Participants who have satisfied the service eligibility requirement are generally eligible for an allocation of the discretionary nonelective contribution for a Plan year if during the year they complete at least 1,000 hours of service and are employed on the last day of the Plan year. For the years ended December 31, 2024 and 2023, the Tribe made nonelective contributions equal to 5% of a participant's eligible compensation.

### Participant Accounts

Each Plan year, a participant's account is credited with that participant's elective contributions, an allocation of employer contributions (if the participant has satisfied the allocation requirements for such contribution), credited with investment earnings, and debited with investment losses, associated with the participant's account, and debited with the participant's share of administrative expenses paid by the Plan. Plan expense allocations are based on participants' account balances and/or specific participant transactions. A participant's account may also include amounts transferred to the Plan from a terminated money purchase pension plan of the Tribe. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account.

### Investment Options

Upon enrollment in the Plan, a participant may direct contributions into any of the investment options offered by the Plan. Participants may change their investment elections each business day. If a participant does not make an investment election, their account will be invested in a default investment option as determined by the Plan administrator.

### Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Participants vest in the portion of their account representing the employer contributions and the earnings thereon based on years of service as follows:

### Forfeitures

Forfeitures available for allocation under the Plan may be used to reduce future employer contributions or pay administrative expenses under the Plan. The Tribe elected to use \$28,200 and \$0 of forfeitures to reduce the 2024 and 2023 employer contributions, respectively. No forfeitures were used to pay Plan administrative expenses in 2024 and 2023. As of December 31, 2024 and 2023, forfeited nonvested account balances were \$22,049 and \$8,473, respectively.

### Notes Receivable from Participants

Participants may borrow from their accounts credited with pre-tax and Roth after-tax contributions up to a maximum of \$50,000 not to exceed 50% of their vested balances in these accounts. The loan made to a participant is secured by the balances in these accounts of the borrowing participant. Loan terms range up to five years or longer if for the purchase of a primary residence, which may extend up to thirty years. Loan interest rates are determined by the Plan administrator by reviewing interest rates charged for similar types of loans by other lenders, which was prime rate plus 1%. Principal and interest is paid ratably through payroll deductions.

### Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount or installment payments equal to the value of the participant's vested interest in their account. A participant may withdraw all or a portion of their vested account in the event of financial hardship, as defined by the Plan. A participant may withdraw all or a portion of their rollover account, if any, at any time. The balance in a participant's money purchase pension plan account will be paid out in an annuity, unless the annuity form of payout is waived by the participant and his/her spouse, if any.

### Mandatory Cash-Out Provisions

If the amount of the participant's vested account balance to be distributed exceeds \$1,000 but is less than or equal to \$5,000 and the participant fails to timely elect a lump sum payment or direct rollover to a participant designated IRA, the Plan administrator will roll the entire vested balance to an IRA established by the Plan administrator at a qualified institution. Vested account balances of less than \$1,000 are distributed in cash directly to the participant without an election made by the participant. Effective March 15, 2025, the plan was amended to increase the mandatory cash-out provision from \$5,000 to \$7,000.

**2) Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting based on the accounting standards as promulgated by the Governmental Accounting Standards Board.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit responsive insurance contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gain and losses on investments bought and sold as well as held during the year.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Risk and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged to the borrower's participant account, recorded as administrative expenses, and are expensed when incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded as distributions when paid.

Administrative Expenses

The Plan permits, but does not require, the Tribe to pay significant costs of Plan administration. The Tribe paid a significant portion of the Plan's administrative expenses for the years ended December 31, 2024 and 2023, which are not included in these financial statements. Fees paid by the Plan for investment management services are included with net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through October 8, 2025, the date which the financial statements were available to be issued.

**3) Investments and Fair Value Measurements**

The Governmental Accounting Standards Board (GASB) issued Statement No. 72, *Fair Value Measurements and Applications*, which provides the framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* The pooled separate accounts (PSAs) are valued daily using publicly available quoted market prices, and participants bear the investment risks. Those PSAs investing in mutual funds or domestic equity securities are measured using quoted prices in active markets for identical assets. Those PSAs directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities. Although the PSAs are valued based on the net asset value (NAV) of underlying mutual funds or securities that are publicly available, the PSA unit prices are not traded in the public exchange market. Assets measured using NAV as a practical expedient are not assigned a level in the fair value hierarchy. Management has determined that the investments using NAV as a practical expedient do not have published prices and; therefore, the investments are not included in the fair value hierarchy. These investments have no unfunded commitments as of December 31, 2024 and 2023, respectively, and can be redeemed daily with no redemption notice period or other redemption restrictions.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment valued at NAV as a practical expedient as of December 31, 2024 and 2023, were \$26,962,431 and \$24,121,040, respectively.

## 4) Information Prepared and Certified by the Custodian (Unaudited)

The administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was obtained or derived from information provided to the Plan administrator by Transamerica Life Insurance Company Inc, the custodian of the Plan, a qualified institution, and certified as complete and accurate:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants reflected on the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments and participant notes receivable reflected on the supplemental schedule of assets held at end of year.

## 5) Investment Contract with Transamerica Life Insurance Company

The Plan has a fully benefit-responsive group annuity contract with Transamerica Life Insurance Company (TLIC). TLIC maintains the contributions in a general account. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is determined by the issuer.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed prior to January 1 and July 1 with the effective annual rate of interest established for the corresponding six-month period. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for each six-month period. There is no stated minimum or maximum interest rate for the Stable Value Core investment choice.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Contract value, as reported to the Plan by TLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Average yield earned by the Plan for the fully-benefit responsive group annuity contract with an adjustment to reflect the actual interest rate credited to participants is calculated by dividing annualized earnings credited to participants by the fair value of the contract. The average yield based on actual earnings and crediting interest rate credited to participants for 2024 and 2023 was approximately 1.6% and 1.2%, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**6) Plan Termination**

Although it has not expressed any intent to do so, the Tribe has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to ERISA. In the event of Plan termination, participants would become 100% percent vested in their employer contributions and earning thereon.

**7) Income Tax Status**

The Plan is operating under a prototype document with a nonstandardized adoption agreement. The Internal Revenue Service has determined and informed the prototype plan sponsor by an opinion letter dated June 30, 2020, that the prototype plan, as then designed, is in compliance with applicable sections of the Internal Revenue Code (IRC). The Plan is relying on the opinion letter of the prototype sponsor. The Plan sponsor and Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's management believes the Plan is generally no longer subject to income tax examinations for years prior to 2021.

## **8) Related-Party and Party-in-Interest Transactions**

Certain Plan investments are managed by Transamerica Life Insurance Company, the Plan's custodian. These transactions qualify as exempt party-in-interest transactions. The Tribe provides certain accounting and administrative services to the Plan for which no fees are charged.

Fees paid by the Plan for administrative services for the years ended December 31, 2024 and 2023, amounted to \$198,818 and \$174,471, respectively.
