## INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of the  
High Watch Recovery Inc. 403(b) DC Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of the High Watch Recovery Inc. 403(b) DC Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the High Watch Recovery Inc. 403(b) DC Plan (the “Plan”) is provided for general information purposes only and is not intended to be a complete description of the Plan. Participants should refer to the Plan document and related amendments for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan, which was formed effective November 1, 2001, and is sponsored by High Watch Recovery Center, Inc. (the “Employer” or “Company”) and available to employees of the Employer. Eligible employees may begin to make salary deferral contributions immediately and become eligible to receive Employer safe harbor contributions after attaining age 21 and following the completion of one year of employment (with a minimum of 83 1/3 hours completed each month). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Teachers Insurance and Annuity Association of America/College Retirement Equities Fund (“TIAA-CREF” or the “trustee”) is the trustee and a third-party administrator for the Plan.

Contributions – Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan. Eligible employees may also elect to have all or a portion of their salary deferral contributions designated as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may, at its discretion, make matching contributions to the Plan. For the year ended December 31, 2024, the Company made a safe harbor contribution equal to 3% of the participant’s compensation and an additional matching contribution equal to the participant contribution, but not exceeding 6% of participant compensation.

Participant Accounts – Each participant’s account is credited with the participant’s contributions, Employer matching contributions, Employer safe harbor contribution, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Vesting – Participants are vested immediately in their contributions and Employer matching contributions, plus actual earnings thereon.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rates, determined quarterly, range from 4.25% to 9.50%. Principal and interest is paid ratably through monthly payroll deductions. Participants may not have more than 3 loans at a time.

Prior to 2020, TIAA-CREF provided loans directly to participants which are secured by the participant’s account balance that is segregated in the participant’s general account but are not distributed from the account. The participant’s vested balance is used to collateralize the participant loan and the funds are transferred, within the Plan assets, to the general account. The amount of Plan assets used to collateralize the loans was \$17,047 and \$28,370 at December 31, 2024 and 2023, respectively.

## **NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)**

Payments of Benefits – Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's interest in his or her account, periodic installments or an annuity distribution available under the applicable funding vehicle. For termination of service for other reasons, a participant may receive the value of the interest in his or her account as a lump sum distribution. Withdrawals from a participant's salary deferral account may also be made in the event of a financial hardship, or for adoption or childbirth expenses, in accordance with the provisions specified in the Plan. Additionally, participants who are at least 59½ years of age may withdraw all or a portion of the balance in their account prior to termination for any reason.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value, except the insurance company general contract that is fully benefit-responsive which is reported at contract value (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date-basis. Interest income is recorded on the accrual basis. Net appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events – The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

*Level 1 Fair Value Measurement - Registered investment companies (mutual funds):* The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must to publish their daily net asset value (“NAV”) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Level 3 Fair Value Measurement - Insurance company general contracts (non-benefit-responsive):* Valued at contract value which approximates fair value. The contract value of the TIAA Traditional Annuity equals the accumulated cash contributions and interest credited to the Plan’s contracts, and transfers, less any withdrawals and transfers. The TIAA Traditional Annuity is not available for sale or transfer on any securities exchange, accordingly, transactions in similar investment instruments are not observable.

*Not Classified - Pooled separate account:* The value is principally derived from the fair value of the underlying real estate holdings and other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values. Securities are generally priced using values obtained from independent pricing sources. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The pooled separate account is not required to be classified within a level on the fair value hierarchy. There were no participant redemption restrictions for the common/collective trust fund; the redemption notice period was only applicable to the Plan. As of December 31, 2024 and 2023, there were no unfunded commitments, daily redemption restrictions and a 12-month redemption notice period.

The Company has various processes and controls in place to ensure that fair value is reasonably estimated. The Company sets the valuation policies for assets and is responsible for the determination of fair value. The Company (1) compares price changes between periods to current market conditions, (2) compares trade prices of securities to fair value estimates, (3) compares prices from multiple pricing sources, and (4) performs ongoing due diligence to confirm that independent pricing services use market based parameters for valuation. Valuation approaches are reviewed on an ongoing basis and revised as necessary based on changing market conditions to ensure values represent a reasonable exit price.

The Company assesses the fair value measurements applied by TIAA-CREF, including those for level 3 measurements, on a continuing basis. Periodically, the Company, together with TIAA-CREF, determines if the current valuation techniques used in the fair value measurements are still appropriate.

The insurance company general contracts (non-benefit responsive) are TIAA-CREF Traditional Annuity contracts, the TIAA-CREF Traditional Non Benefit Responsive 2 and the TIAA-CREF Traditional Non Benefit Responsive, that are unallocated fixed annuity contracts that are fully and unconditionally guaranteed by TIAA-CREF. TIAA-CREF Traditional Annuity within liquid contracts are benefit responsive. TIAA Traditional Annuity within illiquid contracts are non-benefit responsive. TIAA-CREF Traditional Annuity provide a guarantee of principal, a guaranteed minimum rate of interest (generally 3%, but in some contracts between 1% and 3%) and the potential for additional interest if declared by TIAA-CREF. Additional interest, when declared, remains in effect for the “declaration year,” which begins each March 1. Additional interest is not guaranteed for future years. Contributions to a participant’s account purchases a guaranteed amount of lifetime annuity income. When a participant’s account in the TIAA-CREF Traditional Annuity is annuitized based on available options, the present value of the stream of payments is equal to the account balance. Certain contract types contain liquidity restrictions on the redemption of TIAA-CREF Traditional Annuity accumulations, which could impact the value realized upon exiting the contracts.

### **NOTE 4 – BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan has entered into a insurance company general contract with TIAA-CREF totaling \$383,632 and \$83,969 at December 31, 2024 and 2023, respectively. TIAA-CREF maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA-CREF, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

## **NOTE 5 – RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by TIAA-CREF. TIAA-CREF is the trustee of the Plan therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments as the fees are paid through revenue sharing, rather than a direct payment. TIAA-CREF performs certain administrative, advisory and recordkeeping services for the Plan. As described in Note 2, the Employer pays directly any other fees related to the Plan's operations.

The Plan provides for loans to participants. Transactions in such investments qualify as party-in-interest transactions as defined by ERISA.

## **NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## **NOTE 7 – TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code ("Code"). The terms of the Plan have been prepared to conform to the listing of 403(b) plans that have been pre-approved by the Internal Revenue Service. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **NOTE 8 – CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including total investments and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA-CREF, the trustee of the Plan.

## **NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
