A. Description of Plan:

The following description of the Coordinates Operations LLC 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description and the Plan agreement for a more complete description of the Plan's provisions.

General

The Coordinates Operations LLC 401(k) Retirement Plan is a defined contribution plan covering substantially all employees of Coordinates Operations LLC. The Plan became effective on January 1, 1997.

Eligibility

The Plan is extended to all Company employees with the exception of those seasonal employees and interns who have not met specified age and service requirements.

Contributions

Participants may elect to contribute to the Plan on a pre-tax basis or as a Roth deferral contribution, up to 60% of compensation as defined in the Plan up to the annual statutory limits. Contributions are made by payroll deduction. In addition, the Plan allows "catch-up" contributions for participants who have obtained age 50 before the end of the Plan year. Rollover contributions are permitted.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of Plan earnings. Allocations are based on participant account balances, as defined. Participants determine the percentage in which contributions are to be invested in each fund. Participants may change their investment options as set forth in the plan document.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is determined by the plan administrator based on prevailing interest rates. Principal and interest is paid ratably through semimonthly payroll deductions.

Vesting

Participants are immediately vested in their account balances.

Payment of Benefits

Upon termination of service prior to retirement, an employee receives a lump-sum amount equal to the value of his or her account. There are alternative forms of benefit payment arrangements available.

B. Summary of Significant Accounting Policies:

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Notes Receivable from Participants

Loans to participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Investments, Investment Valuation and Income Recognition

The investments were held by Fidelity Management Trust Company. (See Note H regarding the plan trustee). The investments consisted of fixed income, equity, and money market funds with a market value of \$186,948,326 at December 31, 2024 and \$161,584,744 at December 31, 2023.

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

The Plan permits the participants to exercise control over the assets in their accounts and to choose from a broad range of investment alternatives, including a self-directed brokerage alternative.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Unrealized gains and losses are reflected in the fair value of investments; thus investment gain or loss for the Plan includes unrealized appreciation or depreciation.

Payment of Benefits

Benefits are recorded when paid.

Date of Management's Review

Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

C. Fair Value Measurement:

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Self-directed brokerage accounts: Hold common stocks and mutual funds.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

D. Tax Status:

The Plan has not requested a determination letter from the Internal Revenue Service. However, the plan and trust document is a preapproved prototype document. The plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. As such, the Plan is exempt from federal income taxes, and no provisions for income taxes have been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

E. Termination Priorities:

While the Company has not expressed any intent to terminate the Plan, it is free to do so at any time, subject to the restrictions set forth in the Employee Retirement Income Security Act of 1974 (ERISA).

F. Certification of Investment Information:

The plan administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Fidelity Management Trust Company, the trustee of the Plan, has supplied the plan administrator with certifications as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan's independent accountant did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements and supplemental schedules.

G. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

H. Party in Interest:

The Fidelity Management Trust Company (as Plan Trustee) provided recordkeeping investment service for the Plan; therefore, it is a party in interest with regard to the Plan. Accordingly, loans to participants and the management of investments held by the Trustee are considered party in interest transactions. The Plan paid fees to Fidelity Management Trust Company in the amount of \$10,617 for the year ended December 31, 2024.
