### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE 1 – DESCRIPTION OF THE PLAN

---

The following description of the Asbestos Workers Syracuse Welfare Fund provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Fund's provisions.

##### **General**

The Fund provides health, disability and death benefits to the employees of participating employers in the Central New York area meeting the Fund eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan's board of trustees is responsible for oversight of the plan. Plan management monitors investment performance.

##### **Contributions**

The Asbestos Workers Syracuse Welfare Fund is maintained through collective bargaining agreements with various contractors and Local No. 30, the International Association of Heat and Frost Insulators and Asbestos Workers of the United States and Canada. These collective bargaining agreements provide that employers must contribute to the Fund on behalf of each covered employee on the basis of the fixed rate per hour worked. These rates are subject to change each year in May. The Fund administrator may be allowed to participate in the Fund under a participation agreement at the same rate per hour worked as the collective bargaining agreement. The rate was \$11.84 per hour worked for both years ended December 31, 2024 and 2023.

##### **Eligibility**

Participants become eligible for benefits based on the following schedule:

- January 1<sup>st</sup> – For 350 hours worked during the previous September, October, and November –or– 700 hours worked during the previous June through November.
- April 1<sup>st</sup> – For 350 hours worked during the previous December, January, and February –or– 700 hours worked during the previous September through February.
- July 1<sup>st</sup> – For 350 hours worked during the previous March, April, and May –or– 700 hours worked during the previous December through May.
- October 1<sup>st</sup> – For 350 hours worked during the previous June, July, and August –or– 700 hours worked during the previous March through August.

**Benefits**

Benefits are provided through insurance coverage with Excellus BlueCross BlueShield – Utica Region and Central New York Region under various types of plans. Life insurance, short-term disability and accidental death and dismemberment insurance are provided by the Guardian Insurance Company.

**Participants' Account Balances**

Individual accounts were established for each participant in 2001. At December 31, 2024 and 2023, the balances of these accounts amounted to \$2,264,173 and \$2,121,745, respectively, and are included in net assets available for benefits.

Contributions are allocated on a per participant basis to their individual account and to administrative expenses as follows:

May 1, 2023 – April 30, 2024	\$11.84 per hour worked	\$.30 per hour worked

- a. As long as participants meet the initial eligibility requirements, the cost for health insurance premiums will be deducted from their accounts. If their account balance is insufficient to cover the cost of the premiums, participants may self-pay the difference to avoid a lapse in coverage.
- b. If proof of coverage under an alternate plan is submitted, no deductions will be made from the account. Contributions will accumulate until retirement at which time they can be used to pay for health insurance for the participant.
- c. The balance in the participants' accounts may also be used to seek reimbursement for uncovered medical expenses as defined in Section 213(d) of the Internal Revenue Code providing proper documentation is submitted.
- d. If initial eligibility requirements are not met, contributions are forfeited.
- e. The participants' accounts do not reflect any earnings or losses of the Fund other than described above.

**Continuation of Coverage**

Continuation of coverage on a self-pay basis under certain circumstances is allowed if coverage would otherwise stop, separate from COBRA. Continuation of coverage is also allowed in accordance with the Consolidated Omnibus Budget Reconciliation Act of 1985 ("COBRA").

#### NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

---

##### **Basis of Accounting**

The Fund uses the accrual basis of accounting.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Fund's board of trustees determines the Fund's valuation policies and procedures. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Fund's gains and losses on investments bought and sold as well as held during the year.

##### **Contributions Receivable**

Employer contributions receivable represent amounts due as of December 31, 2024 and 2023, under terms of the collective bargaining agreement.

The Fund considers contributions receivable to be fully collectible; accordingly, no allowance for doubtful accounts is required.

##### **Payment of Benefits**

Premiums paid by the Fund are recorded, on an accrual basis, as insurance premiums in the accompanying statements of changes in net assets available for benefits.

Claims paid as reimbursement from participants' accounts are recorded when paid as health claims in the accompanying statements of changes in net assets available for benefits.

##### **Administrative Expenses**

All administrative expenses are paid by the Fund.

#### NOTE 2 – SUMMARY OF ACCOUNTING POLICIES – Continued

##### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

##### **Subsequent Events**

The Fund has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

#### NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Fund has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets and liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Cash Equivalents* – Valued at cost plus interest which approximates fair value.

*U.S. Government Securities and Corporate Equity Securities* – Valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open ended mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Fund's assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### **NOTE 4 – TAX STATUS**

---

The United States Treasury Department originally advised on July 23, 1957, that the plan constitutes a tax-exempt organization and is, therefore, exempt from federal income taxes under provision of Section 501 (c)(9) of the Internal Revenue Code. The plan has been amended since receiving the exemption letter. However, the plan administrator and the plan’s tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the plan’s financial statements. However, from time to time, income may be derived from certain activities not directly related to the plan’s tax-exempt purpose and thus would be subject to taxation as unrelated business income.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

---

Certain Fund investments are managed by Wells Fargo Bank, N.A. which is also the Fund’s investment custodian and record keeper. In addition, certain mutual funds are owned and managed by Manning & Napier who has been designated as the Fund’s investment advisor. These transactions qualify as party-in-interest transactions and are exempt from prohibited transaction rules.

The Fund shares the same board of trustees with Asbestos Workers Syracuse Annuity and Pension Funds.

The Fund has various administrative providers. Such providers are party-in-interest with ERISA and are exempt from prohibited transaction rules. With the exception of certain administrative expenses, which are specifically allocable to an individual fund, all common administrative expenses are allocated to the three Asbestos Workers Syracuse employee benefit funds equally. Total administrative expenses paid by the Pension Fund and subsequently reimbursed by the Welfare Fund amounted to \$60,423 and \$57,604 in 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, there was \$-0- and \$698, respectively, due to the Pension Fund for reimbursement of administrative expenses.

#### **NOTE 6 – RECIPROCAL PAYABLE AND RECEIVABLE**

---

These amounts represent contributions receivable from or payable to other Asbestos Workers Unions' Welfare Funds. The receivables are generated when participants of the Syracuse Welfare Fund work for employers who contribute to other Asbestos Workers Welfare Funds. Likewise, a payable arises when the Syracuse Welfare Fund collects contributions from Syracuse employers on behalf of participants of another area's Asbestos Workers Welfare Fund.

Reciprocals receivable amounted to \$18,706 and \$14,328 for the years ended December 31, 2024 and 2023, respectively, and are included in contributions receivable on the statements of net assets available for benefits.

Reciprocals payable amounted to \$2,031 and \$2,558 for the years ended December 31, 2024 and 2023, respectively.

#### **NOTE 7 – RISKS AND UNCERTAINTIES**

---

The Fund invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **NOTE 8 – CONCENTRATIONS**

---

Cash and cash equivalents include bank demand deposit accounts, and all highly liquid investments purchased with maturities of three months or less. The Fund maintains its cash in bank accounts, which at times, may exceed federally insured limits. The Fund has not experienced any losses in such accounts and believes it is not exposed to any significant credit risk with respect to cash and cash equivalents.

#### **NOTE 9 – PLAN TERMINATION**

---

The future of the Fund will be determined by the terms of the Collective Bargaining Agreements and Trust Agreement. Although it has not expressed any intention to do so, the Fund's board of trustees has the right to amend, suspend, or discontinue the plan subject to the provisions set forth in ERISA. The Fund can also be terminated by government actions if certain minimum funding requirements of federal pension law are not met.
