## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Committee of  
1st Phorm 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of 1st Phorm 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 1st Phorm 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of 1st Phorm 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about 1st Phorm 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

1. DESCRIPTION OF THE PLAN

The following description of the 1st Phorm 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of 1st Phorm International, LLC (the "Company" or "Employer") including all eligible employees of the controlled groups Buff Enterprises, LLC, 44Seven Media, LLC, and Supplement Superstores Franchising, LLC and was established January 1, 2022 with an employee deferral effective date of April 1, 2022. Employees are considered eligible with the completion of 1 year of eligible service and if they are age eighteen or older. Union employees and leased employees are excluded from the Plan. Entry dates for new plan participants are the first day of the first month and seventh month of the Plan year coincident with or next following the date the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Company is responsible for oversight of the Plan and determining the appropriateness of the Plan's investment offerings and monitoring investment performance. The Company acts as the Plan Administrator. Members of senior management serve as the Plan's trustees. The Plan's custodian is John Hancock Life Insurance Company and the Plan's recordkeeper is John Hancock Retirement Plan Services.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. 1st Phorm International, LLC, the Plan Sponsor, has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, not to exceed certain dollar limits established by the Internal Revenue Code ("IRC"). Participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans. If a participant has attained age 50 before the end of the Plan year, he or she is eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company will contribute Safe Harbor matching contributions equal to 100% up to the first 3% of base compensation that a participant contributes to the Plan and an additional 50% for deferrals that exceed 3%, but do not exceed 5% of the participant's compensation. This Company contribution is invested in the various investment options as directed by the participants. In addition, a discretionary profit-sharing amount may be contributed at the option of the Company. Contributions are subject to certain IRC limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of the Company's contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in employee contributions, rollover contributions, and Safe Harbor matching contributions at all times. For discretionary non-Safe Harbor matching and profit-sharing matching contributions, there is a 6-year graded vesting schedule.

Payment of benefits

For distributions other than death (termination, disability, after age 59½), participants may request a distribution, which will be paid in a lump sum. The Plan does not allow hardship distributions.

Full distributions for death must be completed by December 31 of the calendar year containing the fifth anniversary of the death.

The Plan contains an automatic cash out provision for terminated employees who have account balances less than \$7,000.

Notes receivable from participants

The plan does not permit participant loans.

Forfeited accounts

Upon termination of employment, participants forfeit their nonvested balances as determined by the 6 year graded vesting schedule for non-elective contributions. At December 31, 2024 and 2023, there were no forfeitures made to the Plan. Forfeitures can be used to pay Plan expenses or reduce other required contribution amounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments in pooled separate accounts are reported at their readily determinable fair value, as described more fully in Note 4. The Company determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions or repayments have been separated from a participant's pay by the Company, which is the pay date. The Company's contributions, if any, are recorded in the year earned to coincide with the year in which the Company records the contributions in its general ledger. Other liabilities include contributions prefunded by the Company prior to the pay date. The Plan records receivables for contributions based upon contributions recorded in the Plan year but received by the Plan subsequent to year end. Rollover contributions from participants are recorded based on the date the rollover contributions have been received by the custodian.

The Company identified certain participants were not enrolled timely into the Plan. As a result, on September 12, 2024, the Company deposited amounts due to participant accounts equal to 25% of the missed 401(k) withholdings each participant would have been entitled to, plus the full matching contribution, plus earnings, in the form of a qualified non-elective contribution (QNEC). The total amounts deposited are included in the Employer Receivable amounts in the Statements of Net Assets Available for Benefit.

Payment of benefits

Benefit payments to participants are recorded when distributed.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from the Plan's financial statements. Investment related expenses are included in net appreciation in fair value of investments.

3. CERTIFICATION OF INVESTMENT INFORMATION BY THE CUSTODIAN (UNAUDITED)

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from John Hancock Life Insurance Company that all of the investment information provided by the custodian, as of December 31, 2024 and 2023 and for the years ended December 31, 2024 and 2023, and included in the accompanying financial statements and supplemental schedule of assets (held at end of year) is complete and accurate. Information as to the investments in the accounts of John Hancock Life Insurance Company, investment income, and all information appearing in the accompanying financial statements is presented in reliance solely upon those certifications.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quote prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

4. FAIR VALUE MEASUREMENTS (continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

Pooled Separate Accounts: The Plan's pooled separate accounts are valued using the readily determinable fair value ("RDFV"). The RDFV is based on the value of the underlying assets owned by the fund, which consist of mutual funds. The pooled separate accounts held by the Plan publish their RDFV daily and transact at that price.

The preceding method described may procedure a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INCOME TAX STATUS

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under IRC Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

5. INCOME TAX STATUS (continued)

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments held were mutual funds managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the custodian as defined by the Plan, and, therefore, these transactions qualify as permitted party-in-interest transactions. Fees paid by the Plan for investment fees are reflected in net appreciation in fair value of investments. Additionally, the Plan pays fees for an investment advisor as well as an insurance broker. These fees paid by the Plan are reflected in administrative fees.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

10. LATE CONTRIBUTION REMITTANCES

Due to processing delays, the Company did not meet the remittance requirements as described by the Department of Labor regulations for some of the pay periods during the Plan period ended December 31, 2023. The employee contributions in question totaled \$476,694 for the period ended December 31, 2023. The Company is in the process of calculating and remitting the lost earnings attributable to the affected participants.

11. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements are available to be issued.

Effective March 14, 2025, the Plan transferred custodianship of plan assets to Fidelity Management Trust Company ("Fidelity"). On the effective date, all of the Plan's assets in the amount of \$5,549,229 were transferred to Fidelity.
