December 31, 2024

1. Description of Plan

The following brief description of The 401(k) Retirement Plan (the Plan) provides general information about the Plan's provisions. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees, except members of a collective bargaining unit and non-resident aliens, of NewYork-Presbyterian Medical Group Brooklyn (the Plan Sponsor), and effective December 31, 2021, Westchester Medical Practice, PC (WMP). The Plan was established on April 12, 2010, and amended and restated effective January 1, 2022.

Employees hired by the Plan Sponsor subsequent to February 1, 2019, or hired by WMP subsequent to December 31, 2021, are not eligible to enroll into the Plan, however, are eligible to enroll in The Retirement Savings Plan, a 403(b) plan sponsored by The New York and Presbyterian Hospital.

The Plan Sponsor is responsible for the general administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute an amount up to the statutory amount of their annual compensation. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. All contributions are subject to certain limitations by the Internal Revenue Code (the Code).

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan Sponsor may make discretionary employer contributions as determined but does not make matching contributions. WMP participants are not eligible to contribute to the Plan or to receive discretionary employer contributions.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, the Plan Sponsor's contribution (as applicable), and allocations of Plan earnings or losses. Allocations are based on participant's share of net earnings or losses of their respective elected investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants are immediately vested in the value of their contributions plus actual earning thereon. Prior to February 1, 2019, Plan Sponsor contributions were subject to vesting based upon three years of service. Effective February 1, 2019, Plan Sponsor contributions are immediately 100% vested.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 or 50% of the participant's vested account balance. The minimum loan amount is \$1,000. Loans are collateralized by the participant's vested account balance and are accounted for as a specific investment of the borrowing participant's account. Principal and interest are paid by the participant directly to the Plan custodians.

Loans for reasons other than the purchase of a primary residence are to be repaid within five years. Loans are reported at their unpaid principal balances plus any accrued but unpaid interest.

The notes receivable from participants approximates the amortized cost of the loans because the loans are secured by each respective participant's account balance.

Payment of Benefits

Upon termination of employment, retirement, death or disability, a participant, or their beneficiary, in the event of death, is entitled to distribution of their vested account balance. A participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments paid over a certain number of years selected by the participant.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

However, if the value of a participant's vested interest is \$5,000 or less as of March 31, 2024, or \$7,000 or less thereafter, a lump-sum distribution will be made to the participant or his or her beneficiary. During service, participants may withdraw amounts from their salary deferral accounts in the event of financial hardship, upon provision of proof to the satisfaction of the plan administrator. Certain income tax penalties may apply to distributions taken prior to age 59½. Distributions are subject to the applicable provisions of the Plan agreement.

2. Summary of Significant Accounting Policies

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

The following is a summary of the Plan's significant accounting policies:

Investment Valuation and Income Recognition

Investments consist of mutual funds, a guaranteed investment contract, and, through December 31, 2023, a self-directed brokerage account (such amounts included mutual funds only). All investments held by the Plan, except for the guaranteed investment contract, are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for further discussion and disclosures related to fair value measurements.

The Plan invests in The Guaranteed Long-Term Account (GLTA), a guaranteed investment contract. The Plan sponsor has determined that the GLTA is fully benefit-responsive and, therefore, is reported at contract value in the accompanying statements of net assets available for benefits. Contract value is the relevant measurement as contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions plus earnings, less participant withdrawals, and administrative expenses.

Management is responsible for determining the Plan's valuation policies and analyzing information provided by the investment custodians that is used to determine the fair value of the Plan's investments.

The 401(k) Retirement Plan

Notes to Financial Statements (continued)

2. Summary of Significant Accounting Policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation in investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their outstanding principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain amounts reported in the financial statements and accompanying notes and supplemental schedule. Accordingly, actual results may differ from those estimates.

Administrative Expenses

Custodial fees related to the Plan's custodians, legal fees and certain consulting fees are paid directly from the Plan's assets. Expenses relating to purchases, sales or transfers of the Plan's investments are charged to the particular investment fund to which expenses relate. Accounting fees and fees for other services rendered are paid by the Plan Sponsor; such expenses are excluded from the accompanying financial statements.

2. Summary of Significant Accounting Policies (continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net realized and unrealized appreciation in fair value of investments, interest and dividend income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company.

On April 1, 2022, Empower Annuity Insurance Company of America, formerly known as Great-West Life & Annuity Insurance Company, the parent company of Empower Retirement, LLC (Empower) acquired the full-service retirement business of Prudential Financial, Inc. (Prudential), including Prudential Retirement Insurance and Annuity Company (PRIAC) and Prudential Bank & Trust, FSB (PB&T). Empower became the recordkeeper of the Plan. Additionally, on October 3, 2022, PRIAC was renamed Empower Annuity Insurance Company (EAIC). Lastly, on March 31, 2023, PB&T was merged into Empower Trust Company, LLC (ETC).

Effective October 21, 2023, the Plan's recordkeeping and plan level reporting system with Prudential moved to Empower. Custody of the assets remains with EAIC for certain investments previously issued by Prudential. All other investments are held by ETC.

ETC and EAIC are the current trustees and custodians of the Plan.

The 401(k) Retirement Plan

Notes to Financial Statements (continued)

4. Income Tax Status

The underlying pre-approved plan received an opinion letter from the Internal Revenue Service (IRS) dated September 16, 2022, stating that the form of the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is tax-exempt. The Plan administrator has determined that it is eligible to, and has chosen to, rely on the pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Transactions with Parties-In-Interest

The Plan holds certain investments managed by the custodians of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Plan Sponsor provides the Plan with certain accounting and administrative services for which no fees are charged. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

6. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements are applied based on the unit of account from the Plan's perspective. The unit of account determines what is being measured by reference to the level at which the asset or liability is aggregated (disaggregated).

Notes to Financial Statements (continued)

6. Fair Value Measurements (continued)

The fair value hierarchy is composed of three levels based on the source of inputs as follows:

Level 1: Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2: Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.

Level 3: Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement. In determining fair value, the Plan uses valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs to the extent possible and considers nonperformance risk in its assessment of fair value.

The methods described above may produce a fair value that is not indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

7. Fully Benefit-Responsive Investment Contract

As described in Note 3, the Plan invests in the GLTA, which is a fully benefit-responsive investment contract. The issuer maintains the contributions for participant withdrawals and administrative expenses and is contractually obligated to repay the principal and interest at specified interest rates that are guaranteed to the Plan. The GLTA does not have a maturity date or penalties for early withdrawals.

The crediting rate for the GLTA is based on a formula established by the contract issuer but may not be less than 1.0% or greater than 3.0%; the crediting rate is reviewed on an annual basis for resetting.

The Plan's ability to receive amounts due in accordance with a fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet their financial obligations. The issuer's ability to meet their contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Premature termination of a contract
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

The 401(k) Retirement Plan

Notes to Financial Statements (continued)

7. Fully Benefit-Responsive Investment Contract (continued)

In addition, certain events allow an issuer to terminate its contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

The Plan administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with the contract issuers or participants is probable.

8. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will be distributed in accordance with the Plan agreement.

9. Commitments and Contingencies

Effective January 1, 2009, the IRS issued regulations for purposes of determining common control for qualified retirement plans sponsored by tax-exempt organizations. In general, tax-exempt entities that are under common control are treated as one entity for certain of the requirements of qualified plans. The regulations determine control based on facts and circumstances; for this purpose, common control would exist if, among other situations, at least 80% of the directors or trustees of one organization were either representatives of, or directly or indirectly controlled by, another organization. These regulations could have an effect on the operations of the Plan and the responsibilities of those entities for associated liabilities, such as the Company acting as the Plan Sponsor, although such effects are uncertain at this time.

10. Subsequent Events

Subsequent events have been evaluated through October 15, 2025, which is the date the accompanying financial statements were available to be issued. No subsequent events have occurred that require disclosure in, or adjustment to, the financial statements.
