Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hyosung Holdings USA, Inc. Savings Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. (1) Description of the Plan

a) General

Hyosung Holdings USA, Inc. Savings Plan (the “Plan”) is a multiple employer defined contribution plan covering eligible employees of HS Hyosung USA Holdings, Inc. and participating employers (the “Employer”, “Plan Sponsor” or “Company”), as stipulated in each employer’s adoption agreement. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more completed description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the information certified by the trustee, as complete and accurate, except for comparing the information certified by the trustee to information included in the financial statements.

b) Eligibility

Salaried and hourly employees become eligible to participate in the Plan upon hire. Leased employees are not eligible to participate in the Plan.

c) Contributions

Employee – Eligible employees are permitted to make contributions at a rate of up to 100% of employees’ compensation each year. However, employee’s total deferrals in any taxable year may not exceed a dollar limit by the Plan, and subject to Internal Revenue Code (the Code) limitations on deferral contributions of \$23,000 for 2024. Participants aged 50 and older or who will turn 50 during the Plan year are allowed to make additional catch-up contributions up to a maximum of \$7,500 for 2024.

Employer – The Company may contribute to the Plan up to 50% of the first 6% of compensation contributed by the hourly and salaried employee. The Company may contribute up to 50% of the first 7% of compensation contributed by former employees of Goodyear Tire & Rubber Company, regardless of whether they are designated hourly or salaried employees. Additional amounts may be contributed at the discretion of the Company’s board of directors. The discretionary contributions may be allocated among all participants who are eligible salaried and hourly employees on the last day of the Plan year, or who cease to be eligible employees during the Plan year by reason of death or separation from service after attainment of the normal retirement age, or who become entitled to benefits under the employer’s long-term disability plan during the Plan year.

d) Participants’ Accounts

Each participant’s account is credited with the participant’s deferral contribution, allocations of the Company’s matching contributions, allocations of Company discretionary contributions,

participant forfeitures and Plan earnings, and charged with withdrawals, allocation of Plan losses and administrative expenses. Earnings are allocated to each participant's account based on the share of the investment fund they each own at a given time period.

e) Investments

Participants direct the investment of their contributions into various investment options offered by the Plan. Company matching contributions are automatically invested in the same funds as the participant contributions.

f) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of participant's vested interest in the plan, whichever is less.

The loans are secured by the balance in the participant's account and bear interest at the prime rate as published in the Wall Street Journal plus 1%. Interest rates on outstanding participant loans ranged from 4.25% to 9.50% with maturities through 2032 as of December 31, 2024. Loans are to be paid in no later than five years, except for loans made for the purchase of a principal residence in which case the term of the loan can be up to 10 years.

g) Vesting

Participants, matching employer, and discretionary contributions are 100% vested immediately in their contributions plus actual earnings thereon.

h) Payment of Benefits

On termination of services due to death, disability, severance from employment, or retirement, a participant may elect to receive a distribution amount equal to the value of the participant's interest in his or her account or a series of installments (as defined by the Plan). Participants with a vested account balance equal to or less than \$1,000 are immediately distributed as a lump-sum under the terms of the Plan, without the participant's consent, unless the participant has made a timely rollover election to an Individual Retirement Account or other qualified arrangement. In times of financial hardship, the funds in the participant's account are available for withdrawal if a condition is satisfied in terms of emergency medical care, principal for a residence, and educational fees. Such withdrawals are subject to tax as ordinary income.

(2) Summary of Significant Accounting Policies

a) Basis of Presentation

The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP").

b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and

assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end, which are based on quoted market values. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned.

d) Net Appreciation (Depreciation) in Fair Value of Investments

Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

e) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis.

f) Payment of Benefits

Benefits are recorded when paid.

g) Administrative Expenses

The Plan's expenses are paid by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

(3) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) Topic 820, "Fair Value Measurements and Disclosures", establishes a framework for measuring fair value. That framework provides a fair value hierarchy that requires assets and liabilities measured at fair value to be categorized into one of the three levels based on the priority of inputs used in the valuation. Assets and liabilities are classified in their entirety based on the lowest level of input significant to the fair value measurement. The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset's and liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value pursuant to the fair value hierarchy:

Interest-bearing cash: Valued at the daily closing price as reported by the fund. Interest-bearing cash held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Mutual funds: Valued at the net asset value of shares held by the Plan at year-end. The value is based on the quoted market prices of the underlying shares owned by the fund, minus its liabilities, then divided by the number of shares outstanding.

Common/collective trusts: Valued at the net asset value (NAV) per share/unit reported at the close of business every day. Shares/units in common/collective trusts can be redeemed daily on demand. The NAV is used as a practical expedient to estimate fair value.

Self-directed brokerage accounts: Accounts primarily consist of cash, money market funds, mutual funds, common stock, preferred stock, unit investment trusts, other assets, interest bearing cash, and corporate obligations that are valued on the basis of readily determinable market prices. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(4) Income Tax Status

The Internal Revenue Service has determined and informed Ascensus by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the “IRC”). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Company believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or derecognize an asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator believes that there are no uncertain tax positions that would have a material impact on the financial statements of the Plan. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2021.

(5) Plan Termination

Although it is intended to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. If terminated, no further contributions will be made to the Plan and all amounts credited to employee’s accounts will become 100% vested. The distribution will be directed to employees’ accounts in a manner permitted by the Plan as soon as practicable.

(6) Related Party and Party-in-Interest Transactions

As of December 31, 2024, Ascensus serves as a trustee and recordkeeper. Fees paid by the Plan to Ascensus for certain recordkeeping and administrative services for the year ended December 31, 2024, amounted to \$72,357.

The Plan issues loans to participants, which are secured by the balances in the participants' accounts and therefore, these transactions qualify as party-in-interest transactions.

Other notable related party transactions and party-in-interest transactions for services provided to the Plan by the affiliated disclosed.

(7) Concentrations of Credit Risks

The Plan's exposure to a concentration of credit risk is limited by diversification of investments across all participant-directed fund elections. Additionally, the investments within each participant-directed fund election are generally diversified into various financial instruments.

(8) Risks and Uncertainties

The Plan provides for the various investment options as described in Notes (1) and (3). Any investment is exposed to various risks, such as interest rate, market, and credit risks. These risks could have a material effect on the participant's account balance and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
