### **Note 1 – Description of Plan**

The following description of the ASB Sports Acquisition, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### General

The Plan, as amended and restated, is a defined contribution plan covering all eligible employees, as defined in the Plan document, of ASB Sports Acquisition, Inc. and affiliated employers (the Company and Plan Administrator). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, and an allocation of Plan earnings (losses). The allocation of Plan earnings (losses) is based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested value of the participant's account. Participants direct the investment of their account balances among the investment funds offered by the Plan.

#### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment period shall not be more than 5 years unless for the purchase of a primary residence. The loans are secured by the balance in the participant's account. Participants should refer to the Plan documents for a complete description of loan provisions.

#### Contributions

Participants may elect to contribute pre-tax or Roth deferrals up to the maximum allowed by the Internal Revenue Service and as defined by the Plan document. Participants are also permitted to contribute amounts distributed from another qualified plan (rollover contributions). Newly eligible employees that do not make an election will be automatically enrolled at an initial pre-tax deferral rate of 2%.

The Plan provides for discretionary matching contributions, to be determined by the Company. For 2024 and 2023, the Company elected to make discretionary matching contributions of 50% of the first 4% of the participant's deferrals. The Plan also provides for a discretionary profit sharing contribution to be allocated to eligible participants as defined by the Plan document. There was no discretionary profit sharing contribution in 2024 and 2023.

Payment of Benefits

The Plan generally provides that upon retirement, death, disability, or termination, participants are entitled to receive the vested value of their account in a lump sum payment or in partial payments. Upon meeting certain other qualifications, participants may also be eligible for in-service distributions and hardship distributions.

Vesting

Participants are immediately vested in their contributions (including related earnings and losses). Company contributions and related earnings (losses) become fully vested after one year of service.

Forfeitures

Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. In the event of Plan termination, participants become fully vested in the total value of their account.

Administrative Expenses

Administrative expenses are paid by the Company or by the Plan, as permitted in the Plan document. The services are rendered by parties-in-interest to the Plan.

**Note 2 – Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In contrast, contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. There have been no changes in the valuation methods used.

Mutual funds represent investments with various investment managers. The fair value of these investments is determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are valued at net asset value.

The Lincoln National Life Insurance Company Stable Value Separate Account 1 (held at December 31, 2024 and 2023) and the Guaranteed Investment Account (held throughout 2023, but not at year end) are fully benefit-responsive investment contracts valued at contract value, which represents contributions made under the contract, plus interest, less participant withdrawals and administrative expenses.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent outstanding loans and are measured at their unpaid principal balance plus accrued interest

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through October 14, 2025 the date the financial statements were available to be issued.

**Note 3 – Investments**

Reliance Trust Company held Plan assets and executed transactions beginning December 1, 2023 through December 31, 2024. Ameritas Life Insurance Corp held Plan assets and executed transactions from January 1, 2023 through November 30, 2023. All investment information disclosed in the accompanying financial statements and schedules, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) of investments, and dividends and interest for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Reliance Trust Company and by Ameritas Life Insurance Corp.

**Note 4 – Fully Benefit-Responsive Investment Contracts**

As of December 31, 2024 and 2023, the Plan holds traditional investment contracts that meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semi-annual basis for resetting (previously on a quarterly basis).

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value without adjustment. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer. The contract permits the issuer or the Plan to terminate the agreement prior to the scheduled maturity date as a result of specific occurrences as defined in the contract.

**Note 5 – Fair Value Measurements**

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels within the fair value hierarchy. The three levels are described below:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

**Note 5 – Fair Value Measurements (continued)**

- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

At December 31, 2024 and 2023, the Plan's investments valued at fair value in the statements of net assets available for benefits are all mutual funds, which are Level 1 investments.

**Note 6 – Restrictions on Net Assets**

There are no restrictions on deposits or transfers into the fully benefit-responsive investment contracts. Participants always have the option to transfer money out of the investment, although there may be circumstances in which a 90-day equity wash or a market value adjustment would be applied to the transaction. Any contract termination initiated by the contract holder will be based on either of the two following options as described in the contract:

- A lump sum payment of the Plan's assets, after any applicable market value adjustment, will be paid on a date mutually accepted by both parties; or
- The market value adjustment will not apply if the contract holder requests the value to be divided into approximately 5 annual payments. The interest rate credited during this pay-out period is determined by the applicable contract.

**Note 7 – Income Tax Status**

The Internal Revenue Service ruled on October 6, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan (the document upon which the Plan is based) qualifies under Section 401 of the Internal Revenue Code (IRC) and the related trust is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator will take the necessary steps, if any, to bring the Plan's operations into compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
