To the Plan Administrator of the  
A. Stucki Company 401(k) Profit Sharing Plan & Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of A. Stucki Company 401(k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

### NOTES TO FINANCIAL STATEMENTS

#### 1. DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following brief description of the A. Stucki Company 401(k) Profit Sharing Plan & Trust (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions

*General* - The Plan provides all full-time nonunion employees of A. Stucki Company (the "Company"), who meet age and service requirements, with a tax-deferred savings and profit-sharing program. The Plan is administered by the Company and subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Employer Contributions* - The Company makes a safe harbor contribution equal to 100% of the first 3% of employee elective deferrals and 50% on the next 2% of employee elective deferrals.

The Company may also elect to provide a profit-sharing contribution. The amount of the profit sharing contribution is determined annually by the Board of Directors based on the profitability of the Company. The Company did not make a profit sharing contribution for 2024 or 2023.

*Employee Contributions* - All employees who meet age and service requirements are eligible to participate in the Plan. The Plan provides for employee contributions from 1% to 85% of compensation, subject to IRS limitations on total deferrals. Employee contributions consist of employee elective deferrals and rollovers from other qualified plans. Effective May 1, 2024, the Plan was amended to allow for automatic enrollment of new participants at 3% of eligible compensation.

*Participant Accounts* - Each participant's account is credited with the participant's contributions, share of plan earnings and employer contributions.

*Investments* - The Plan's investments are held by the custodian of the Plan. Participants may direct contributions to the investment options available within the Plan. Participants may change their investment options at any time.

*Vesting* - Participants are immediately vested in their voluntary contributions, their share of safe harbor employer contributions and the respective earnings thereon. Vesting in profit sharing contributions and earnings thereon is according to the following schedule:

Participants are 100% vested in the event of total disability, death or upon reaching retirement age prior to guidelines noted above.

*Forfeitures* - Forfeitures represent non-vested benefit payments remaining in the Plan for all current-year terminated employees. Forfeitures are applied to reduce employer contributions or, if in excess of employer contributions, allocated among the remaining participants. During the years ended December 31, 2024 and 2023, there were no forfeitures. There is no available balance in the forfeitures account at December 31, 2024 or 2023.

*Payment of Benefits* - Benefit payments to participants are recorded at the time of distribution.

*Use of Estimates* - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires plan management to make estimates and assumptions that affect the reported amounts of assets available for benefits and changes therein. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* - Investments are carried at their fair value based upon published quotations or, in the absence of readily ascertainable market values, at such values as the custodian determines. The unrealized appreciation of investments is determined by the change in current market value from the beginning of the year (if held for the entire year) to the end of the year, or from the date of purchase to the end of the year. The realized appreciation of investments is determined from the date of purchase to the date of sale. Gains and losses on securities sold or redeemed are determined on the basis of specific identification. Dividend and interest income is recorded as earned.

The guaranteed investment contract is reported a contract value, which is the relevant measure attributable because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 3).

U.S. GAAP establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs that may be used to measure fair value are defined as:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Notes Receivable from Participants* - Participants may borrow up to 50% of their account balance, up to a maximum of \$50,000. The amount of the loan must be at least \$1,000. Loans accrue interest at a rate equal to the prime rate plus 1% at the inception of the loan and are secured by the participant's account balance. The interest rates on the loans outstanding at December 31, 2024 and 2023 ranged from 4.25% to 9.5%. All loans must be repaid in their entirety over a maximum of 54 months, unless the purpose of the loan is to purchase a principal residence.

*Risks and Uncertainties* - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Administrative Expenses* - Administrative expenses of the Plan are paid by the Company; certain investment and custodial fees are paid by the Plan.

*Subsequent Events* - Management has evaluated subsequent events through September 2, 2025, the date which the financial statements were available to be issued.

## **2. INVESTMENTS**

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds*: Investments in mutual funds are valued at quoted market prices in an exchange and active market, which represent the net asset values of shares held at year end (Level 1 measurement).

*Collective Investment Trusts (CIT):* Each CIT invests in a collective trust fund as well as a variety of separate accounts and mutual funds. The collective trust fund and the separate accounts are not valued using publicly quoted pricing inputs; the mutual funds are valued using publicly quoted pricing inputs. The fair values of all of these investments are used to determine the net asset value (NAV) of each CIT. The NAV is not publicly quoted but is available to current investors. The NAV is the basis for current transactions, and each CIT can be redeemed at NAV as of the measurement date. Therefore, each CIT has a readily determinable fair value (Level 1 measurement).

*Pooled Separate Accounts (PSA):* Each PSA invests mainly in domestic stocks, which are valued using publicly quoted pricing inputs. The fair values of all of these stocks are used to determine the NAV of each PSA. The NAV is not publicly quoted but is available to current investors. The NAV is the basis for current transactions, and each PSA can be redeemed at NAV as of the measurement date. Therefore, each PSA has a readily determinable fair value (Level 1 measurement).

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **3. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan holds fully benefit-responsive guaranteed investment contracts with Principal Life Insurance Company (PLIC). PLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the assets available for benefits attributable to the guaranteed

investment contract. Contract value, as reported to the Plan by PLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with PLIC. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **4. CERTIFIED FINANCIAL INFORMATION**

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the custodian, has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of assets available for benefits as of December 31, 2024 and 2023.
- Investment activity as shown in the statements of changes in assets available for benefits for the years ended December 31, 2024 and 2023.
- The accompanying schedule of assets held for investment purposes as of December 31, 2024.

#### **5. PLAN TERMINATION**

The Company anticipates and believes that the Plan will continue without interruption but reserves the right to discontinue the Plan at its discretion. In the event that such discontinuance results in the termination of the Plan, all amounts credited to participant accounts become 100% vested. The assets of the Plan will be distributed by the custodian in accordance with the trust agreement in a uniform and nondiscriminatory manner.

**6. FEDERAL INCOME TAX STATUS**

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan operates under an adoption agreement in connection with a non-standardized pre-approved profit sharing plan with a cash or deferred arrangement. The Internal Revenue Service has determined and informed the Plan sponsor by a letter dated June 30, 2020 that the form of the pre-approved plan is acceptable for use by employers under IRC Section 401. Although the Plan has been amended, the Plan sponsor believes that the Plan is currently being administered in compliance with the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. Management believes there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to tax examinations for the years before December 31, 2021.

**7. RELATED PARTIES AND PARTIES-IN-INTEREST**

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company served as the custodian of the Plan during the years ended December 31, 2024 and 2023, respectively.

Certain plan investments in collective trusts, pooled separate accounts and the guaranteed investment contract are managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the custodian, and affiliated companies, which are considered parties-in-interest. Additionally, the Plan paid certain administrative fees for custodial services. Fees paid by the Plan for custodial services were not significant for the period ended December 31, 2024 and are not considered prohibited transactions under Section 408(b) of ERISA regulations.

Neither the Sponsor nor employees of the Sponsor involved in the administration of the Plan receive compensation from the Plan.
