Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Lord Hobo Brewing Company 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.



1. DESCRIPTION OF PLAN

The following description of the Lord Hobo Brewing Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC). The Plan was established in January 2020. A Summary Plan Document outlining the Plan, its benefit provisions and vesting requirements is provided to each Plan participant. The Plan is administered by Lord Hobo Brewing Company (the "Company").

Eligibility Requirements

All employees who have completed three months of service, as defined, are eligible to participate, provided they are at least 21 years of age. On January 1, 2024, the Plan was amended to change the service requirement to 60 days. If an employee does not meet the requirement as specified, the employee will also be eligible for the Plan after completing 1,000 hours of service in a consecutive 12-month period.

Contributions

Participants may elect to contribute up to one hundred percent (100%) of eligible compensation as defined in the Plan document. The Plan includes an automatic deferral provision requiring 3% of participant compensation to be withheld as participant deferral unless the employee elects to change the deferral percentage or not to participate. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may in its sole discretion make matching contributions to participants that contribute to the Plan. No matching contributions were made in 2024 or 2023.

The Company may in its sole discretion make non-elective contributions to participants employed by the Company on the last day of the Plan year and credited with at least 1,000 hours of service during the Plan year. No non-elective contribution was made for 2024 or 2023.

All contributions are subject to certain IRC limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's non-elective contribution and Plan investment earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always one hundred percent (100%) vested in amounts attributable to their salary deferrals and rollover contributions. Participants' vested percentage in their account attributable to discretionary non-elective and Company matching contributions is determined under the following schedule and is based on vesting years of service. A year of service is based on 1,000 hours worked during the Plan year. Participants will always, however, be one hundred percent (100%) vested if they are employed on or after their normal retirement age.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by any outstanding loan balance, if any during the one-year period ending on the day before a new loan is made or fifty percent (50%) of their vested account balance. The loans are secured by the balance in the participant's account and bear interest of 8.75% - 9.50% at December 31, 2024. The loan interest rate is the prime rate plus one percentage point. Loans must be fully repaid through payroll deductions within five years unless the loan is used to purchase a primary residence, which is repayable over 30 years. A participant may not have more than one outstanding loan at any time.

Payment of Benefits

Upon termination of employment, death, disability, or normal retirement, a participant or designated beneficiary may elect to receive the participant's vested interest in his or her account in the form of a lump-sum, installment, or direct rollover to another qualified retirement plan or IRA. Participants who terminate employment with an aggregate vested account balance of \$5,000 or less will be distributed from the Plan paid in a single lump-sum or direct rollover to another qualified retirement plan or IRA. Participants may also withdraw their vested account balance upon attaining age 59 ½. Hardship withdrawals are also permitted by the Plan.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are reported as a liability with a corresponding reduction to contributions. There were no excess contributions refunds payable as of December 31, 2024. Excess contributions refunds payable as of December 31, 2023 was \$10,157.

Secure 2.0 Act

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective January 1, 2023. Plan management evaluated the impact of the adoption and implementation of this legislation on the Plan and there was no material impact to the Plan for the year ended December 31, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation / (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based upon the terms of the Plan document. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

Contributions Receivable

Receivables are recorded when amounts have been withheld from participants' compensation.

Benefits Paid

Benefits paid to participants and their beneficiaries are recorded when paid.

Administration Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administration expenses. Investment related expenses are included in net appreciation / (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued. The Plan switched its payroll service provider, custodian and recordkeeper to ADP during 2025.

3. INFORMATION PREPARED AND CERTIFIED BY PLAN'S CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian (John Hancock Life Insurance Company (U.S.A.)) has certified to the completeness and accuracy of all investments reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related investment activity reflected on the Statements of Changes in Net Assets Available for Benefits for the years then ended, and Schedule H, Line 4(i)- Schedule of Assets (Held at End of Year), as of December 31, 2024.

4. FAIR VALUE MEASUREMENTS

Plan investments are units of pooled separate accounts. Pooled separate accounts are recorded at net asset value (“NAV”) as determined by the investment manager based on the aggregate value of their underlying investments. Units in pooled separate accounts are only redeemable by the issuer. There have been no changes to the valuation methodologies used at December 31, 2024 and 2023.

5. EXEMPT PARTIES-IN-INTEREST TRANSACTIONS

John Hancock Life Insurance Company (U.S.A.) is the custodian as defined by the Plan and therefore, these transactions qualify as exempt party-in-interest transactions.

Certain administrative expenses for accounting and other services are rendered by parties-in-interest and are paid by the Company. The Company also provides certain administrative services to the Plan for which it receives no compensation.

6. TAX STATUS

The Internal Revenue Service (IRS) has provided an opinion and informed the Company by a letter dated June 30, 2020 that the prototype non-standardized plan maintained by the Plan is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently operating in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator believes it has no uncertain tax positions as of and for the years ended December 31, 2024 and 2023. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. PLAN TERMINATION

Although the Company has not expressed any intent to do so, it reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in the entire amount credited to their accounts.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
