### **Note 1 - Plan Description**

The following description of syncreon Employees 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees, excluding leased employees, of syncreon Acquisition Corp., Inc.; syncreon Technology (America) Inc.; syncreon Technology (USA) LLC; syncreon America, Inc.; and syncreon US Inc. (collectively, the "Company"). The Plan covers eligible employees of collectively bargained units that have agreed to adopt the Plan.

Effective December 31, 2024, the Cargoes US Inc. 401K Plan; the DP World Logistics USA 401k Plan; the DP World Americas RO, Inc. 401(k) Plan; and the CFR Rinkens, LLC 401k Plan were merged into the Plan. Including participant notes receivable, the assets and participant account balances of these plans approximating \$9,073,000 were transferred into the Plan in January 2025. Accordingly, the mergers are accounted for as mergers receivable on the accompany statement of net assets available for benefits at December 31, 2024. The provisions and significant accounting policies of the Plan disclosed below are those of the Plan prior to the plan mergers.

Effective January 1, 2025, the Plan was renamed the DP World CL Holding Americas Inc. 401(k) Plan. Effective January 1, 2025, the Company includes the following participating employers; DP World Tech Americas Inc. (formerly known as syncreon Technology (America) Inc.); DP World Tech US LLC (formerly known as syncreon Technology (USA) LLC); DP World Contract Logistics US Inc. (formerly known as syncreon America, Inc.); DP World US Inc. (formerly known as syncreon US Inc); Cargoes US, Inc.; DP World Logistics USA, Inc.; DP World Americas RO, Inc.; and CFR Rinkens, LLC.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee pretax and Roth salary deferral contributions up to a maximum of 75 percent of annual compensation subject to maximum limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

For union participants, the Plan provides for employer matching contributions of a participant's contribution, not to exceed certain percentages of eligible compensation deferred upon, as reflected in the applicable collective bargaining agreements.

For nonunion participants, the Plan provides for employer safe harbor matching contributions of 100 percent of a participant's contribution, not to exceed 4 percent of the employee's compensation deferred upon.

The Company may also make discretionary employer contributions. There were no discretionary employer contributions made during the year ended December 31, 2024.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$500 up to a maximum of 50 percent of their vested account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate. Participants may not have more than one note receivable outstanding at any time.

**Note 1 - Plan Description (Continued)**

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

***Benefit Payments***

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

***Vesting***

Nonunion participants are immediately vested in their employee salary, rollover, and safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's employer discretionary contributions portion of their accounts plus actual earnings thereon is based on years of continuous service beginning at 33 percent after one year of service and increasing 33 percent for each year of continuous service thereafter. A participant is 100 percent vested after three years of service with the Company.

Union participants are immediately vested in their employee salary, rollover, and employer discretionary contributions portion of their accounts, plus actual earnings thereon. Vesting in the Company's employer matching contributions portion of their accounts plus actual earnings thereon is based on years of continuous service.

The Company's employer matching contributions for union participants vest according to the following schedule:

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Empower Trust Company, LLC or Empower Annuity Insurance Company of America (EAICA) (collectively, the "Custodians"). These transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive unallocated contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Plan and the Company.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 14, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

The Custodians hold the Plan's investments and participant notes receivable and execute all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodians.

**Note 4 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

There were no unfunded commitments or redemption restrictions on the investments described above.

**Note 6 - Investment Contract**

The Plan has a benefit-responsive investment contract with EAICA. EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

**Note 6 - Investment Contract (Continued)**

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting. The minimum interest rate credited to participants under the EAICA contract is 1.50 percent. When establishing interest crediting rates for this product, EAICA considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time. The plan administrator believes that no events occurred during the year ended December 31, 2024 that would have impacted the Plan's ability to transact at contract value with participants.
