Note 1 – Plan Description

The following description of Bowman Andros Products 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Bowman Andros Products LLC (the “Company”) who are age 18 or older, with quarterly entry dates, except those employees whose employment is governed by a collective bargaining agreement. Participants who have completed one year of service (1,000 hours) are eligible for employer matching and safe-harbor contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Automatic Deferrals

Participants are subject to automatic salary deferrals of 3%, increasing annually by 1% up to a maximum of 10% of compensation. Participants may opt out or elect an alternative deferral amount.

Contributions

Each year participants may contribute up to 90% of their compensation as pre-tax or Roth contributions, as defined by the Plan, not to exceed the maximum allowable under the *Internal Revenue Code (IRC)*. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. The Company makes safe-harbor matching contributions on 100% of the first 3% of employee deferrals and 50% of the remaining employee deferral, not to exceed 5% of eligible compensation. The Company may also contribute a discretionary matching contribution. For 2024, the Company made a matching contribution of 33% of the first 6% of eligible compensation that a participant contributed to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, and an allocation of the Plan earnings and is charged with an allocation of Plan expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants hired prior to January 1, 2020, are immediately 100% vested in their contributions and employer safe-harbor and matching contributions, plus actual earnings thereon. Employees hired after January 1, 2020, are immediately 100% vested in their contributions and employer safe-harbor matching contributions and are subject to a six-year graded vesting schedule in employer matching contributions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$548 and \$10, respectively. Forfeitures can be used to reduce employer contributions and pay Plan expenses. In 2024, \$33,763 in forfeited account balances were used to reduce employer contributions.

Payment of Benefits

Upon termination of service for any reason, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments not exceeding the life expectancy of the participant. If the participant's balance is under \$5,000 upon termination, the participant's vested interest in his or her account will be automatically distributed.

Effective January 1, 2024, the automatic direct rollover threshold increased to \$7,000 in accordance with SECURE Act 2.0.

Administrative Costs

Administrative expenses incurred by the Plan may be paid by either the Company or the Plan on a discretionary basis.

Notes from Participants

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested balance. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at the Prime Rate plus one percent. At December 31, 2024, the interest rate on loans ranged from 4.25% - 9.50%. Principal and interest are paid ratably through payroll deductions.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a full discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefit Payments

Benefits are recorded when paid.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 consists of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The collective investment trust funds issued by FlexPATH Strategies, LLC and owned at December 31, 2024 and 2023, are composed primarily of mutual funds and a variety of stocks and bonds and are valued at the net asset value of units of FlexPATH's collective trust. The collective investment trust funds issued by Blackrock, Inc. and owned at

Level 1 Fair Value Measurements

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

Level 2 Fair Value Measurements

The fair values of collective investment trusts are based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

The collective investment trusts invest in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While the underlying assets values are quoted prices, the net asset value (NAV) of a unit in these funds is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are reflected in the computation of the NAV and are realized by the participant upon withdrawal.

Note 4 – Related Party Transactions and Party-In-Interest Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may direct their investments in funds issued and managed by the Plan Trustee. Investments in funds issued by the Trustee are considered related party transactions. Fees paid by the Plan to service providers amounted to \$123,907 for the year ended December 31, 2024.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their contributions.

Note 6 – Tax Status

The Plan adopted a non-standardized prototype plan sponsored by ADP, LLC and has not requested a determination letter, but rather has relied upon the Internal Revenue Service (IRS) opinion letter dated October 6, 2020 issued on the prototype plan, stating the Plan is designed in accordance with applicable sections of the *IRC*. The Plan has been amended since receiving the IRS opinion letter. However, the Company believes the Plan is currently being operated in compliance with the applicable requirements of the *IRC* and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
