## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrators  
DHSE, Inc. 401(k) Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of the DHSE, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the DHSE, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

### *Opinion*

### *Basis for Opinion*

**1. Description of the Plan and Significant Accounting Policies:**

The following description of the DHSE 401k Plan ("Plan") is provided for general information purposes only. Reference should be made to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution savings plan under Section 401(k) of the Internal Revenue Code, which covers all full-time non-union employees of DHSE, Inc. ("Company"). Participants must be over 21 years of age and have completed 3 months of service. Eligible employees will be automatically enrolled into the Plan with an initial elective contribution rate of 1%. The Participant entry date is the first day of each month on or after the date the participant becomes an eligible employee. The Plan also allows Roth 401(k) contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

**Participants:** Participants may contribute up to 90 percent of their salaries to the Plan, up to the Internal Revenue Service ("IRS") annual maximum limit of \$23,000 for 2024. The Plan also allows participants age 50 and older an additional "catch-up" contribution up to the IRS annual maximum limit of \$7,500.

**Employer:** The Company may make discretionary contributions to the plan. During the years ended December 31, 2024, and 2023, the Company did not make any discretionary contributions to the plan.

Participant Accounts and Vesting

Each participant's account is credited with their contribution and an allocation of Plan earnings. The benefits to which a participant is entitled are the benefits that can be provided from their account. Participants are immediately vested in their voluntary contributions and contribution earnings. Vesting in the employer's matching contribution is attained ratably over five years of service (defined as 1,000 hours of service) and immediately upon death or permanent disability.

Forfeited Accounts

Forfeitures of non-vested Company contributions are used to reduce future Company contributions. At December 31, 2024, and 2023, there were no forfeitures that had not yet been applied to reduce Company contributions and no forfeitures were used to reduce Company contributions.

Payment of Benefits

Upon termination of service, participants receive the value of their account in the form of a lump-sum payout or substantially equal installments.

Participant Loans

Participants may borrow from their accounts a minimum of \$500, up to a maximum of \$50,000, not to exceed 50 percent of the vested interest of the participant's balance. The balance in the participant's account secures the loans. Principal and interest are paid ratably over the term of the loan through payroll deductions (not to exceed 5 years). Loan terms range from one to five years unless the loan is used for the purchase of a principal residence. The loan bears interest at the prime rate plus 2%, as determined by the plan administrator on the first day of the month the loan is originated. The rate of interest will be constant throughout the term of the loan.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**1. Description of the Plan and Significant Accounting Policies (continued):**

Administrative Expenses

The Company pays most of the Plan's administrative expenses. Loan fees are paid by the participants who have outstanding loans with the Plan.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair values reported by Reliance Trust Company, the Custodian of the assets. Net appreciation and depreciation in the fair value of investments consists of the realized gain or loss on disposition of investments, plus the unrealized increase or decrease in the fair value of investments held from the beginning of the Plan year or date of purchase, whichever is later. Dividends are also included in net appreciation and are recorded on the ex-dividend date.

Receivables

Receivables are recorded for employer contributions and participant deferrals for the years ended December 31, 2024, and 2023, for amounts that are remitted to the Custodian subsequent to year end. Receivables are presented in the statement of net assets available for benefits, net of the allowance for doubtful accounts. At December 31, 2024, and 2023, there were no contributions receivable.

Excess Contributions Payable

Excess contributions payable consists of participant deferrals in excess of amounts allowed under top-heavy rules and are refunded to the participant. At December 31, 2024, and 2023, there were no excess contributions payable.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date on which the financial statements were available to be issued.

**4. Fair Value Measurements:**

The fair value measurement and disclosure topic of FASB ASC, establishes a framework for measuring fair value.
