Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Team Beans, LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1. Description of Plan

The following brief description of the Team Beans, LLC 401(k) Profit Sharing Plan (the “Plan”) is for general information only. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan was established on January 2, 1997 and was amended and restated on May 30, 2022. The Plan is a defined contribution plan that covers substantially all employees of Team Beans, LLC and its affiliated companies (the “Company” or “Employer”). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”) and is administered by the Retirement Committee of the Company.

Eligibility

Employees of the Company are eligible to participate in the Plan after reaching the age of 21 and after completing three months of service with the Company.

Contributions

Participants may elect to contribute pre-tax and Roth contributions, up to the maximum amount permitted by the Internal Revenue Code (“IRC”) up to 90% of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make annual catch-up contributions.

Eligible employees are automatically enrolled in the Plan at a 3% pre-tax deferral percentage. Employees may elect not to participate in the Plan. Employees that are automatically enrolled in the Plan have their pre-tax deferral contribution percentage escalated by 1% annually, on the anniversary of their automatic enrollment, unless the employee makes a contrary election. The automatic escalation cannot increase an employee’s pre-tax deferral rate higher than a maximum rate of 10%.

Eligible employees will receive an employer matching contribution equal to 50% of the participant’s contributions up to 6% of the participant’s eligible compensation calculated on a pay period basis.

Vesting

Participants are immediately and fully vested in their own contributions, plus actual earnings thereon and become vested in discretionary nonelective contributions and employer matching contributions, plus actual earnings thereon, according to the following schedule:

Forfeitures

The Plan provides for terminated employees who resume employment within five years to have any forfeited amounts reinstated (“reinstatement period”), if the employee repays the full amount of the distributions attributable to the vested employer contributions prior to the end of the reinstatement period. Subsequent to the reinstatement period, plan participants’ forfeitures may be used to pay plan expenses or reduce employer matching contributions. Any remaining amount shall be applied toward succeeding plan years until fully utilized. Forfeitures from participants for the year ended December 31, 2024 were approximately \$37,000. Plan forfeitures of approximately \$116,000 were applied in conjunction with the payment of employer matching contributions for the year ended December 31, 2024. As of December 31, 2024 and 2023, the available balance of forfeitures was \$11,000 and \$90,000, respectively.

Participant Accounts

Each participant’s account is credited with their contributions, employer contributions, and the earnings thereon. Contributions to the Plan are invested by the custodian as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The maximum term of the loan is five years; or thirty years if the loan is for the purchase of a principal residence. Participants must repay any outstanding loan before a new loan can be made. Loans are secured by the balance in the participant’s account and bear interest at the prime rate in effect in the month a participant takes a loan plus one percent (1%). Notes receivable from participants are repaid through payroll deductions and monitored by the Plan Administrator. Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. As of December 31, 2024, the interest rates on the outstanding notes receivable from participants ranged from 4.25% to 9.50%.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants before March 15, 2025.

Benefits Paid to Participants

A participant’s vested interest in his or her account balance is distributable upon normal retirement (65), termination, hardship withdrawal, disability, or death, as described by the Plan Document. Participants can also make in-service withdrawals upon reaching age 59½.

Other Income

Other income represents revenue from certain investments as described in Note 7.

Subsequent Events

The Company has evaluated subsequent events for the Plan through October 13, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Administrative Expenses

All transaction fees for loan and distribution requests are paid from participants' accounts. Substantially all other administrative expenses are to be paid by the Plan through the forfeiture account or the ERISA expense account (see Note 7), if available, otherwise they are to be paid by the Company.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year and held at year-end.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefits are recorded when paid.

Note 3. Information Certified by the Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company ("Reliance"), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies during 2024.

Mutual Funds: Valued at quoted prices reported in an active market at year-end.

Common Collective Trust Funds: The fair value of the common collective trust is determined by the custodians of the common collective trust fund based on the underlying assets, which represent the net asset value, a practical expedient to fair value of units held by the Plan. The common collective trusts do not have any unfunded commitments relating to its investments, or any restrictions on redemptions. Redemptions can be made on any business day and do not have a redemption notice period.

Stable Value Fund: Composed primarily of fully-benefit responsive investment contracts and is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate the fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There are no participant redemption restrictions for these investments and the redemption notice period of 12 months is applicable only at the Plan level.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Plan Termination

Although it has not expressed any intention to do so, the Company reserves the right to amend, alter or terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, the amount credited to the account of each participant will be fully vested.

Note 6. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by ADP. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Party-in-Interest Transactions

ADP is the record keeper for the Plan and therefore, these services qualify as party-in-interest transactions. Fees paid by the Plan to ADP for recordkeeping and administrative services were approximately \$7,000 for the year ended December 31, 2024.

ADP receives revenue from certain investments in the Plan. ADP and the Employer have agreed that if this revenue exceeds an agreed-upon revenue rate, ADP shall make an amount equal to such excess available to the Plan to pay ERISA qualified plan administrative expenses. For the year ended December 31, 2024, an excess of approximately \$21,000, was made available to the Plan and was used to pay for ERISA qualified plan administrative expenses. There was no remaining balance available to pay future expenses of December 31, 2024.

Note 8. Risks and Uncertainties

The Plan's investments are concentrated in common collective trust funds and mutual funds that invest in various investment securities. Such securities are subject to various risks, such as interest rates, market, and credit risks that determine the value of the investments. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that the changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.
