### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of JC Ford Company 401(k) Profit Sharing Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### *Opinion*

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. **Note 1:**      **Description of Plan**

The following description of the JC Ford Company 401(k) Profit Sharing Plan & Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established on January 1, 2004, to provide all eligible employees of JC Ford Company with retirement benefits in accordance with section 401(k) of the Internal Revenue Code (IRC). The Plan covers all regular, part-time and full-time employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

Company employees are eligible to participate in the Plan upon attaining the age of 21. After the completion of three consecutive months of service, participants are eligible to make elective deferral contributions. In addition, after the completion of at least one year of service, participants are eligible to receive Company discretionary profit-sharing contributions. Employees are eligible to enter the Plan on the first day of each calendar month of the plan year, coincident with or next following satisfaction of the eligibility requirements.

**Contributions**

Employees may elect to make pre-tax contributions up to 100% of their eligible compensation, subject to limits imposed by the IRC. The percentage elected by the participants is withheld from their paychecks and contributed to the Plan by the Company. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employees who have met the eligibility requirements and have not already elected to participate in the Plan are automatically enrolled with a 3% deferral rate unless they opt out.

The Plan provides for discretionary profit-sharing contributions in an amount determined by the Company's Board of Directors. Discretionary profit-sharing contributions are allocated to eligible participants on a pro-rata basis, based on the percentage that each participant's compensation bears to total compensation for the plan year. During the year ended December 31, 2024, the Company did not make a discretionary profit-sharing contribution to the Plan.

The Plan also provides for discretionary qualified non-elective contributions (QNEC) to non-highly compensated employees equal to the percentage of the participant's compensation to the total compensation of all eligible participants in a given plan year. During the year ended December 31, 2024, the Company did not make a discretionary QNEC to the Plan.

**Forfeitures**

At December 31, 2024 and 2023, there were no forfeited non-vested accounts. Forfeited non-vested accounts can be used to fund Company matching contributions and plan expenses.

**Participant Accounts**

Each participant's account is credited with the participant's own contributions, an allocation of the Company's contributions, and an allocation of net earnings from investments and changes in investment values and Plan administrative expenses. Allocations are based on each participant's contributions, earnings, or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's account.

**Vesting**

Participants are always fully vested in their own contributions and earnings thereon. Participants vest in discretionary profit-sharing contributions over six years, as follows: 20% after two years, 40% after three years, 60% after four years, 80% after five years and 100% after six years of credited service.

**Payment of Benefits**

Upon termination of employment due to retirement, death, disability or separation from service, the balances in the participants' accounts will be distributed to the participants or to their beneficiaries in either a lump sum, equal installments in the form of nontransferable annuity, or some combination of the foregoing, at the election of the beneficiary.

**Notes Receivable from Participants**

Participants are allowed to borrow a minimum of \$1,000 up to one-half of their vested balance, up to a maximum of \$50,000. Participants may only have one loan outstanding at any time. Loans bear a reasonable fixed-rate of interest, which is determined by the Plan custodian. Generally, loans must be repaid over a maximum of five years. The loans are secured by the participant's account balance.

**Administrative Expenses**

The Company, as Plan sponsor, pays certain administrative expenses on behalf of the Plan. Participants' accounts are adjusted for fees pertaining to loan or termination processing, and are charged for expenses incurred by the custodian in the performance of their duties.

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Payment of Benefits**

Benefits are recorded when paid.

**Investment Valuation and Income Recognition**

Investments are stated at fair value and contract value as certified by the Plan's custodians. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Use of Estimates**

In preparing the financial statements in accordance with accounting principles generally accepted in the United States of America, management makes estimates and assumptions which affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Note 3:**      **Information Certified by the Custodian**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the custodian of the Plan).

**Note 4:**      **Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

Level 1) Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2) Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3) Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a PSA is calculated based on a compilation of primarily observable market information. There are no unfunded commitments or redemption restrictions as of December 31, 2024 and 2023.

**Note 5:**      **Plan Termination**

Although it has not expressed any intent to do so, the Plan sponsor reserves the right to terminate the Plan at any time. In the event of Plan termination, all accounts become fully vested and non-forfeitable. Plan assets would first be used to pay any expenses properly charged to the Plan. The remainder would then be distributed to participants in a lump sum.

**Note 6:**      **Tax Status**

On June 30, 2020, the IRS stated that the non-standardized pre-approved plan adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognizes tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7:**      **Party-In-Interest Transactions**

Certain Plan investments include shares of registered investment company funds managed by John Hancock Life Insurance Company (John Hancock). As John Hancock is the custodian of the Plan, transactions with this entity qualify as exempt party-in-interest transactions.

**Note 8:**      **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9:**      **Reconciliation to Form 5500**

The financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP), which differ from the reporting requirements of the Department of Labor's Form 5500. As a result, certain classification differences arise in the presentation of participant contributions. Specifically, excess participant contributions, including related earnings, identified during the plan year and subsequently refunded to participants, are not reported as contributions in the financial statements under US GAAP. Instead, these amounts are recorded as a liability and reduce participant contributions for the year. In contrast, Form 5500 instructions require that such amounts be reported as contributions when deposited and as corrective distributions when returned to participants. Accordingly, a reconciliation is provided to align the financial statement amounts with those reported on Form 5500.
