1. Description of Plan

The following brief description of The Neil Jones Food Company 401(k) Plan (the “Plan”), formerly The Northwest Packing Company Thrift Plan, is provided for general information purposes only. Participants should refer to the plan agreement for more complete information. The Plan was established to provide eligible employees of The Neil Jones Food Company dba Northwest Packing Company (the “Company”) with retirement benefits.

General

The Plan is a defined contribution plan covering eligible employees of the Company whose employment is not governed by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). A committee appointed by the Company’s board of directors is responsible for overseeing the Plan’s operations, determining the appropriateness of the Plan’s investment offerings, and monitoring investment performance.

Periodically, certain participant accounts may be transferred between the Plan and The Neil Jones Food Company Union Employees’ 401(k) Plan (the “Plan”) due to changes in the status of the employees’ membership in the Teamsters District Council No. 2, Local 388M union and Teamsters Local Union No. 890.

Employees who have completed one consecutive month of service and have reached their 21st birthday are eligible to make contributions to the Plan beginning on the first day of the month following satisfaction of the Plan’s entrance requirements for elective deferrals.

Employees who have completed one year of service, defined by the Plan as 1,000 or more hours of service during the twelve month period subsequent to each respective employee’s date of hire or a subsequent plan year, and reached their 21st birthday are eligible to begin receiving employer matching contributions commencing on the first day of the next January or July following the satisfaction of the Plan’s eligibility requirements for employer matching contributions.

Employees who have completed one year of service, as defined, and reached their 21st birthday may be eligible to begin receiving employer profit sharing contributions commencing on the first day of the next January or July following the satisfaction of these eligibility conditions. Once eligible, participants will not be entitled to share in the employer profit sharing contributions made for the plan year if they terminate employment with the Company, or complete less than 1,000 hours of service, during the plan year. However, if termination is on account of death, disability, or attainment of normal retirement age, a participant will be entitled to share in any employer profit sharing contributions made for that year regardless of number of hours of service performed.

Contributions

Each year participants may contribute to the Plan a designated percentage of their compensation, as defined in the plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from certain other qualified plans. The Plan includes an automatic enrollment feature under which newly eligible employees are enrolled at a default deferral rate of 2 percent of eligible compensation, unless they elect otherwise. Contributions under this provision are directed to a designated default investment option until changed by the participant. Unless modified, the default deferral rate increases by 1 percent annually on the anniversary of the participant's automatic enrollment date, up to a maximum of 5 percent of eligible compensation.

Under the terms of the plan document, the employer may elect to make discretionary matching contributions to eligible participants. For the year ended December 31, 2024, the Company elected to remit a safe harbor matching contribution to eligible participants in an amount equal to 100 percent of eligible employee contributions up to the first 3 percent of eligible compensation deferred, and 50 percent of eligible employee contributions up to the next 2 percent of eligible compensation deferred, as defined. Once they have become eligible to begin receiving employer matching contributions, participants are entitled to share in the Company matching contributions made for a plan year if they have made elective contributions during the year regardless of the number of hours of service they worked during the year, or whether or not they are employed on the last day of the plan year.

In addition, the Company may elect to make employer profit sharing contributions. A participant's employer profit sharing contribution is determined by the ratio of the participant's annual compensation to the total annual compensation of all participants who are eligible to share in the employer profit sharing contributions for the year. Participants will not be entitled to share in the employer profit sharing contributions made for the plan year if they terminate employment with the Company or complete less than 1,000 hours of service during the plan year. However, if termination is on account of death, disability, or attainment of normal retirement age, a participant will be entitled to share in the employer's supplemental contribution made for that year regardless of number of hours of service performed.

Participants direct the investment of all contributions credited to their accounts into any of the various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings. Participant accounts are charged with an allocation of certain distribution expenses that are paid by the Plan which consist of expedited overnight delivery fees for distribution checks as requested by participants. Allocations are based on participant earnings, account balances, or specific participant initiated transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, including salary deferral, catch-up, and rollover contributions, and employer safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions portion of respective participant accounts is based on credited years of service, as defined. A participant is 100 percent vested in the Company's discretionary matching and profit sharing contributions after five years of credited service as follows:

1	20%

Payment of benefits

Company contributions become fully vested upon a participant's disability, death or attainment of normal retirement age 65, regardless of years of service. Participants who terminate after vesting, but prior to early retirement age, may elect to receive a 401(k) benefit in the form of a nontransferable joint and survivor annuity or a lump sum. Plan benefits may be paid directly to retirees from Plan assets or funded through purchase of annuities.

Forfeited accounts

At December 31, 2024 and 2023, no forfeited nonvested accounts were held by the Plan. These accounts may be used to reduce future employer contributions or to pay plan expenses.

2. Summary of Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees initiated by participant requests for expedited overnight distribution delivery services are charged directly to the related participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events

Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank and ADP Retirement Trust Services, LLC.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1. Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or

liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. Fair values are provided by the Plan's investment custodian for all of the Plan's assets as follows:

- Common/collective trust investments are valued at the net asset value ("NAV") of units of a collective investment trust. The NAV, as provided by the custodian, is used to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This value is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions, including purchases and sales, are valued on a daily basis. Certain participant-initiated withdrawals may be executed subject to a redemption notice period. Were the Plan to initiate a full redemption of certain investments, under the terms of the collective trust agreement the investment issuer may reserve the right to temporarily delay withdrawal from the fund.
- Registered investment companies, including money market accounts and other mutual funds, are valued at the daily closing price as reported by the fund. Registered investment company investments held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Insurance company general accounts are value at the book value of the accounts, net of any market value adjustments determined by the issuer, plus accrued interest. There are no reserves against these accounts for credit risk of the issuer or otherwise. The crediting rate for these accounts is determined by the issuer. The Plan's investments in unallocated contracts and the related accrued interest income are subject to the credit risk of the issuer and are solely funded by the assets held in its general account. Unallocated contracts are classified in Level 3 of the fair value hierarchy and are presented at fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party and Party-In-Interest Transactions

Certain of the Plan's investments are managed by Standard Insurance Company, affiliates of which served as a recordkeeper for the Plan during 2024, therefore, these transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid at the investment level rather than by direct payments from the Plan. The Plan made direct payments of administrative expenses totaling \$30,287 during the year ended December 31, 2024. The Company pays directly certain other fees related to the Plan's operations.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the employer contributions portion of their accounts.

7. Tax Status

The Plan has adopted a volume submitter profit sharing plan document which the Internal Revenue Service has determined by a letter dated October 6, 2020 to be designed in accordance with applicable sections of the Internal Revenue Code (the "IRC"). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with applicable sections of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
