December 31, 2024

1. Description of Plan

The following description of the Golub & Company LLC 401(k) Plan (the Plan) provides only general information about the Plan's provisions. Golub & Company LLC (the Company) is the Plan's sponsor. Participants should refer to the summary plan description and other plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, formed April 1, 1994, and is subject to the requirements of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan has a 401(k) component and was established to provide retirement benefits for employees of the Company. Reliance Trust Company is trustee of the Plan and State Street Bank and Trust Company is custodian of the Plan's investments. ADP Retirement Plan Services is the record-keeper for the Plan.

Substantially all employees, other than those hired on a temporary or periodic basis, who have attained the age of 21 years are eligible to participate. Eligible employees can enroll in the Plan immediately.

Contributions

Each year, participants may contribute from 1% to 80% of eligible annual compensation, as defined in the Plan, subject to maximum amounts established by the Internal Revenue Code (the Code), pursuant to Section 401(k) of the Code. Participants age 50 or more are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company may make a discretionary matching contribution, in cash, based on the participant's elective deferral in a percentage set by the Company prior to the end of each plan year. Generally, participants must be employed on the last day of the plan year to be eligible for the Company's contributions. For the year ended December 31, 2024, the Company contributed 5% of the amount each participant contributed to the Plan. All contributions are subject to certain limitations of the Code.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, employer's contributions, if any, and allocations of the Plan's earnings. Plan earnings are allocated based on the participants' share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on participant account balances, as defined in the Plan. The benefit to which a participant is entitled is the balance that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's contribution portion of their accounts plus actual earnings thereon is based on years of credited service, as defined in the Plan. Participants in the Plan vest under the following schedule:

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. If a participant is rehired within a five-year period, the forfeited contributions may be reinstated. Forfeited balances of terminated participants' non-vested accounts are used to reduce employer contributions or to pay the Plan's expenses. Unallocated forfeited balances as of December 31, 2024 and 2023, were \$12,467 and \$570, respectively. Forfeitures of \$13,658 were used to reduce the 2024 discretionary matching contribution that was funded in 2025.

1. Description of Plan (continued)

Participant Loans

Participants may borrow (subject to certain restrictions) from their plan accounts a minimum of \$500 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. All loans are to amortize over a reasonable period of time not to exceed 5 years, or 30 years for purchases of real estate that is to serve as the participant's primary residence. Loans are secured by the vested balance in the participant's account and are to bear interest at the Prime Rate plus 2% as published in *The Wall Street Journal* on the 14th day of each month. Principal and interest are to be paid through payroll deductions or cash installments whenever payroll deductions are not possible. In the event of a participant termination, the participant loan amount outstanding is due immediately.

Payment of Benefits

In the event of the participant's retirement, termination of service, death, or disability, the participant or the participant's beneficiary may receive a lump-sum amount equal to the vested value of his or her account. Installment payments and partial withdrawals are also available as outlined in the plan document. Participants may obtain withdrawals of any portion of their participant contributions after attaining the age of 59 1/2 or for certain financial hardship situations. Such withdrawal will be authorized by the plan administrator only upon satisfaction of criteria as enumerated in the plan agreement.

Administrative Expenses

Administrative expenses, consisting principally of accounting and trustee fees, are paid by either the Company or the Plan, as provided by the Plan's provisions. Certain transaction charges are paid by the Plan.

Investment Options

Participants may direct their contributions and employer contributions among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan's provisions.

1. Description of Plan (continued)

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest-level input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan:

Mutual funds – Valued at the quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

Common collective trusts – Valued at the NAV provided by the administrator of the fund.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Tax Status

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related-Party and Party-in-Interest Transactions

The Plan holds units of common collective trusts managed by State Street Bank and Trust Company, the custodian of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

8. Subsequent Events

Management evaluated subsequent events for the Plan through October 14, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan amended its trust agreement to change its trustee from the Reliance Trust Company to ADP Retirement Trust Services, LLC.
