- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's responsibilities for the audit of the financial statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter - supplemental schedule required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - PLAN DESCRIPTION

The following description of The Pep Boys Savings Plan - Puerto Rico (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established April 1, 1995. The Plan is a defined contribution plan which is intended to allow participating employees of Pep Boys - Manny, Moe & Jack of Puerto Rico, Inc. (the "Company"), to save for retirement. The Plan is sponsored by the Company, which is a subsidiary of The Pep Boys - Manny, Moe & Jack LLC ("Pep Boys"). In addition to retirement benefits, the Plan provides certain benefits in the event of death, disability, or other termination of employment. The Plan is for the exclusive benefit of eligible employees and their beneficiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Trustee of the Plan is Banco Popular and prior to August 1, 2024, T. Rowe Price Trust Company ("T. Rowe Price") serves as the asset custodian and recordkeeper. Effective August 1, 2024, the Company changed the asset custodian and recordkeeper to Fidelity Management Trust Company ("Fidelity").

Eligibility

Full-time employees and part-time employees are eligible to participate immediately upon hire.

Contributions

Participants can contribute up to 75% of before-tax eligible compensation as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, participants may at any time elect to rollover amounts from other qualified plans or individual retirement accounts into the Plan. Regardless of participation status, an employee who has met the eligibility requirements of the Plan is able to complete a rollover.

Upon meeting the eligibility requirements, participants who do not affirmatively make a deferral election will be automatically enrolled in the Plan at 6% of their eligible compensation as a pre-tax contribution. Prior to August 1, 2024, the automatic enrollment period took effect twelve months after becoming eligible. Effective August 1, 2024, the automatic enrollment period was reduced to 90 days. A participant that is automatically enrolled shall have their contribution rate of 6% increased by 1% annually up to 15% unless an affirmative election is made by the participant to change their contribution rate.

The Company may contribute to the Plan, on behalf of each eligible participant, a discretionary matching contribution. Effective August 1, 2024, the Company began making a discretionary matching contribution equal to 50% of the elective deferrals up to 6% of the participant's eligible compensation on a payroll period basis. From April 1, 2020 through July 31, 2024, the match was suspended.

During the year ended December 31, 2024, there were approximately \$102,000 in discretionary matching contributions made.

Contributions are subject to certain Puerto Rico Internal Revenue Code ("IRC") limitations.

Participant Accounts

A separate account is established for each participant. The account is credited or charged, as applicable, with the participant's salary deferral contributions, an allocation of the Company's contributions, the participant's share of investment earnings and losses, the participant's distributions and certain

administrative charges. Allocations are based on participant earnings or account balances, as defined. Participants direct the investment of their account into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting

Participants hired prior to October 1, 2016 are fully vested at all times in their accounts. Participants hired or rehired after October 1, 2016 are immediately vested in participant contributions and funds rolled over from another plan plus earnings thereon, while vesting in the Company's discretionary matching contributions made prior to August 1, 2024, plus earnings thereon, is based on years of continuous service according to the following schedule:

Effective August 1, 2024, vesting for participants hired after October 1, 2016 for the Company's discretionary matching contributions made after August 1, 2024, plus actual earnings, thereon, is the following:

Participants are 100% vested if employed by the Company upon death, disability, or upon attainment of age 65.

Forfeitures

An employee may forfeit the non-vested portion of their account if employment ceases and the employee is less than 100% vested in any Company contributions made to their account. Forfeitures are retained in the Plan and may be used to reduce future Company contributions, to the extent any such contributions are made, or to pay Plan expenses. If forfeitures remain after all contribution obligations are satisfied or upon termination of the Plan, and such forfeitures cannot be used to pay Plan expenses, the remainder shall be re-allocated among participants. Forfeited non-vested accounts totaled \$3,805 and \$800 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$3,494 of forfeitures were used to offset plan expenses.

Payment of Benefits

Upon retirement, disability, death or termination of service, a participant may receive a lump sum distribution equal to the value of the vested portion of his or her account. Distributions are subject to the applicable provisions of the Plan document. The Plan allows in-service withdrawals to participants upon attaining age 59½ and hardship withdrawals, under certain conditions based on participant eligibility and approval by the Plan Administrator.

Notes Receivable from Participants

Participants may borrow from their accounts, up to a maximum equal to the lesser of 50% of their vested account balance at the time of the loan or \$50,000 less the amount of the highest outstanding loan balance in the prior 12-month period. The maximum term of a general loan is five years and the maximum term of a loan for the purchase of a primary residence is 15 years. The loans are secured by the balance in the participants' accounts and bear interest at fixed rates charged by institutions in the business of lending money for similar types of loans. Interest rates ranged from 4.25% to 9.50% at December 31, 2024 and 2023. Participants may have only one loan outstanding at any one time and can prepay loans in full at any time. Principal and interest is primarily paid ratably through payroll deductions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("US GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Other Income

Prior to August 1, 2024, T. Rowe Price Retirement Plan Services, Inc. received certain pricing credits and/or revenue sharing payments for administrative services associated with certain investments offered in the Plan and periodically shared those pricing credits and/or revenue sharing payments with the Plan and allocated them to participants in proportion to their account balances invested in those options.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. The recordkeeper of the Plan charges a quarterly administrative fee that is charged directly to the participant accounts.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

NOTE C - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds - Valued at the NAV of units held by the Plan at year end, as determined by the fair value of the underlying assets. Underlying assets include commingled pools of exchange traded equity, fixed income and/or short-term investments and index funds of exchange traded equity, bond and debt securities.

Stable value fund - A stable value fund valued at the NAV of units of a collective trust. The NAV is calculated by the fund based on net assets, which includes fully benefit-responsive investment contracts at contract value. This NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund and is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with industry practices, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

The Plan Administrator has elected to have the audits performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan Administrator determined that the certifications received from the T. Rowe Price and Fidelity meet the requirements of ERISA Section 103(a)(3)(C). T. Rowe Price and Fidelity certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 was certified by Fidelity and December 31, 2023 was certified by T. Rowe Price;
- Investment income, interest income on notes receivable from participants, and other income, as shown in the statement of changes in net assets available for benefits for the period January 1, 2024 through July 31, 2024 was certified by T. Rowe Price and the period August 1, 2024 through December 31, 2024 was certified by Fidelity; and
- Schedule H, Line 4i - schedule of assets (held at end of year) as of December 31, 2024 was certified by Fidelity.

NOTE E - TRANSACTIONS WITH PARTIES-IN-INTEREST

During the year ended December 31, 2024, certain Plan investments were held and managed by T. Rowe Price and by Fidelity. Both T. Rowe Price and Fidelity were parties-in-interest during 2024 and therefore these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules. Notes receivable from participants also qualify as allowable party-in-interest transactions.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company contribution portion of their accounts.

NOTE G - TAX STATUS

The Puerto Rico Department of Treasury has determined and informed the Company by a letter dated December 26, 2017 that the Plan meets the requirement of Section 1081.01 of the Puerto Rico IRC of 2011, as amended, and the regulations thereunder, and that the trust established thereunder is entitled to exemption from Puerto Rico income tax. In addition, pursuant to the authority of Section 1022(i)(1) of ERISA, the trust is exempt from United States income taxes under Section 501(a) of the United States IRC of 1986, as amended. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Puerto Rico Department of Treasury. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
