## Report of Independent Auditors

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Gracie Square Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following brief description of the Gracie Square Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information. The Plan's sponsor is The New York Gracie Square Hospital, Inc. (the Hospital).

The Plan, which was established and became effective January 1, 1975, was most recently amended and restated on January 1, 2022. The amended and restated provisions of the Plan became effective retroactive to the Plan's inception.

The Plan is a noncontributory defined contribution money purchase pension plan covering eligible non-union employees of the Hospital. An eligible employee will be deemed to have completed six months of service in the employment of the Hospital at any time six months after the employee's employment commencement date. An eligible employee becomes a participant on the first day of the plan year (January 1) following the date that the employee satisfies the eligibility requirements. Participants are eligible to vest in contributions provided they have completed 1,000 hours of service during the plan year.

Normal retirement is upon attainment of 65 years of age. A participant may remain employed past the normal retirement date and continue to receive an allocation of the contributions made by the Hospital. Upon retirement and having attained the normal retirement age, a participant will be entitled to 100% of the participant's account balance, beginning at a reasonable time after retirement.

Upon the death of a participant while in active employment, the entire amount credited to the participant's individual account, as of the date of death, shall become vested and the plan administrator shall direct the trustee to distribute the vested amount to the participant's beneficiary. Certain optional terms of payment can be elected which provide for additional forms of death benefits.

If the employment of a participant is terminated other than by death, prior to retirement, the plan administrator shall distribute the amount credited to the participant's individual account which is determined to be vested as of the date of termination of employment. A calculation will be made of the percentage of the account which is vested based upon the years of service completed.

### 1. Description of the Plan (continued)

The years of service contribution formula provides for contributions as a percentage of eligible compensation, as follows:

<b>Years of Service</b>	<b>Contribution %</b>
1-4	5%
5-9	6
10-14	7
15-19	8
20 or more	10

Additionally, should a participant not be eligible for a contribution under the above formula, solely because the participant did not complete a year of service during the Plan year, a contribution shall be made based on 3% of the employee's eligible compensation. The percentage is subject to change depending on annual testing.

Participant vesting is based upon years of service. Effective January 1, 2007, the Plan was amended to provide vesting for currently employed participants, as follows:

#### 1. Description of the Plan (continued)

Effective January 1, 2019, the plan was amended to change the vesting schedule according to which participants vest in their Plan accounts, from a six-year grade schedule noted above to a three-year cliff. For participants who terminated between October 21, 2008 and December 31, 2018, a participant's account shall vest to the previous vesting table noted above. For Plan years beginning on and after January 1, 2019, a participant's account shall vest according to the following schedule:

The Plan does not recognize compensation in excess of the Internal Revenue Service (IRS) maximum compensation limits. The Hospital's total contribution will be reduced by the aggregate amount of forfeitures, if any, with respect to the plan year or to pay reasonable plan administrative expenses. Forfeitures are recognized as reductions in employer contributions at the earlier of (1) the participant's distribution; or (2) after the employee incurs five consecutive one-year breaks in service. For the year ended December 31, 2024, \$13,259 in forfeitures were used to offset employer contributions. No forfeitures were used to offset employer contributions for the year ended December 31, 2023. As of December 31, 2024 and 2023, unused forfeitures were approximately \$16,000 and \$8,000, respectively.

The Hospital is the plan administrator. Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to amend or terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). In the event of termination or partial termination of the Plan, all affected participants who are employed as of the date of termination or partial termination shall be fully vested.

#### **2. Summary of Significant Accounting Policies**

The following is a summary of the Plan's significant accounting policies:

*Basis of Accounting:* The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

*Valuation of Investments:* The Plan's investments consist of mutual funds and a guaranteed investment contract. All investments held by the Plan, except for the fully benefit-responsive investment contract, are stated at fair value. Fair values generally are determined based on closing quoted market prices on an active market as of December 31 of each year.

The Guaranteed Long-Term Account (GLTA) is a guaranteed investment contract. The Plan sponsor has determined that the GLTA is fully benefit-responsive and, therefore, is reported at contract value in the accompanying statements of net assets available for benefits. Contract value is the relevant measurement as contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions plus earnings, less participant withdrawals, and administrative expenses.

*Investment Transactions:* All investment transactions are recorded on the dates such trades take place. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The realized gain or loss resulting from these transactions is the difference between the proceeds received and the average historical cost of the assets sold. The change in the difference between the fair value and the cost of investments held, plus net realized gains or losses, is reflected in the statements of changes in net assets available for benefits as net realized and unrealized appreciation in fair value of investments.

*Contributions:* Employer contributions are recognized when earned. Employees are not permitted to make contributions to the Plan.

*Payment of Benefits:* Benefits are recorded when paid.

*Administrative Expenses:* Custodial fees to the Plan trustee are paid directly from Plan assets. Legal and accounting fees and fees for other services rendered are paid by the Plan sponsor. Expenses that are paid by the Plan sponsor are excluded from these financial statements.

#### **2. Summary of Significant Accounting Policies (continued)**

*Use of Estimates:* The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **3. Investments**

Certain information related to investments disclosed in the accompanying financial statements and the supplemental schedule, including investments held at December 31, 2024 and 2023, and net realized and unrealized appreciation in fair value of investments and interest and dividend income for the years then ended, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by Prudential Bank & Trust, FSB, Empower Trust Company, LLC, and Empower Annuity Insurance Company.

On April 1, 2022, Empower Annuity Insurance Company of America (EAICA), formerly known as Great-West Life & Annuity Insurance Company, the parent company of Empower Retirement, LLC (Empower) acquired the full-service retirement business of Prudential Financial, Inc. (Prudential), including Prudential Retirement Insurance and Annuity Company (PRIAC) and Prudential Bank & Trust, FSB (PB&T). Empower became the recordkeeper of the Plan. Additionally, on October 3, 2022, PRIAC was renamed Empower Annuity Insurance Company (EAIC). Lastly, on March 31, 2023, PB&T was merged into Empower Trust Company, LLC (ETC).

Effective October 21, 2023, the Plan's recordkeeping and plan level reporting system with Prudential moved to Empower. Custody of the assets remains with EAIC for certain investments previously issued by Prudential. All other investments are held by Empower Trust Company, LLC.

ETC and EAIC are the current trustees and custodians of the Plan.

#### 4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The Plan uses a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

*Level 1:* Quoted prices (unadjusted) in active markets that are accessible at the measurement date for identical assets or liabilities.

*Level 2:* Observable inputs that are based on inputs not quoted in active markets, but corroborated by market data.

*Level 3:* Unobservable inputs are used when little or no market data is available.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based upon the lowest level input that is significant to the fair value measurement in its entirety.

All Plan investment assets at fair value, which consist of mutual funds, are classified as Level 1 at December 31, 2024 and 2023.

The following is a description of the Plan's valuation methodologies for assets measured at fair value. Fair value for Level 1 assets is based upon quoted prices in an active market. The methods described above may produce a fair value that is not indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting dates.

#### **5. Fully Benefit-Responsive Investment Contract**

As described in Note 2, the Plan invests in the GLTA, which is a fully benefit-responsive investment contract. The issuer maintains the contributions for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan as further described below.

The GLTA does not have a maturity date or penalties for early withdrawals. The contract issuer for the GLTA is contractually obligated to repay the principal and interest at specified interest rates that is guaranteed to the Plan. The crediting rate for the GLTA is based on a formula established by the contract issuer but may not be less than 1.0% or greater than 3.0%; the crediting rate is reviewed on an annual basis for resetting.

The Plan's ability to receive amounts due in accordance with a fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet their financial obligations. The issuer's ability to meet their contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Premature termination of a contract
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

#### **5. Fully Benefit-Responsive Investment Contract (continued)**

In addition, certain events allow an issuer to terminate its contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

The Plan administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with the contract issuers or participants is probable.

#### **6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **7. Commitments and Contingencies**

Effective January 1, 2009, the IRS issued final regulations for purposes of determining common control for qualified retirement plans sponsored by tax-exempt organizations. In general, tax-exempt entities that are under common control are treated as one entity for certain of the requirements of qualified plans. The regulations determine control based on facts and circumstances; for this purpose, common control would exist if, among other situations, at least 80% of the directors or trustees of one organization were either representatives of, or directly or indirectly controlled by, another organization. These regulations could have an effect on the operations of the Plan and the responsibilities of those entities for associated liabilities, such as the Hospital acting as the Plan sponsor, although such effects are uncertain at this time.

### Notes to Financial Statements (continued)

#### **8. Tax Status**

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated December 16, 2022, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require the plan administrator to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **9. Party-in-Interest Transactions**

The Plan holds certain investments managed by a trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

#### **10. Subsequent Events**

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued. No subsequent events have occurred that require disclosure in, or adjustment to, the financial statements.
