INDEPENDENT AUDITOR'S REPORT

To the Employee Benefits Committee of
Four Seasons Hotels Employee Benefits Plan

Opinion

We have audited the accompanying financial statements of Four Seasons Hotels Employee Benefits Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits - modified cash basis of Four Seasons Hotels Employee Benefits Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits - modified cash basis for the years then ended, in accordance with the modified cash basis of accounting as described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Four Seasons Hotels Employee Benefits Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. 1. DESCRIPTION OF THE PLAN

The following description of the Four Seasons Hotels Employee Benefits Plan (the "Plan") provides only general information about the Plan's provisions. Participants should refer to the plan agreement for a more complete description of the Plan.

General

The Plan provides health benefits to eligible employees of the employers participating within the Plan and their covered dependents. At December 31, 2024 and 2023, approximately 50 employers (individual hotels) were participating within the Plan. Plan assets are held in a voluntary employee's beneficiary association ("VEBA") trust. The Employee Benefits Committee of Four Seasons Hotels Limited is the Plan Sponsor. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 as amended ("ERISA").

Insured benefits

The Plan provides medical and prescription benefits to eligible participants. Currently such benefits are provided on a fully-insured basis. The Plan purchases annual insurance contracts for these insured benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA"), if they so elect. At each annual enrollment, provisions, such as participant contribution rates, coverage, deductibles, copays, and out-of-pocket maximums may change. Premiums for all insured benefits were paid from the assets of the VEBA trust. The VEBA trust is funded by the participating employers.

Contributions

Participating employers pay to the VEBA trust an amount equal to the premiums for all covered employees and an allocable share of administrative expenses. Participating employers may, at their sole discretion, require their employees to contribute toward the required contribution.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and use of estimates

The accompanying financial statements have been prepared using the modified cash basis of accounting. Accordingly, income is recognized when deposited and expenses when paid. No determination was made as to income earned but not received, contributions receivable, and no determination was made as to expenses incurred but not paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Cash

Cash includes interest-bearing cash held in a financial institution. At times, such deposits may be in excess of the Federal Deposit Insurance Corporation ("FDIC") insurance limit. Plan management does not believe the Plan is exposed to any significant credit risk on cash.

Insurance premiums

Insurance premiums are recorded net of any pharmacy rebates or any rebates received as a result of the medical loss ratio.

Subsequent events

Management has evaluated subsequent events for the Plan through October 15, 2025, the date the financial statements were available to be issued.

3. BENEFIT OBLIGATIONS

Health care costs incurred by participants and their beneficiaries and dependents are covered by insurance contracts maintained by the Plan. The Plan does not provide for post retirement benefits, except as provided by COBRA, and is at the expense of the retiree.

4. ADMINISTRATIVE EXPENSES

The Plan pays administrative expenses that consist of administrative fees paid to third party claims administrators, custodians, and professional service providers. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses.

5. TAX STATUS

The VEBA trust established under the Plan to hold the Plan's net assets is qualified, pursuant to Internal Revenue Code Section 501(c)(9), and accordingly, the trust's net investment income is exempt from income taxes. The VEBA trust funding certain benefits of the Plan received an exemption letter from the IRS dated November 14, 2008, stating the trust is tax exempt. The Plan's trustees believe that the trust, as amended, remains qualified and operating as designed.

The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

6. TERMINATION OF THE PLAN

Although it has not expressed any intention to do so, the Plan's Board of Directors has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner.
