To the Trustees and Participants of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Eissmann Automotive 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. GENERAL DESCRIPTION OF PLAN

The following description of the Eissmann Automotive 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Adoption document for a more complete description of the Plan’s provisions.

General

The Plan is a profit-sharing plan with a 401(k) savings option established on January 1, 2006 by Eissmann Automotive North America, Inc. (the “Sponsor”). The Plan provides retirement benefits for the employees of the Sponsor upon attainment of 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”) and the Internal Revenue Code (the “IRC”).

In February 2024, Eissmann Automotive Deutschland GmbH (the “Parent”) filed insolvency in the bankruptcy courts in Germany. The Parent owns 100% of the Sponsor. As of the date of the report, the Sponsor is not part of the bankruptcy proceedings. The ultimate effect on the Plan of the Parent’s insolvency proceedings is currently unknown.

Contributions

Each eligible participant may contribute, on a pre-tax basis, up to 100% of his or her eligible compensation (as defined) to the Plan in the form of a salary deferral. For any Plan year, elective deferrals may not exceed a specific dollar amount determined annually by the Internal Revenue Service (“IRS”). The Plan also allows participant rollover contributions from other qualified plans. Eligible employees who do not elect otherwise will be automatically enrolled in the Plan with a salary deferral of 3% of compensation, which after two years will increase annually by 1%, up to a maximum of 6%.

The Sponsor provides a qualified automatic contribution (“QACA”) safe harbor matching contribution of 100% of the first 4% of participant deferrals. The Sponsor, at its sole discretion, may also make an additional matching contribution. There was no discretionary additional matching contribution made during the year ended December 31, 2024.

Investment options

The Plan’s investment assets are held by John Hancock Life Insurance Company (U.S.A.) (the “Custodian”), the custodian of the Plan’s investment assets. Under the arrangement with the Custodian and upon enrollment in the Plan, a participant may direct employee contributions in any percentage increments into any of the available funds offered by the Custodian.

Participant accounts

Each participant’s account is credited with (a) the participant’s contributions, (b) the Sponsor’s contributions on behalf of the participant and (c) the earnings and losses of the participant’s investments and is charged with any expenses incurred as a result of transactions initiated by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately fully vested in all salary deferral contributions to the Plan plus earnings thereon. Sponsor discretionary matching contributions are subject to a vesting schedule, whereby participants are vested 20% per year and are fully vested after five years of service. QACA safe harbor matching contributions are subject to a vesting schedule, whereby participants are vested 50% per year and are fully vested after two years of service.

Forfeitures

Forfeited balances of terminated participants’ non-vested accounts are used to pay administrative expenses or future Sponsor contributions. During the year ended December 31, 2024, \$70,394 was forfeited from participant accounts and \$24,745 of additional amounts were added to the forfeitures account. Amounts used to pay administrative expenses and to reduce Sponsor matching contributions for the year were \$-0- and \$62,024, respectively. At December 31, 2024 and 2023, the unallocated forfeiture balance was \$56,546 and \$23,431, respectively.

#### Administrative expenses

Administrative fees associated with each participant loan and benefit payment are paid by the Plan and charged to the individual participant's account.

#### Payment of benefits

Upon termination of employment, attainment of normal retirement age or for reasons of death or disability, participants may withdraw the balance of their account in the form of a lump sum. Participants still employed with the Sponsor may withdraw all or a portion of their account balance upon attainment of age 59½ or for reasons of a financial hardship, as allowed under the IRC. A participant whose vested account balance does not exceed \$1,000 will receive a lump sum distribution of their vested account balance as soon as administratively feasible following termination. A participant whose vested account balance exceeds \$1,000 but does not exceed \$5,000 will have their vested account balance rolled over into an individual retirement account outside the plan as soon as administratively feasible following termination of employment.

#### Notes receivable from participants

The Plan allows participant loans only for hardship reasons as defined by the IRC. If eligible, participants may borrow, from their accounts, amounts ranging from \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balances. The maximum term of repayment for a loan is 5 years, unless the loan is for the purchase of the participant's principal residence, in which case the term may be extended up to 20 years. A participant may have no more than one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of the prime rate plus two percentage points. Principal and interest are paid ratably through payroll deductions. Interest rates range from 5.25% to 10.50% on loans outstanding at both December 31, 2024 and 2023.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Payment of benefits

Benefits are recorded when paid.

#### Use of estimates in financial statement preparation

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Interest is recorded when earned. Net appreciation/depreciation of fair value of investments includes dividends and realized and unrealized gains and losses on those investments.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are recorded as distributions based upon the Plan's provisions.

#### Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation/depreciation of fair value of investments.

## 3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (the "DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the

Custodian, except for comparing such information to the related information included in the Plan’s financial statements and supplemental schedules.

The following information included in the accompanying financial statements and supplemental schedules was prepared and certified to as complete and accurate by the Custodian as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

#### 4. FAIR VALUE MEASUREMENTS

Following is a description of the valuation methodology used for assets measured at fair value. There was no change in the methodology used during the year ended December 31, 2024.

- Pooled separate accounts: Valued at the unit value of shares held by the Plan at year-end, as determined by the Custodian based on the net asset value (“NAV”) of the underlying mutual funds. The NAV, as reported by the Custodian, is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.
- Collective trust: Valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Sponsor believes its valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Under Accounting Standards Update No. 2015-7, since the pooled separate account’s and collective trust’s fair value is measured using NAV as a practical expedient, there is no requirement to categorize and disclose the investments fair value hierarchy.

#### 5. RELATED PARTY TRANSACTIONS

The Sponsor pays certain costs on behalf of the Plan for insurance, administration and professional services. Recordkeeping and administrative services are also provided by the Sponsor at no cost to the Plan.

The Plan offers, as investment options, certain funds managed by the Custodian. Accordingly, transactions in these investments qualify as party-in-interest transactions.

#### 6. INCOME TAX STATUS

The Plan utilizes a volume submitter plan document sponsored by Benetech Administrators, Inc., who was informed by the Internal Revenue Service (“IRS”) by a letter dated June 30, 2020, that the plan, as amended, is designed and being operated in accordance with applicable sections of the IRC. Though the Plan has not received a determination from the IRS, the Sponsor and the Plan’s tax counsel believe that the Plan is designed and being operated in accordance with the applicable sections of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress and the plan administration believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

#### 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

#### 8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### 9. SUBSEQUENT EVENTS

The Sponsor has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued.
