**NOTE 1 – DESCRIPTION OF PLAN**

Pinto Valley Mining Corp. (the Company) established the Pinto Valley Mining Corp. Retirement Savings Plan for Union Represented Employees (the Plan) as a qualified retirement plan effective January 1, 2013, to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was amended and restated effective October 10, 2023. The provisions of the Plan have also been adopted by San Manuel AZ Railroad Co. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following description of the Plan provides only general information. Participants should refer to the legal plan document for a more complete description of the Plan's provisions.

Plan Transfers: During 2024, plan assets totaling \$1,373,751 were transferred from the Plan to the Pinto Valley Mining Corp. Retirement Savings Plan for Salaried Employees. Plan assets totaling \$2,893 were transferred from the Pinto Valley Mining Corp. Retirement Savings Plan for Salaried Employees into the Plan.

Eligibility: The Plan covers all employees of the Company or any affiliate who has adopted the Plan, except non-union employees. Eligible employees of the Company can join the Plan as an active participant in the Plan on their date of hire.

Contributions: Participants may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as a salary deferral. There are two types of salary deferrals: pre-tax 401(k) deferrals and Roth 401(k) deferrals. Total deferrals in any taxable year may not exceed a dollar limit which is set by law. Participants at least age 50 or will attain age 50 before the end of a calendar year may elect to defer additional amounts to the Plan as catch-up contributions. Participants may revoke, or make any other modifications to, their salary deferral election at any time during the Plan year.

The Company will provide a matching contribution of 100% of the first 3% of eligible compensation that an employee contributes.

Participants are also permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs as rollover contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company contributions (b) Plan earnings or losses, and (c) forfeitures of discretionary matching and profit-sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are 100% vested in their contributions, rollover contributions, and Plan earnings thereon. Vesting for employer contributions is based on periods of vesting service according to a graded vesting scale, with participants becoming 100% vested after three years of service.

Payment of Benefits: Participants may receive a distribution of the vested portion of some or all of their account in the Plan upon termination of employment, normal retirement, or disability. A beneficiary will become entitled to receive a participant's vested account balance in case of death. If the vested account balance does not exceed \$5,000, then the vested account balance may only be distributed as a single lump-sum payment. If the vested account balance exceeds \$5,000, the participant must consent to any distribution before it is made. Vested account balances exceeding \$5,000 may be paid as a single lump-sum payment, installments, or partial withdrawals. Benefits under the Plan will be paid to participants in cash only.

Participants who have attained age 59½ may receive a distribution from the Plan from certain accounts prior to their termination of employment as an in-service distribution. Participants may also withdraw money for financial hardship. A hardship distribution may be made to satisfy certain immediate and heavy financial needs that a participant might have.

Notes Receivable from Participants: Loans are available to participants on a reasonably equivalent basis. The amount of the loan will be limited to the lesser of \$50,000 reduced by the excess of the highest outstanding balance of loans during the prior one-year period or ½ the participant's vested interest in the Plan. No loan in an amount less than \$1,000 will be made. All loans are adequately secured by the balance in the participant's account and charged a reasonable rate of interest. Generally, the term of the loan may not exceed five years unless the loan is for the purchase of a principal residence.

Forfeitures: Forfeitures may be used to pay Plan expenses or to offset employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$127,533 and \$87,434, respectively. In 2024, \$42,975 of forfeitures were used to reduce employer contributions.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participant accounts will continue to be 100% vested. The Company will direct the distribution of participant accounts in a manner permitted by the Plan as soon as practicable.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through July 29, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments, other than the fully benefit responsive investment contract, are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefits Paid to Participants: Benefits are recorded when paid.

Risks and Uncertainties: The Plan invests in various types of investment securities, including mutual funds and a fully benefit-responsive investment contract. These investments are subject to a range of risks, including interest rate risk, credit risk, market volatility, and geopolitical and economic uncertainty. Such risks could materially affect participants' account balances, and the amounts reported in the financial statements.

The fair values of individual securities or asset classes may fluctuate significantly due to changes in market conditions. Additionally, the fully benefit-responsive investment contract is subject to credit risk related to the issuer's financial capacity. It is at least reasonably possible that changes in the values of investment securities could occur in the near term and materially impact the amounts reported in the statements of net assets available for benefits.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company, LLC and John Hancock Life Insurance Company.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

**Mutual Funds:** The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges. These investments are classified as Level 1 and are valued using the market approach.

**NOTE 5 – GROUP ANNUITY CONTRACT**

The Plan holds a fully benefit-responsive group annuity contract with John Hancock Life Insurance Company (U.S.A.) (John Hancock). This contract is reported at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The contract is credited with interest at a rate set by John Hancock, which is reviewed and may be reset semi-annually on January 1 and July 1. Under the terms of the contract, the interest crediting rate is guaranteed not to be less than 1%. John Hancock is contractually obligated to repay principal and credited interest to the Plan. The Plan's ability to receive amounts due is dependent on John Hancock's ability to meet its financial obligations.

Participant-initiated withdrawals are paid at contract value. However, withdrawals triggered by Plan sponsor actions—such as plan termination, mergers, spin-offs, layoffs, early retirement incentive programs, sales or closings of all or part of the Plan sponsor's operations, bankruptcy, or receivership—may be subject to market value adjustments or paid in five equal annual installments if the total amount of such withdrawals over the preceding twelve-month period exceeds 5% of the Plan's balance in the contract as of the start of such period.

The contract includes provisions that restrict direct transfers from the stable value fund to competing investment options. Transfers to such options are subject to an equity wash, requiring assets to be directed to a non-competing investment option for a designated period before being eligible to invest in a competing fund. Fees for plan recordkeeping or other services may be deducted from the assets of the stable value fund at the direction of the Plan sponsor.

The contract includes an optional market value recovery feature. If the Plan experiences a market value adjustment loss on a prior investment, John Hancock may add a corresponding recovery amount to the initial deposit into the contract. In such cases, an additional fee is charged until the recovery amount is recouped. As of the financial statement date, no events are currently probable of occurring that might limit the ability of the Plan to transact at contract value with John Hancock or with participants.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain other. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds an unallocated investment contract with John Hancock. John Hancock and affiliates are service providers to the Plan and, therefore, these transactions and the Plan's payment of fees to the service providers qualify as party-in-interests. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 7 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
