## REPORT OF INDEPENDENT AUDITORS

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Skyline Security Management 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

## 1. DESCRIPTION OF THE PLAN

The following description of Skyline Security Management 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution savings plan sponsored by Skyline Security Management, Inc. (“Plan Sponsor” or “Plan Administrator”), and effective January 1, 2023, Skyline Solar, LLC, a related entity to the Plan Sponsor, became a participating employer in the Plan (collectively “Employers”). The Plan was established in 2013 and is subject to the provisions of the Department of Labor's (“DOL”) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (“ERISA”), and subsequent laws.

### Plan administration

The Plan Sponsor has contracted with Empower Trust Company, LLC (“Empower”) to act as the trustee and with an affiliate of Empower to provide recordkeeping services to the Plan.

### Eligibility

The Plan covers substantially all employees of the Employers, except union employees covered by a collective bargaining agreement, leased employees, residents of Puerto Rico, and certain nonresident aliens, who have attained age 21 and completed 90 days of credited service, as defined in the plan document.

### Contributions

Each year, participants may contribute up to 100% of their eligible pre-tax or after-tax (as Roth contributions) compensation, as defined by the plan document, up to the maximum annual amount allowed by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Effective October 1, 2024, the Plan was restated to remove the provision for safe harbor matching contributions. Prior to that, the Employers made safe harbor matching contributions to the Plan equal to 100% of each eligible participant’s elective deferrals, up to 5% of the participant’s deferred compensation, as defined in the plan document. For the year ended December 31, 2024, the Employers made safe harbor matching contributions to the Plan of approximately \$132,000. The Employers may also make profit-sharing contributions to the Plan on a discretionary basis for participants who have attained 12 months of service with the Employers and are employed on the last of the day of the plan year for which the profit-sharing contributions are made. The Employers did not make any profit-sharing contributions to the Plan for the year ended December 31, 2024. Participants may also make rollover contributions to the Plan from other qualified defined benefit or defined contribution plans.

Participants direct the investment of contributions to their respective accounts into the investment options offered by the Plan.

### Participant accounts

Each participant's account is credited with the participant's contributions, any Employers’ contributions, and allocations of plan earnings. Accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting

Participants are immediately 100% vested in their elective contributions and the Employers' safe-harbor matching contributions, plus earnings thereon. Participants begin to ratably vest in the Employers' profit-sharing contributions after two years of credited service and are fully vested after six years of credited service, as defined by the plan document. Participants become fully vested in their account balances in the event of retirement, disability or death.

Participants who transferred to the Plan from the Skyline Smart Energy 401(k) Plan, sponsored by Skyline Solar, LLC, are 100% vested at all times in their nonelective profit-sharing contributions.

Notes receivable from participants

Participants may borrow from their account a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants ("participant loans") are issued by the Plan and secured by the balance in the participant's account. Participant loans must be repaid within five years. Participant loans, issued after January 1, 2023, bear a rate of interest equal to the prime rate. Prior to that, the interest rate was equal to the prime rate plus 1%. Principal and interest are generally paid ratably through payroll deductions with payments made each pay period. Outstanding participant loans at December 31, 2024 bear annual interest rates that range from 4.25% to 8.50% and mature with various dates through June 2030.

Payment of benefits

Distributions and withdrawals are payable upon retirement, termination, disability, or death. The Plan permits in-service and hardship withdrawals under certain conditions, as described in the plan document. Upon termination, participants with total vested account balances of up to \$1,000 may automatically receive a lump sum cash distribution from the Plan. Unless affirmatively elected otherwise by the participant, if a participant's vested account balance is greater than \$1,000 and up to \$7,000 upon termination, the balance may be automatically rolled over into an individual retirement account, preselected by the Plan Sponsor.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting and financial statement presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the change therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions are separated from a participant's pay by the Employers, which is the pay date. Contributions from the Employers are recorded in the year earned to coincide with the year the Employers record the contributions in their financial statements. Rollover contributions from participants are recorded based on the date the contributions are received by the Plan.

Payment of benefits

Benefits are recorded when paid.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Empower, the trustee, certifies the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis; settlement-date basis may also be used. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Participant loans are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on participant loans is recorded on an accrual basis. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative expenses

The plan document allows administrative expenses to be paid by the Plan, unless paid by the Employers. The majority of the recordkeeping and administration fees are paid by the Plan. The Plan participates in an expense offset agreement whereby certain third-party expenses are paid with rebates received by the Plan from investment managers. During the year ended December 31, 2024, the Plan received investment manager rebates of approximately \$6,700, which were offset against investment advisor fees. The net rebates are included in other income in the Statement of Changes in Net Assets Available for Benefits.

Investment fees, which may vary according to the individual investment options selected, are also paid out of the assets of the Plan. Certain other administrative expenses of the Plan were paid directly by the Employers for the year ended December 31, 2024 and they are excluded from these financial statements. The Plan is not expected to reimburse the Employers for these other expenses.

Subsequent events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information was certified as complete and accurate by Empower, the trustee, and was not subjected to any auditing procedures performed by the independent auditors:

- Investments and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants reflected on the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investments and notes receivable from participants reflected on the Schedule of Assets (Held at End of Year).

#### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.
- Level 2 - inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value fund:* The Putnam Stable Value Fund (“SV”) invests in fully benefit responsive guaranteed investment contracts, security backed investment contracts, and a money market fund, which are unitized. Units are valued using the NAV practical expedient of the SV as reported by the fund trustee. The NAV practical expedient is based on the fair value of the underlying assets owned by the SV, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of the SV is determined daily and units are issued and can be redeemed daily at the latest NAV practical expedient. There are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

## 6. PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined by ERISA as any fiduciary of the Plan, any party rendering services to the Plan, the Employers and their employees, and certain others. Transactions conducted by Empower and its affiliates, including fee offset agreements, qualify as party-in-interest transactions. Also, the Employers pay certain fees and expenses on behalf of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

## 7. TAX STATUS

The Plan has adopted a non-standardized pre-approved profit-sharing defined contribution plan document that has received a favorable opinion letter from the Internal Revenue Service dated November 14, 2022, which stated that the plan document, as then designed, was in accordance with the applicable sections of the IRC. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants would become fully vested in their account balances in the event the Plan is terminated.
