Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sky Bird Travel & Tours, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Sky Bird Travel & Tours, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Emphasis of Matter

As discussed in Note A to the financial statements, effective July 1, 2024, the Plan changed its trustee and recordkeeper from John Hancock ADP Retirement Trust Services. Our opinion is not modified with respect to this matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Sky Bird Travel & Tours, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Sky Bird Travel & Tours, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgement and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Auditor's Responsibilities for the Audit of the Financial Statements (continued)

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Sky Bird Travel & Tours, Inc. 401(k) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgement, there are conditions or events, considered in the aggregate, that raise substantial doubt about Sky Bird Travel & Tours, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain other procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Other Matter – Supplemental Schedule Required by ERISA (continued)

A. Description of Plan

The following description of the Sky Bird Travel & Tours, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General: The Plan is a defined contribution plan that became effective on December 31, 1983 covering all employees of Sky Bird Travel & Tours, Inc. ("the Company") who meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator is responsible for oversight of the Plan. The investment committee determines the appropriateness of the plan's investment offerings, monitors investment performance and reports to the plan administrator.

Effective July 1, 2024, the Plan was amended for a change in the third-party administrator, and the eligibility requirement was reduced from one year of service to three months. The amendment also limited the maximum contribution to 90% of compensation and added an automatic increase feature to before-tax contributions of 1%, 2%, or 3%. On the same date, the Plan's trustee/custodian was changed from John Hancock to ADP Retirement Services. All Plan assets and records were transferred to the new provider in accordance with Plan provisions. This change does not affect the rights of participants under the Plan.

Eligibility: An eligible employee may participate in the Plan upon attaining age 21 and completion of three months of employment (3 months of service), effective July 1, 2024. Prior to this date, eligibility was based on attainment of age 21 and completion of one full year of employment (12 months of service with at least 1,000 hours of service). Employees may enroll on the first day of the Plan Year or the first day of the seventh month of the Plan Year coinciding with or next following the date eligibility requirements are met. Employees who are union employees, certain nonresident aliens, leased employees, or residents of Puerto Rico are not eligible to participate in the Plan.

Contributions: Prior to July 1, 2024, participants could elect to contribute up to 100% of their annual compensation, as defined by the Plan, as pre-tax and/or Roth contributions, subject to the annual limitations imposed by the Internal Revenue Service ("IRS"). Effective July 1, 2024, the Plan was amended to limit participant deferral elections to 90% of annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). In addition, participants may make a Roth contribution, including an In-Plan Roth Transfer (provided they are an employee at the time of transfer), whereby they may elect to change the tax treatment of all or a portion of their pre-tax accounts, provided the account is 100% vested. Participants direct the investment of their contributions into various investment options offered by the Plan.

A. Description of Plan (continued)

The Company may provide a discretionary match. The Company also provides for a profit sharing match as determined by management each year. During the year ended December 31, 2024, the Company did not make a discretionary match or profit sharing match contribution to the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution and Company profit sharing contribution, as well as allocations of the Company's plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service. Effective July 1, 2024, the Company's matching contributions are vested after six years of service, and employer profit-sharing contributions are immediately vested.

Notes Receivable from Participants: Participants may borrow from their vested account balances. Loans may not exceed the lesser of \$50,000 minus the highest outstanding loan balance during the past year or 50% of the participant's account balance, less any outstanding loans, and may not be less than \$1,000. Loans are secured by the participant's account balance and bear interest at 2% over the prime rate through June 30, 2024, and 1% over the prime rate effective July 1, 2024, as determined quarterly by the plan administrator. Principal and interest are repaid ratably through payroll deductions over a period not to exceed five years, except for loans used to purchase a principal residence, which may be repaid over a period not to exceed ten years. Participants may have only one loan at a time.

The Plan allows for involuntary cash-out distributions. Prior to July 1, 2024, a participant who terminated employment with a vested account balance of \$5,000 or less would receive an involuntary cash-out distribution. Effective July 1, 2024, a participant who terminates employment with a vested account balance of \$7,000 or less will receive an involuntary cash-out distribution.

A. Description of Plan (continued)

Payment of Benefits: Upon termination of service as a result of death, disability, or separation from employment, a participant is entitled to receive a distribution equal to the value of his or her vested account balance. Prior to July 1, 2024, if the vested account balance exceeded \$5,000, the participant could elect to receive payment in any form permitted under the Plan; if the balance did not exceed \$5,000, the participant would receive a lump sum distribution. Effective July 1, 2024, the threshold increased to \$7,000. Participants with vested account balances exceeding \$7,000 may elect to receive payment in any form permitted under the Plan, while participants with vested account balances that do not exceed \$7,000 will receive a lump sum distribution.

The Plan allows in-service distributions and required minimum distributions. A participant may withdraw all or any portion of the participant's vested account balance upon attainment of age 59 1/2 for elective deferrals, employer profit sharing or discretionary match. A hardship that satisfies the safe harbor rules is also allowed for participant deferrals.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$62,787 and \$7,455, respectively. These accounts may be used to reduce future employer contributions or pay administrative expenses. In 2024 and 2023, forfeiture accounts were not used to pay administrative expenses. Also, in 2024, employer contributions were not reduced using forfeited nonvested accounts.

B. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

B. Summary of Accounting Policies (continued)

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. No amounts were distributed to participants for the plan year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, as provided by the plan document. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

C: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. The Plan invests in mutual funds, common collective trusts, and formerly held pooled separate accounts (redeemed as of June 30, 2024).

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchases and sales) may occur daily.

C: Fair Value Measurements (continued)

Pooled separate accounts prior to transfer on July 1, 2024: The pooled separate accounts' fair values were based on the fair values of the underlying assets to determine the Net Asset Value ("NAV") of the pooled separate accounts. The underlying assets had publicly quoted pricing inputs which were reported to John Hancock Life Insurance Company ("John Hancock"). John Hancock reported the daily published NAV to fund holders and the funds transact at that price. This practical expedient was not used when it is determined to be probable that the fund would sell the investment for an amount different than the reported NAV. The redemption frequency of each of the pooled separate accounts was daily, and there were no redemption restrictions. There were no unfunded commitments related to the plans' investment in pooled separate accounts.

Investments Measured Using NAV Practical Expedient:

[a] Certain investments that are measured at fair value using NAV per share (or its equivalent practical expedient), have not been classified in the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits. The portfolio's investment objective is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. The portfolio invests in assets (typically fixed-income securities or bond funds and mutual funds), and invests in cash equivalents represented by shares in money market funds. There are no unfunded commitments at December 31, 2024 or 2023. The fund has a daily redemption frequency and redemption notice period.

Change in Investment Types:

Effective July 1, 2024, the plan's assets were transferred from pooled separate accounts held under a group annuity contract with an insurance company to investments in mutual funds and common/collective trusts. Pooled separate accounts were previously valued using the NAV of units held, as reported by the insurance company, which represented the fair value of the underlying investments. Following the transfer, all pooled separate accounts were liquidated and replaced by investments in mutual funds and common/collective trust funds, which are valued as described above.

The plan sponsor, Sky Bird Travel & Tours, Inc. is also the plan administrator. During 2024, all of the members of the board of trustees were also plan participants.

Certain plan investments were managed by John Hancock through June 30, 2024. John Hancock served as the trustee and recordkeeper for the Plan during that period, and therefore, these transactions qualified as party-in-interest transactions. Fees paid by the Plan for investment management services for the year ended December 31, 2024, amounted to \$50,186.

Effective July 1, 2024, a new third-party administrator, ADP Retirement Trust Services (ADPRS) assumed recordkeeping and administrative responsibilities for the Plan. Fees paid to ADPRS for services rendered after July 1, 2024 amounted to \$12,493.

H: Tax Status

The IRS has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not, would not be sustained upon examination by the IRS or Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.
