INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Lexington Coal Company, LLC 401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. Basis of Accounting

Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1 – DESCRIPTION OF PLAN

The following description of Lexington Coal Company, LLC (the “Company”) 401k Plan (the “Plan”) provides only general information. Effective July 1, 2022, the plan document was restated to comply with recent regulatory changes. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a safe harbor defined contribution Plan covering all employees of Lexington Coal Company, LLC, Republic Superior Products, LLC, Construction & Reclamation Services, LLC, Prep Plant Solutions, LLC, and Grand Patrician Resort, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was originally established January 1, 2003.

Contributions

Participants may elect to defer an amount not in excess of 90% of their pre-tax compensation up to the maximum allowable dollar limit provided by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company matches one hundred percent (100%) of the first three percent (3%) of compensation that a participant contributes to the Plan. Additionally, the Company matches fifty percent (50%) of the next two percent (2%) of compensation that a participant contributes to the Plan.

Participant Accounts

In addition to a participant’s contribution and employer match, each participant’s account is credited with an allocation of Plan earnings and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and safe harbor matching contributions plus actual earnings thereupon.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account as soon as administratively feasible, if the account balance does not exceed \$5,000. For account balances exceeding \$5,000, the participant must consent to the distribution and may elect to receive a lump-sum distribution. The Plan does allow for hardship withdrawals upon management approval.

Forfeited Accounts

Forfeited nonvested accounts can be used to reduce Company contributions or pay reasonable plan expenses. During 2024, \$0 was used to reduce Company contributions. As of December 31, 2024 and 2023, no forfeited nonvested accounts existed.

2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounting records of the Plan are maintained on the modified cash basis of accounting, a basis of accounting permitted by the Department of Labor. This method includes recording of Plan assets at fair market value but excludes the recording of receivables for participant and employer contributions, interest and dividends receivable on investments, interest on notes receivable from participants, and accrued expenses. The effect of these items has not been determined. This basis differs in some respects from accounting principles generally accepted in the United States of America which require that the financial statements be prepared on an accrual basis. Accordingly, the accompanying financial statements are not intended to present the financial position and changes in net assets available for benefits in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis and dividends and interest are recognized when received. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses, including trustee, legal, auditing, and other fees, are paid by the Company, and, as such, are not expenses of the Plan. The amount reported as administrative expenses of the Plan are transactional fees charged to participant accounts.

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following description of the valuation methodologies used for assets measured at fair value basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: These investments are public investment vehicles valued using the Net Asset Value ("NAV") provided by the administrator of the fund. The NAV is quoted price in an active market and classified within Level 1 of the valuation hierarchy.

Common collective trust: These investments are valued at the net assets value of units of a bank collective trust. The net asset value, as provided by the Trustee, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7 – TAX STATUS

On October 6, 2020, the IRS stated the prototype adopted by the Plan, as then designed, qualifies under the Internal Revenue Code (IRC) Section 401. However, the plan administrator is aware of certain plan operational failures which could jeopardize the Plan's tax-qualified status and intends to fully correct those failures according to applicable provisions of the Internal Revenue Code. Accordingly, the plan administrator believes the Plan will retain its tax-qualified status. Therefore, no provision for income taxes has been included in the Plan's financial statements.

All required federal returns for the Plan have been filed up to and including the tax year ended December 31, 2024.

8 – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets.

9 – SUBSEQUENT EVENTS

Management evaluated events for the Plan through the date of the auditor's report, the date the financial statements were available to be issued.
