## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Harbor Beach Community Hospital Pension and Tax Deferred Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Harbor Beach Community Hospital Pension and Tax Deferred Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. - the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

**NOTE 1 - DESCRIPTION OF PLAN:**

The following description of the Harbor Beach Community Hospital Pension and Tax Deferred Savings Plan ("Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan pursuant to Section 403(b) of the Internal Revenue Code covering substantially all employees of the Hospital. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility** – Any employee of the Hospital (employer) is eligible to voluntarily participate in the Plan upon the date of hire. Employees are eligible to receive discretionary employer and matching contributions after completion of 1,000 hours and twelve consecutive months of service.

**Contributions** – The employer may elect the amount of discretionary employer contributions to be contributed to the Plan. The discretionary contribution for 2024 and 2023 was 2% of an employee's eligible wages. For the years ended December 31, 2024 and 2023, the Hospital made discretionary contributions of \$145,470 and \$126,557, respectively.

Participants may contribute up to the lesser of 100% of their annual wages or \$23,000. Contributions are subject to certain limitations. The Hospital may make discretionary matching contributions based on a percentage of the employees' deferred contribution. For 2024 and 2023, the matching contribution will not exceed 50% of the participants' deferral up to a maximum of 1% of wages. For the years ended December 31, 2024 and 2023, the Hospital made matching contributions of \$49,356 and \$41,398, respectively.

Forfeitures of participant account balances may be applied to reduce the current period employer contribution.

**Participant Accounts** - Each participant's account is credited with the participant's contribution; the Hospital's matching contribution and an allocation of (a) the Hospital's discretionary contribution, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. Participants make elections to invest their account balances in selected funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. The participants are vested over a three year period in the Discretionary Employer Contributions Account and the Matching Contributions Account based on the following schedule:

**Forfeited Accounts** - For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5,958 and \$2,062, respectively. These accounts will be used to reduce future Company contributions or to pay administrative expenses of the plan. In 2024 and 2023, \$2,368 and \$1,875 were used to pay plan fees, respectively. In 2024, no forfeitures were used to fund employer contributions. In 2023, \$8,692 was used to fund employer contributions.

**Hardship Withdrawals** – Participants may request that all or a portion of the account be distributed in the case of severe financial hardship, as defined in the plan document. The Hospital must approve any such hardship withdrawals.

**NOTE 1 - DESCRIPTION OF PLAN: (CONTINUED)**

**Payment of Benefits** – Other than withdrawals because of hardship, no plan benefits can be disbursed to the participant or to the participant's beneficiaries earlier than the participant's normal retirement age (age 65), death, disability, termination or employment, or attainment of age 55 with three years of service. Upon termination, if the value of the participants vested benefit does not exceed \$1,000, then the distribution will be made in a lump-sum payment regardless of whether the participant elects to receive it.

**Notes Receivable from Participants** – A participant may obtain a loan collateralized by their account balance, up to certain limits, as defined in the Plan. Loan transactions are treated as a transfer to (from) the Investment Fund from (to) the Participant Loan Fund. Interest will be charged at a reasonable rate comparable to similar types of loans by other lenders. Loans require payments not less frequently than quarterly over a period of not greater than five years (may be longer if the proceeds are used in connection with the purchase of a principal residence of the participant). Principal and interest are paid ratably through monthly payroll deductions or ACH.

**Investment Options** – Upon enrollment in the Plan, participants may direct their contributions and the Company's matching contribution, in whole or in part, to a range of investment options. Participants may change their investment options daily.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

**Basis of Accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Investment Valuation and Income Recognition** – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable – Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participants account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

**Payment of Benefits** – Benefits are recorded when paid.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES: (CONTINUED)**

**Operating Expenses** – Certain expenses of maintaining the Plan are paid by the Hospital and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

**Estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“U.S GAAP”) requires the plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Date of Management's Review** – Subsequent events were evaluated through September 18, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 – FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE:**

**NOTE 4 - FAIR VALUE MEASUREMENTS:**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The Plan Administrative Committee determines the Plan's valuation policies. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

**NOTE 4 - FAIR VALUE MEASUREMENTS: (CONTINUED)**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

**Level 1 Fair Value Measurements**

The fair values of the mutual funds are based on the closing price reported in the active market where the individual funds are traded, when available.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

**NOTE 5 - RELATED PARTY TRANSACTIONS:**

Certain administrative expenses of the Plan were paid by the participating employer and are not charged to the Plan. Fees paid during the year for administrative services rendered by parties-in-interest are, in the opinion of the Trustees, based on customary and reasonable rates for such services.

Certain Plan investments are shares of mutual funds managed by Alerus or its affiliates. Alerus is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than direct payment.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 6 - PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Hospital may determine.

**NOTE 7 - TAX STATUS:**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Services (IRS) in Revenue Procedures 2007-71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for the plan participants under Section 403(b). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

**NOTE 8 - RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500:**

For the years ended December 31, 2024 and 2023, there are no differences in the net assets available for benefits or the changes in net assets available for benefits between the Plan's financial statements and the amounts reported on the Form 5500.

We have audited the financial statements of the Harbor Beach Community Hospital Pension and Tax Deferred Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) for the year ended December 31, 2024, and have issued our report thereon dated September 18, 2025. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated April 22, 2025. Professional standards also require that we communicate to you the following information related to our audit.

#### Significant Audit Matters

##### *Qualitative Aspects of Accounting Practices*

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Harbor Beach Community Hospital Pension and Tax Deferred Savings Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Management's estimate of the fair value of the Plan's investments is based on quoted market prices available at the date of the financial statements. We evaluated the key factors and assumptions used to develop the fair value of the Plan's investments in determining that it is reasonable in relation to the financial statements taken as a whole.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements was:

The disclosure of the fair value measurements of the Plan's investments in Note 4 to the financial statements provides an explanation of the methods used by management in determining the fair values of the Plan's investments.

The financial statement disclosures are neutral, consistent, and clear.

##### *Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

### *Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in dealing with management in performing and completing our audit.

### *Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole.

### *Reportable Findings*

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgement is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified no reportable findings.

### *Disagreements with Management*

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

### *Management Representations*

We have requested certain representations from management that are included in the management representation letter dated September 18, 2025.

### *Management Consultations with Other Independent Accountants*

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

### *Other Audit Findings or Issues*

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

### *Other Matters*

With respect to the ERISA-required supplementary information accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the supplementary information to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

This information is intended solely for the use of the Plan Committee and management of the Harbor Beach Community Hospital Pension and Tax Deferred Savings Plan and is not intended to be, and should not be, used by anyone other than these specified parties.
