To the Plan Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hall Hospitality Group LLC 401K Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Hall Hospitality Group LLC 401K Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Hall Hospitality Group LLC 401K Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. DESCRIPTION OF PLAN

The following description of the Hall Hospitality Group, LLC (the “Company”) 401K Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General The Plan is a defined contribution plan covering all employees of the Company who have completed six months of service, and have attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) as amended. The Plan Sponsor’s management is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. All Plan assets are held in a trust fund.

Contributions Each year, participants may contribute up to 86 percent but not less than 1% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Eligible employees may elect to defer eligible compensation on a pre-tax, an after-tax (Roth) basis, or a combination of both up to a designated percentage, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan is referred to as a safe harbor plan. A “safe harbor” plan is a plan design where the Employer commits to making certain contributions. This commitment to make contributions enables the Employer to simplify the administration of the Plan by ensuring that nondiscrimination regulations are met, which is why it is called a "safe harbor" plan. In order to maintain "safe harbor" status, the Employer will make a safe harbor matching contribution equal to 100% of an eligible participant’s salary deferrals that do not exceed 4% of compensation. The Plan, by law, cannot recognize annual compensation in excess of a certain dollar limit, \$345,000 for 2024. For purposes of calculating the safe harbor matching contribution, participant compensation and deferrals will be computed for each payroll period.

The Company may decide to make a non-elective contribution to the plan, although the Company is not required to do so. The non-elective contributions, if made, will be allocated as of the end of each plan year based upon eligible earnings within the computation period. There were no non-elective contributions made for 2024 or 2023.

Participant Accounts Each participant's account is credited with the participant's contributions and Company matching contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures Non-vested participant account balances of terminated participants are forfeited in the year their account balance is distributed. Forfeited balances of terminated participants’ nonvested accounts may be used to reduce future employer contributions. For the years ended December 31, 2024 and 2023, employer contributions were offset by \$432 and \$10,465, respectively, by forfeited nonvested accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,646 and \$2,655, respectively.

1. DESCRIPTION OF PLAN – (CONTINUED)

Vesting Participants are immediately vested in their voluntary contributions and safe harbor matching contributions plus actual earnings thereon. For non-elective contributions made by the Company, participants vest based on years of continuous service. A participant is 100 percent vested after six years of credited service. The vesting schedule in effect for the years ending 2024 and 2023 is as follows:

Vesting Schedule:

Less than 2 Years of Service	0% Vested
At least 2 years, but less than 3	20% Vested
At least 3 years, but less than 4	40% Vested
At least 4 years, but less than 5	60% Vested
At least 5 years, but less than 6	80% Vested
6 or more Years of Service	100% Vested

Payment of Benefits Upon termination of service, death, disability or retirement, participants may elect to receive either a direct rollover to an individual retirement account, lump-sum payment, or partial withdrawals or installments but only with respect to minimum required distribution, over a period of time not more than your assumed life expectancy, if the value of the account is \$5,000 or more. If the value of their account is less than \$5,000 the participant's vested interest will be paid to them as a lump sum when requested and as soon as administratively possible.

Notes receivable from Participants Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to 50% of their account balance, and a maximum amount of \$50,000. Loan terms range from one to five years or up to 30 years if the loan is for the purchase of the participant's principal residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus two. Loan repayments are made through payroll deductions. A new loan may not be taken out until any previous loan has been paid off.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits Benefits are recorded when paid.

Use of Estimates The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Expenses Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. PLAN TERMINATION

Although they have not expressed any intention to do so, the Company have the right under the Plan to discontinue their contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

4. TAX STATUS

The Internal Revenue Service has determined and informed the Plan by letter, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been restated since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing agency. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. RELATED PARTY TRANSACTIONS

ADP Retirement Services and Reliance Trust Company provide certain administrative services to the Plan pursuant to a Master Services Agreements whereby certain administrative expenses are charged to the individual funds and netted against the investment's earnings.

Certain expenses of maintaining the Plan, as well as, fees related to the audit, are paid directly the by the Company and are excluded from these financial statements. Fees related to the administration of distributions to participants are charged directly to the participant's account and are presented on the financial statements. Investment related expenses are included in net appreciation of fair value of investments.

6. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The of the fair value hierarchy under Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets
- b. Quoted prices for identical or similar assets or liabilities in inactive markets
- c. Inputs other than quoted prices that are observable for the asset or liability
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts - Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.
