To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Alternative Paths Training School 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section—

- The amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Their report dated October 6, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). NOTES TO FINANCIAL STATEMENTS

NOTE 1 - Description of Plan

The following description of the Alternative Paths Training School (the Plan) 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document and Adoption Agreement for a more complete description of the Plan's provisions.

General

The Plan, established March 1, 2014, is a defined contribution plan intended to qualify under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Act of 1974 (ERISA). The Plan generally covers all employees of the Company who are a minimum of 18 years of age and complete 12 consecutive months of eligibility service. Eligible employees may enter the Plan at the beginning of the month upon meeting eligibility.

Individuals of the Plan Sponsor serve as the Plan's trustees and are responsible for the oversight of Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance. The custodian of the Plan is John Hancock Trust Company LLC.

Contributions

Participants may make salary reduction contributions, including Roth 401(k) contributions, up to 100% of their compensation each pay period subject to the limitations of the Internal Revenue Code ("IRC").

Qualified distributions from other qualified retirement plans can also be contributed to the Plan and retained as rollover contributions. Participants are immediately vested in their salary reduction and rollover contributions plus actual earnings thereon.

The Plan Sponsor may make profit-sharing contributions to the Plan at its sole discretion. For the year ended December 31, 2024, no such profit-sharing contributions were made by the Company. The Company has the option to make additional contributions to the Plan that are at its sole discretion. The Company contributes a matching contribution equal to 50% of each participant's contributions up to the first 4% and up to the first 6% for participants with at least 5 years of eligible service. For the year ended December 31, 2024, \$136,410 of matching contributions were made by the Plan Sponsor and \$70,995 of forfeitures were applied.

Vesting

Vesting in the matching contributions portion of their account plus earnings thereon is based on years of continuous service. Matching contributions vest 20% after completion of the first two years of service and vest an additional 20% thereafter until fully vested at six years. A participant becomes fully vested upon reaching normal retirement age (age 65) or in the case of death or disability.

NOTE 1 - Description of Plan – continued

Participant Accounts

Each participant's account is credited with the participant's salary deferral contribution, rollovers (transfers in from other qualified plans), the Company profit sharing contributions, and allocations of (a) Plan sponsor discretionary contributions (if any), (b) Plan earnings, (c) realized and unrealized gains and losses on investments, and (d) administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Hardship Withdrawals and In-Service Distributions

Participants may withdraw part or all of their vested account balances while actively employed. The Plan also allows both in-service distributions upon reaching age 59 ½ and hardship withdrawals based on certain hardship situations as defined in the Plan. Hardship withdrawals are subject to IRC restrictions and penalties.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the highest outstanding balance of loans in the last 12 months or 50% of their vested account balance. The number of loans a participant may have outstanding is limited to two. All loans must be approved by the Plan administrator and will bear interest at a rate commensurate with local prevailing rates. Interest rates on participant loans range from 4.25 – 9.50%. Loans are secured by the balance in the participant's account, require bi-weekly payroll deductions, and are due through October 16, 2029.

Forfeited Accounts

Terminating participants forfeit the non-vested portion of the participants' employer contributions. Forfeitures may be used to reduce the Plan's contributions or pay reasonable Plan expenses as directed by the Plan. For the year ended December 31, 2024, \$70,995 of forfeitures were used to reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$25,800 and \$9, respectively.

Payment of Benefits

Participants are eligible for retirement benefits upon attaining the age of 65 or early retirement, defined as age 59-1/2. On termination of service due to death, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or installments over a period of time. For termination of service due to disability, retirement or for other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution or through the purchase of an annuity contract. However, if the total value of the vested balance is \$5,000 or less the entire vested balance will be distributed in a lump sum distribution or through a direct rollover. Benefit payments to participants are recorded when paid.

Investment Options

Participants are afforded several investment options covering a wide range of investment objectives and risk. Participants may allocate their contributions across these options in any proportion they wish and can change this allocation at any time. Transfers of account balances between elected investment options may also be made at any time.

NOTE 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting under U.S. Generally Accepted Accounting Principles (GAAP).

Contributions

Contributions from Plan participants and the related matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit responsive group annuity contract, which is reported at contract value. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees. See Note 4 for additional information related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Earnings and interest from investments are recorded as earned using the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation in fair value includes the Plan's gains and losses investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

The Plan Sponsor may elect to pay the administrative expenses of the Plan. If not paid by the Plan Sponsor, administrative expenses are required to be paid by the Plan. All such costs and expenses will, unless allocable to the accounts of participants, be charged against the accounts of all participants on a pro-rata basis or in such other reasonable manner as may be directed by the Plan. In addition, certain accounting and administrative functions of the Plan are performed by employees of the Plan Sponsor at no cost to the Plan.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. The Plan has determined that there are no subsequent events pursuant to the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC).

NOTE 3 – Information Prepared and Certified by Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Trust Company LLC, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of 2024 and 2023.
- Investment income, net and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

NOTE 4 – Fair Value Measurements

ASC 820, Fair Value Measurements and Disclosures, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

NOTE 4 – *Fair Value Measurements, continued*

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: The Plan’s shares of mutual funds are valued at quoted market prices which represent the net asset value (NAV) of shares held by the Plan at each year end. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1. *Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods could produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – Investments at Contract Value

The Plan has a fully benefit-responsive investment contract with John Hancock, which is called the John Hancock Stable Value Guaranteed Income Fund (Stable Value Fund). The contract value of the Stable Value Fund was \$65,560 and \$65,618, at December 31, 2024 and 2023, respectively. The crediting rate will be set every January 1 and July 1 and will generally be guaranteed for 6 months. However, if the weighted value of certain indexes changes by more than 2%, John Hancock reserves the right to also reset the crediting rate on October 1 or April 1. The minimum crediting rate is 1%. The crediting interest rate and average yield for the year ended December 31, 2024, was 1.7%

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Such events include the following: (a) the Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC, (b) premature termination of the contracts, (c) Plan termination or merger, (d) changes to the Plan's prohibition on competing investment options, or (e) bankruptcy of the Company or other Company events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Such events include the following: (a) an uncured violation of the Plan's investment guidelines, (b) a breach of material obligation under the contract, (c) a material misrepresentation, or (d) a material amendment to the agreements without the consent of the issuer.

NOTE 6 – Tax Status

The Plan has adopted a non-standardized form of a pre-approved plan. The pre-approved plan provider, CCH Incorporated DBA FTWilliam.com, has received on June 30, 2020, an opinion letter from the Internal Revenue Service as to the plan's qualified status. The pre-approved plan opinion has been relied upon by the Plan. The Plan has since been amended and restated and the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – Plan Termination

The Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan’s termination, participants will become fully vested in their accounts.

NOTE 8 – Related Party and Parties-In-Interest Transactions

Certain Plan investments are managed by John Hancock Trust Company LLC the custodian of the Plan and therefore these transactions qualify as party in interest transactions. Fees paid during the year for professional services rendered by parties-in-interest were based on customary and reasonable rates for such services. Participant loan origination fees are paid out of the relevant participants’ accounts.
