Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 403(b) Thrift Plan for Center for New Horizons, Inc. dba Head Injury Association (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. Description

The following brief description of the 403(b) Thrift Plan for Center for New Horizons, Inc. dba Head Injury Association (the Plan), which is sponsored by Center for New Horizons, Inc. dba Head Injury Association, Inc. (the Center) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution pension plan under Section 403(b) of the Internal Revenue Code (IRC) and covers all eligible employees of the Center. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Administration

Empower Life & Annuity Insurance Company of New York (Empower) is the Plan's trustee and custodian of the Plan as of December 31, 2024 and 2023. The Center, as Plan Sponsor, controls and manages the operation and administration of the plan.

Eligibility

All employees that are not excluded employees (non-resident aliens and employees who are eligible to participate in another 401(k) plan or 403(b) plan sponsored by the Center), as defined by the Plan document, are eligible to participate in the Plan on the first date of employment with the Center. There is no age or service requirement to enter the Plan. Employees covered by a collective-bargaining agreement between employee representatives and the employer are excluded from the employer matching component and employer discretionary component.

Employee Contributions

Participants may contribute up to 100% of pre-tax annual eligible compensation for the contribution period, subject to Internal Revenue Service (IRS) limitations of \$23,000 and \$22,500 in 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions subject to IRS limitations of \$7,500 and \$6,500 in 2024 and 2023, respectively. Participant contributions are recorded in the period during which the participant's salary is reduced under a salary reduction agreement with the Center. Participants are also permitted to make rollover contributions of amounts received from other tax-qualified employer sponsored retirement plans.

Employer Contributions

The Center makes discretionary employer matching contributions, as approved by the Center for each Plan year. Participants must have attained age 18 and have performed one year of service (defined as 1,000 hours of service during the Plan year), to be eligible for the discretionary employer matching contribution. The matching contributions are directly related to employee salary-reduction contributions to the Plan. During the years ended December 31, 2024 and 2023, the Center matched 100% of participant contributions up to 5% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, rollover contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts. Participants direct the investment of their contributions, employer contributions and rollover contributions into various investment options offered by the Plan.

Vesting

Participants are vested immediately in their individual deferral and rollover contributions and actual earnings thereon. Participants are to be vested in the Center's discretionary employer matching contributions based upon the participant's years of continuous service, as follows:

3 or more	100

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures of employer contributions are allocated or divided among participants or used to reduce future matching contributions. Forfeitures in the amount of \$26,431 and \$9,829 were used in 2024 and 2023, respectively, to reduce employer matching contributions. The balance in the forfeiture account was \$0 as of both December 31, 2024 and 2023.

Payments of Benefits

Upon termination of employment, retirement, disability, or death, a participant may elect one of several forms of payment (e.g., lump sum, annuity, etc.) to receive the vested balance of his or her account, as defined by the Plan document. Participants are also eligible for in-service withdrawals after attaining 59½ years of age. The Plan allows hardship withdrawals against the vested benefits of active employees. The Plan allows the participant to elect to have any portion of an eligible distribution paid directly to an eligible retirement plan specified by the participant as a direct rollover.

Notes Receivable from Participants

Participants may borrow from their account balance up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance reduced by the highest outstanding loan balance during the past 12 months. The Plan requires a minimum loan of \$1,000. Each note must be repaid within a period not to exceed five years, unless the note is for the purchase of a principal residence. The participant loans are secured by the balance in the participating account and bear interest at a fixed rate determined at the time of borrowing and fixed for the life of the loan. Principal and interest are paid through payroll deductions.

2. Summary of Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments (except for fully benefit-responsive investment contracts, which are reported at contract value) are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note 5 for a discussion of fair value measurements. See Note 6 for a discussion of the fully benefit-responsive investment contract valued at contract value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Center. Expenses that are paid by the Center are excluded from these financial statements. Investment-related expenses are included in net appreciation in the fair value of investments. Loan maintenance fee, plan asset based fee and registered investment advisor fee are included in administrative expenses.

3. Risk and Uncertainties

The Plan invests in various investment securities. These investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities and the level of uncertainty related to changes in the value of investments,

it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in the fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, a qualified institution.

5. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The

mutual funds held by the Plan are actively traded. These investments are classified as Level 1, in accordance with the fair value hierarchy.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Investment Contract with Insurance Company

The Plan has a benefit-responsive guaranteed investment contract with Empower, whereby Empower maintains a guaranteed interest account for each participant. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spin-offs of a subsidiary), which cause a significant withdrawal from the Plan; or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value represents contributions made under the

contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

7. Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of funds managed by Empower; therefore, these transactions qualify as party-in-interest transactions. Purchases and sales of these funds are open-market transactions at fair market value. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA and applicable exemptions promulgated thereunder. Notes receivable from participants qualify as party-in-interest transactions.

8. Tax Status

The Plan uses pre-approved plan documents sponsored by Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC (formerly referred to as Great-West Life & Annuity Insurance Company of New York and Great-West Trust Company, LLC) (collectively, Empower). Empower Retirement received opinion letters from the IRS, dated March 31, 2017 and April 7, 2021, respectively, which state that the pre-approved plan documents, as then-designed, satisfy the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letters, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

9. Plan Termination

Although it has not expressed any intent to do so, the Center has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, all participants' accounts would become fully vested.

10. Subsequent Events

The Plan's management has performed subsequent events procedures through October 15, 2025, the date the financial statements were available to be issued. There were no other subsequent events requiring adjustments to the financial statements or disclosures as stated herein.
