Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Transel Elevator and Electric, Inc. 401(k)/Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's system of internal control over financial reporting ("internal control") as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan ("investment information") by Reliance Trust Company, the trustee, which prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that have not been identified. However, as discussed below, we identified certain deficiencies in internal control that we consider to be material weaknesses.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented or detected and corrected on a timely basis. A reportable finding is an indication of deficiencies in internal control identified during the audit that have not been communicated to management by other parties and that, in the auditors' professional judgment, are of sufficient importance to merit management's attention.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in the Plan's internal control to be significant deficiencies and a reportable finding:

Participant Withholdings and Matches

Issue:

As a result of not following the definition of eligible wages in accordance with the Plan document, the Internal Revenue Service found that the Sponsor under contributed to the Plan for some participants and over contributed to the Plan for other participants.

Recommendation:

We recommend that the Sponsor monitor the computation of all eligible wages to ascertain whether or not employer contributions are in accordance with the Plan documents. In conjunction with our recommendation, you may want to consider having your payroll provider set up separate codes for bonuses and commissions, so the determination of eligible wages is simplified. Additionally, the contributions and matches should be checked quarterly or bi-annually in order catch and correct any errors in participant contributions or employer matches before year-end.

Missing Employee Files

Issue:

During the course of our audit, I-9s could not be located for two long-standing employees.

Potential Effect:

Without such documentation, being unable to verify employee information, such as hire dates that impact eligibility, vesting, and withdrawals, could result in related errors.

Recommendation:

We recommend that management review their documentation retention practices and files to ensure their files are complete. As well as consider implementing an electronic storing method of the employee files.
