Independent Auditor's Report

To the Plan Administrator of
RWJBarnabas Health 401(k) Savings Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of RWJBarnabas Health 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of RWJBarnabas Health 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of RWJBarnabas Health 401(k) Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about RWJBarnabas Health 401(k) Savings Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of RWJBarnabas Health 401(k) Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about RWJBarnabas Health 401(k) Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan

The following description of the RWJBarnabas Health 401(k) Savings Plan (the "Plan"), formerly Barnabas Health 401(k) Savings Plan ("BHSP"), provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1999 and is a defined contribution plan covering the former participants of BHSP and substantially all new employees of Barnabas Health, Inc. ("Barnabas Health"). Barnabas Health and its affiliates and Robert Wood Johnson Health Care Corp. and its affiliates completed a transaction pursuant to a merger agreement to form RWJ Barnabas Health, Inc. (the "Corporation"), which is a not for profit, tax exempt corporation. The Plan also covers former participants of the Robert Wood Johnson Physician Enterprise ("RWJPE") 401(k) Plan ("RWJPE 401k") and new employees of RWJPE, former employees of Liberty Healthcare Management, LLC ("LHM") who were former participants in the Liberty Healthcare Management, LLC 401(k) Plan ("LHM 401k") and are now employees of Jersey City Medical Center ("JCMC"), new employees of JCMC and former participants of the Greenville Hospital Retirement Plan ("Greenville Plan"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Trustee of the Plan is Fidelity Management Trust Company and the Plan Sponsor is RWJBH Corporate Services, Inc.

Effective December 31, 2022, the Plan merged with the Trinitas Hospital Savings and Retirement Plan (the "TRMC Plan"). The majority of the assets were transferred to the Plan on December 30, 2022 with the remaining balance of \$1 transferred on January 6, 2023. The Plan covers former participants of the TRMC Plan and new employees of Trinitas Regional Medical Center ("TRMC").

The Investment Committee of the Board of Trustees of the Corporation has delegated the administrative and investment responsibilities to the Defined Contribution ERISA Administrative and Defined Benefit Plan Subcommittee (the "Committee"). The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees.

Eligibility

Employees of Barnabas Health, RWJPE and TRMC are eligible to participate in the Plan immediately upon hire.

Employees of Barnabas Health and JCMC become eligible for employer matching and non-elective contributions upon completion of three months of service if they are full-time employees, or six months of service if they are part-time employees, or otherwise upon completion of 1,000 hours of service.

Employees of RWJPE are eligible for matching contributions on a quarterly basis for full-time employees and on a calendar year basis for part time employees. Matching contributions are conditioned on satisfying the following requirements: (i) full time employees must be employed in the last pay period of the quarter; (ii) part time employees must be employed in the last pay period of the Plan year and complete 1,000 hours of service during the Plan year; (iii) full time employees must be scheduled to work at least 78 hours bi-weekly; and (iv) employees will share in the matching contribution for the full year regardless of the amount of service

completed during the Plan year if terminated due to death, disability or attainment of age 65. Employees hired after January 1, 2018 will be eligible for matching contributions and nonelective employer contributions upon attaining age 21 and completing two years of service.

Employees of TRMC are eligible for matching contributions after 1 year of service.

Contributions

The Plan provides that participants employed by Barnabas Health and RWJPE may contribute, in the form of pretax deferred salary reductions, any whole percentage of gross compensation between 1% and 100% up to Internal Revenue Service ("IRS") limits. Participants may also contribute in the form of after-tax (Roth) salary deductions.

Employees of Barnabas Health receive matching contributions of 75% up to the first 4% of compensation contributed by participants based on the affiliate facility that employs the participant and length of employment of the participant. No matching contributions are made by Barnabas Health to certain participants who elected not to participate in Barnabas Health's defined benefit cash balance plan, or who are covered by a collective bargaining agreement that allows for participation in the Plan but does not provide matching contributions.

Each year, employees of TRMC may contribute up to 50 percent of pretax annual compensation up to the maximum limits of the Internal Revenue Code ("IRC"). The Plan includes a Roth 401(k) feature in which participants may contribute post-tax annual compensation subject to the contribution provisions of the Plan and the maximum limits of the IRC. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). TRMC may make a discretionary match equal to 50 percent of that portion of a participant's contribution which does not exceed three percent of the participant's pay each period. TRMC may also make discretionary nonelective contributions, qualified matching contributions or qualified nonelective contributions at the option of TRMC's Board of Trustees.

New employees of Barnabas Health are automatically enrolled with a 3% deferral rate unless the participant elects otherwise, and they receive the following matching and nonelective contributions based on eligible compensation and years of service as follows:

Vesting for new employees is 0% less than 3 years and 100% if 3 or more years of service.

Eligible participants of the Plan employed by RWJPE shall receive matching contributions and nonelective contributions based on years of service as follows:

Eligible participants employed by JCMC shall receive a matching contribution equal to one-half of one percent (0.5%) of compensation, up to one percent (1%) of compensation that is contributed as deferred cash contributions and catch-up contributions on behalf of such participant during the plan year. Eligible employees could also receive a discretionary non-elective contribution; the amount credited to each participants account will be based on the same ratio that the participant's compensation bears to the total compensation of all participants in the Plan.

Each year, JCMC eligible employees may receive discretionary contributions. The amount credited to each participant's account will be based on the same ratio that the participant's compensation bears to the total compensation of all participants in the Plan. For 2024, the discretionary contribution was 1% of eligible employee compensation. The Plan also makes a matching contribution to the eligible JCMC employees equal to 50% of 1% of a participant's compensation, not to exceed 1% of the participant's total salary. Rollovers of vested benefits from other qualified plans are permitted. Participant contributions from JCMC employees are not permitted, although JCMC's matching contribution is contingent upon the participant's minimum 1% contribution to the RWJBarnabas Health 403(b) Savings Plan (the "403b plan"). All JCMC participants' contributions are deposited into the 403(b) plan, which includes only participants' contributions. The accounts of the 403(b) plan are not included in these financial statements. Contributions are subject to certain IRS limitations.

Participants' contributions, under the former Greenville Plan, were deposited into the respective 403(b) plan, which includes only participants' contributions. The accounts of the 403(b) plan are not included in the accompanying financial statements. Contributions are subject to certain IRS limitations.

As dictated by the Plan, the maximum combined participant and employer contributions to a participant's account for a plan year is limited to the lesser of \$69 (or \$76.5 with catchup contributions for those over 50 years of age) for 2024 or 100% of the participant's annual compensation. The IRS has limited a participant's annual tax deferred contribution to \$23 (or \$30.5 with catch-up contributions for those over 50 years of age) for 2024.

Vesting

The participants have full and immediate vesting in their contributions and related interest and earnings credited to their accounts. Most participants become vested in the portion of their accounts attributable to Barnabas Health's contributions in accordance with the provision of the Plan as follows:

Certain participants are eligible for an accelerated vesting schedule.

Most participants employed by JCMC become vested in the portion of their accounts attributable to Barnabas Health's contributions in accordance with the provision of the Plan as follows:

In addition, participants will become 100% vested in JCMC's contributions and any earnings on such contributions if the participant (a) attains the Plan's normal retirement age of 65; (b) becomes permanently disabled; and (c) dies while in service, or if the Plan terminates.

TRMC participants have full and immediate vesting in their contributions, including related earnings therein, qualified matching TRMC contributions and qualified nonelective TRMC contributions.

Participants employed by RWJPE were vested immediately in their contributions and the Barnabas Health's contributions plus earnings thereon.

Forfeited Accounts

Participants who terminate before becoming fully vested forfeit that portion of their account related to the employer contribution to which they are not vested. Any forfeited funds will periodically be used by Barnabas Health to reduce its required contributions to the Plan. During 2024, \$0 and \$2,929 of forfeitures were used to pay expenses and fund employer contributions into the Plan, respectively. During 2023, \$0 of forfeitures was reallocated to participant accounts. At December 31, 2024 and 2023, there were \$1,952 and \$1,438, respectively, of forfeitures available to be used to reduce Barnabas Health's future required contributions.

Participant Accounts

Each participant's account is credited with (a) the participant's salary deferrals, (b) matching and non-elective contributions, (c) rollovers from other qualified plans, (d) allocations of investment income changes in fair value of investments, and (e) charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Participants may receive all or a portion of their vested account balance upon reaching 59½ years of age or termination of employment in the form of a cash, lump sum payment, as a series of equal periodic installments payable for a specified number of fixed monthly or annual payments or may transfer their balance to an individual retirement account or another employer's qualified plan. Participants can elect to receive all or a portion of amounts attributable to rollovers because of financial hardship. Death benefits are paid according to the beneficiary designation in effect at the time of death.

For TRMC, a participant will receive a lump sum payment if the value of the account is \$1 or less.

Notes Receivable from Participants

Participants may borrow funds from the Plan. A maximum of two loans may be taken for any reason and repayment is made through periodic payroll deductions. The minimum amount of a loan is \$1 and the maximum is the lesser of 50% of the value of the participant's vested interest in the participant's account in the Plan or \$50. The interest rate on the loan is prime plus 1%, fixed for the life of the loan which ranged from 4.25% to 9.50% as of December 31, 2024. Terms for a loan generally range from one to five years, unless the loan is for the purchase of a principal residence, in which case the terms range from 15 to 25 years.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of assets and liabilities in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee. See Note 5 for a discussion of fair value measurements.

Contract value is the relevant measure for the portion of the assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the gains and losses on investments bought and sold as well as held during the year. Certain investment-related expenses are included in net appreciation in fair value of investments.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's elective deferrals and qualified nonelective contributions, under certain circumstances, in accordance with the Plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by Barnabas Health and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Recent Accounting Standards

The Plan is not aware of any new accounting standards that were required to be adopted in 2024, or yet to be adopted, that would significantly impact the Plan's 2024 or prospective financial statements.

3. Information Certified by Trustee

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023, and therefore, as permitted, no auditing procedures were performed by the independent auditor with respect to the information certified by the Trustee. The Trustee has certified to the completeness and accuracy of the investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 and the supplementary Schedule H, Part IV, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and notes receivable activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

4. Fully Benefit-Responsive Investment Contracts

The Plan holds investment contracts that meet the fully benefit-responsive investment contract criteria and are therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The contract issuers are contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuers and for each contract as follows, provided that the crediting rate can not be less than 0%:

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuers' ability to meet its financial obligations. The issuers' ability to meet their contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC;
- Premature termination of the contracts;
- Plan termination or merger;
- A breach of material obligation under the contract; or
- A material amendment to the agreements without the consent of the issuer.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, a material amendment to the agreements without the consent of the issuer may allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value.

5. Fair Value Measurements

Financial Accounting Standards Codification (“ASC”) Topic 820-10, *Fair Value Measurement*, establishes a three-level valuation hierarchy for disclosure of fair value measurements. The valuation hierarchy is based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date. The three levels are defined as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value:

- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price.
- Stable value funds are valued at the NAV. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

6. Related Party and Party-In-Interest Transactions

Certain of the Plan's investments are managed by the Trustee, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of Barnabas Health. No such officer or employee receives compensation from the Plan.

7. Income Tax Status

The Plan has received a favorable determination letter dated October 20, 2016, in which the IRS stated that the Plan is in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Management evaluates tax positions taken by the Plan and recognizes a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

8. Plan Termination

The Committee has the right to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in employer contributions.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. The Plan's investment portfolio includes mutual funds, stable value funds, a guaranteed investment contract and an insurance contract. As of December 31, 2024 and 2023, three investments represented 40% and 42%, respectively, of the Plan's net assets available for benefits. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

10. Subsequent Events

Management evaluated all events and transactions that occurred after December 31, 2024 and through October 14, 2025, which is the date the financial statements were available to be issued. Effective July 1, 2025, the Plan was amended and restated to harmonize eligibility, contribution and vesting provisions. Among other provisions, employees are immediately eligible to participate in the Plan once hired. The Plan will also provide an employer matching contribution of 50% of the first 6% of the employee contribution and may offer a discretionary non-elective annual contribution. The Plan did not have any other material subsequent events during the period.
