1. Description of Plan:

The following description of the Chemence, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of Chemence, Inc., Chemence Medical, Inc., and Craffiti, Inc. who have adopted the Plan (collectively referred to as the Plan Sponsor, Plan Administrator, Employer, or the Company). The Plan covers substantially all employees who are at least eighteen years of age and complete three months of services, as defined by the Plan documents. Employees are eligible to make deferrals, receive employer match and employer nonelective contributions on the first day of the calendar month once eligibility requirements have been met, as previously defined. The Plan implemented a Safe Harbor plan design, as permitted by the Internal Revenue Service (IRS), which exempts the Plan from certain compliance requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Investment Committee determines the appropriateness of the Plan's investments, monitors investment performance, and reports to the Board of Directors of the Plan Sponsor.

Contributions

*Participant Contributions:* Each year, participants may defer a portion of their pre-tax annual compensation, as defined by the Plan documents, subject to certain statutory limitations. Participants may also elect to make Roth 401(k) contributions, which are subject to federal income taxes in the year of deferral. Additionally, the Internal Revenue Code (IRC) allows for participants over the age of 50 to make additional contributions (catch-up contributions) in excess of these limits. For 2024 and 2023, the deferred amount may not exceed \$23,000 and \$22,500, respectively. The maximum catch-up contributions for 2024 and 2023 was \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan.

*Employer Contributions:* The Plan Sponsor makes a safe harbor matching contribution to each eligible participant's in an amount equal to the each participant's salary deferral that does not exceed 3% of their eligible compensation plus 50% of their salary deferrals between 3% and 5% of a participant's compensation to the Plan for the plan year. The Plan Sponsor may elect to make a discretionary nonelective contribution in an amount to be determined by the Plan Sponsor for each plan year. The participant must be employed on the last day of the Plan year and must work at least 1,000 hours during the Plan year to receive Plan Sponsor's nonelective contributions. For the years ended December 31, 2024 and 2023, the Plan Sponsor elected not to make a discretionary nonelective contribution to the Plan.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's pre-tax contribution, Roth 401(k) contributions, the Plan Sponsor's safe harbor matching contributions, the Plan Sponsor's discretionary nonelective contributions, if any, plan earnings or losses, an allocation of forfeitures from terminated participants' non-vested accounts, if any, and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan documents. Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account.

1. Description of Plan (continued):

Vesting

*Participant Contributions* : Participants are vested at all times in their pre-tax contributions, Roth 401(k) contributions, rollover contributions, and earnings or losses thereon.

*Employer Contributions* : : Participants are vested at all time in the safe harbor matching contributions. Participants vest at a rate of 20% per year of employment and are fully vested after five years of employment in the Employer’s profit sharing contributions and the Employer’s nonelective contributions, and earnings or losses thereon. Participants will also fully vest upon death, disability, or the attainment of sixty-five years of age, the Plan’s normal retirement age.

Notes Receivable from Participants

Effective January 1, 2019, new loans are not permitted by the Plan. Prior to January 1, 2019, participants could borrow from their fund accounts up to 50% of their vested account balance, subject to a minimum of \$1,000 and a maximum of \$50,000, reduced by the excess of the participant’s highest outstanding participant loan during the twelve month period immediately prior to the new loan application date. Loan transactions were treated as a transfer between the investment funds and the loan fund. Loan terms ranged from one to five years, or up to ten years for the purchase of a primary residence. The notes receivable from participants are secured by the balance in the participant’s account and bear interest at a rate commensurate with the rate of interest charged on similar commercial loans by persons or institutions in the business of lending money in the same geographic region as the Plan Sponsor. Principal and interest are paid ratably through payroll deductions. If repayment is not made by payroll deduction, a loan shall be repaid to the Plan by payment to the Plan Sponsor. The maximum number of Plan loans a participant could have outstanding at any time is one.

Benefits Paid to Participants

Upon termination of service, attainment of normal retirement age of sixty-five years of age, retirement, disability or death, a participant may elect to receive a lump-sum amount equal to the vested value of their account, annual installments over a specified period, or partial withdraws. Installment payments are only available to participants who have attained fifty-nine and a half years of age, and have to take required minimum distributions. Military distributions, as defined by the Plan documents, are allowed under the Plan for qualified reservist distributions.

Forfeited Accounts

Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. These accounts will be used to either reduce future employer contributions or may be used to pay administrative expenses of the Plan. At December 31, 2024 and 2023, and for the years ended, forfeited non-vested accounts and forfeited non-vested balances used to reduce employer contributions and/or pay administrative expenses were:

2. Summary of Significant Accounting Policies:

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Collective Trust Fund

Investments in the collective trust fund are required to be reported at fair value. The collective trust fund is composed primarily of fully benefit-responsive investment contracts held by the fund's trustee. Net asset value (NAV) for the collective trust fund reflects the contract value of the underlying fully benefit-responsive investment contracts within the fund because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents the costs plus contributions made under the contract plus interest at the contract rates less withdrawals and administrative expenses. The Plan has elected to value the collective trust fund using NAV as the practical expedient to determine fair value.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit loss has been recorded. If a participant does not make loan repayments, and the plan administrator considers the participant note receivable to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan agreement.

Excess Contributions Payable

At December 31, 2024 and 2023, excess contributions payable to participants are as follows:

Excess Contributions Payable (continued)

The excess contributions payable are for participant contributions in excess of amounts allowed by the Internal Revenue Service ("IRS"). The corrective distributions are recorded as a liability and were included in corrective distributions in the statement of changes in net assets available for benefits for the year ended December 31, 2021.

Benefits Paid to Participants

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are therefore excluded from these financial statements. Investment-related expense are included in the net appreciation (depreciation) in fair value of investments. Fees for distributions as well as the administration of notes receivable from participants are included in the administrative expenses and charged directly to the participants' accounts.

Date of Management's Review of Subsequent Events

Subsequent events have been evaluated through October 09, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Reliance Trust Company and T. Rowe Price Trust Company:

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by Reliance Trust Company, the custodian of the Plan, and T. Rowe Price Trust Company, the custodian of the collective trust fund (collectively referred to as the custodian) for the period from January 1, 2024 through March 18, 2024. For the period from March 18, 2024 through December 31, 2024, ADP Retirement Trust Services, LLC, the trustee of the Plan, certified the following information as complete and accurate for the period of the December 31, 2024 year end that they held the Plan's assets and acted as the trustee of the Plan.

4. Fair Value Measurements:

Fair value measurement guidance under GAAP defines fair value, establishes a consistent framework for measuring fair value, and establishes a fair value hierarchy based on the observability of inputs used to measure fair value. The objective of a fair value measurement is to determine the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). Accordingly, the fair value hierarchy gives the highest priority to quoted prices (unadjusted) in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

5. Tax Status: In the base plan document

The Internal Revenue Service (“IRS”) has determined and informed the trustee by a letter dated October 6, 2020 that the pre-approved defined contribution plan on which the Plan is based, and the related trust as then designed was in accordance with applicable regulations of the IRC. The volume submitter plan has been amended subsequent to that date. However, the Sponsor believes that the Plan was, at all times during the years ended December 31, 2024 and 2023, designed and operated in compliance with the applicable requirements of the IRC, and that the Plan and related trust continued to be tax-exempt.

GAAP requires the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS, U.S. Department of Labor, and/or Georgia Department of Revenue. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination:

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the accounts of each participant would continue to be fully vested.

7. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant’s account balances and the amounts reported in the statements of net assets available for benefits.

8. Related-Party Transactions and Party-in-Interest Transactions:

Certain plan investments are mutual funds and a collective trust fund managed by the custodian, and therefore, these transactions qualify as party-in-interest transactions. The custodian administers the Plan and receives fees from the Plan for these services. The Plan had notes receivable from participants as of December 31, 2024 and 2023. These notes, as well as all related transactions, qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Assets Allocated to Terminated Participants:

Net assets available for benefits include amounts allocated to the accounts of participants who were terminated prior to year-end but had not yet received payment. At December 31, 2024 and 2023, the vested account balances of terminated participants were:
