Notes to Financial Statements

NOTE A -- DESCRIPTION OF PLAN

The following description of the Ohio AFSCME Legal Care Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General. The Plan provides prepaid personal legal services to the Plan's participants and their dependents. The Plan and related trust were established effective March 1, 1987 pursuant to a collective bargaining agreement between certain employers and Ohio Council 8 of the American Federation of State, County and Municipal Employees (AFSCME). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits. Various legal services are provided to the participants and their dependents through a network of attorneys established by MetLife Legal Plans, Inc. The Plan is responsible for paying a monthly fee to the providers at \$4.05 per month per participant. The various services include real estate purchases/sales, document preparation (e.g. deeds, notes, powers of attorney), wills, debt collection defense, separation agreement and dissolution or divorce, in addition to general advice and consultation.

Employer Contributions. Participating employers contribute \$5.00 per month for each eligible participant pursuant to the current collective bargaining agreements between employers and the union.

NOTE B -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of estimates. The preparation of financial statements in conformity with accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results may differ from those amounts.

Federal Tax-Exempt Status. The Plan is exempt from Federal income tax under Section 501 (c)(9) of the Internal Revenue Code. The sponsor received its most recent determination letter from the Internal Revenue Service dated August 4, 1994, which indicated that the Plan and related trust were designed in accordance with the applicable sections of the Code.

NOTE B -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Employer Contribution Receivable . Employer Contributions Receivables are recorded at the amount the Company expects to collect on balances outstanding at year-end. Based on management's assessment of the credit history with Employers having outstanding balances and current relationships with them, it has concluded that realization lossess on balances outstanding at year-end will be immaterial.

Basis of Accounting. The records of the Plan are maintained on the accrual basis of accounting, except that benefit payments are recorded when paid.

NOTE C -- OTHER MATTERS

Related party transactions. The Plan pays \$166.67 per month for the use of facilities and administrative personnel employed by the Ohio AFSCME Care Plan. These are shown as administrative fees and totalled \$2,000 for the years ended December 31, 2024 and 2023. Additionally, there are contributions for benefits that are received by the Care Plan and there are contributions for the Care Plan received by the Legal Plan during the year. These amounts are repaid periodically through transfers between the plans. At December 31, 2024 and 2023, the net of these amounts are shown on the balance sheet as a receivable. At December 31, 2024 and 2023 the amounts receivable were \$9,410 and \$4,915 respectively.

Termination provisions. The Plan's board of trustees, as sponsor, has the right under the Plan to modify the benefits provided to its participants and their dependents. The Plan may be terminated only by joint agreement between the employers and union.
