Opinion

We have audited the financial statements of Employees Flexible Benefit Plan of The Jay Group (the Plan), an employee benefit plan subject to the Employee Retirement Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended, and the related notes to the financial statements.

Note 1 - Description of Plan

The following description of the Employees Flexible Benefit Plan of The Jay Group (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General

The Plan is a health and welfare benefit plan that provides benefits to employees of The Jay Group (the Company), as well as former employees electing coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA). In order to be eligible for health, dental, vision, short-term disability, long-term disability, life insurance, and accidental death and dismemberment benefits, the employee must be a full-time or part-time employee who works at least 30 hours per week and has completed 30 days of service. This was changed from 90 days, which was in place in 2023. The 30 days of service waiting period is waived for temporary agency employees working at the Company, if they had met this service requirement as a temporary employee, prior to becoming a full-time or part-time employee. The waiting period is also waived for former employees of The Jay Group that are rehired within 90 days of their termination date. Benefits are also provided to dependents of these individuals who elect coverage on their behalf. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is a member of Veris Benefits Consortium, LLC, which operates as a health insurance consortium under which the members negotiate and establish welfare benefit plans for their employees. Expenses of the health plan are paid through the Veris Benefits Trust (the trust). The employees were required to pay for a portion of the cost of the benefit.

Contributions

The Company shall contribute such amounts to the Plan as necessary for timely payment of all claims and administrative expenses of the Plan. The Company provides for stop loss insurance over a specified amount as per agreement with the reinsurance carrier, with the premiums being paid by funds deposited in the Plan. Employee contributions are determined on a fixed fee basis. The amount varies depending on the selection of individual or eligible dependent coverage.

Benefits

The Plan provides health (medical, hospital, surgical, major medical, and prescription drug benefits), dental, vision, short-term disability, long-term disability, life insurance, and accidental death and dismemberment to substantially all employees of the Company who meet the service requirements of the Plan and to their covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through COBRA as defined in the plan document.

All health and dental benefits are self-insured. Current health and dental claims are processed through Capital Blue Cross and Delta Dental, respectively. All other plan benefits are fully insured.

The Company provides most health insurance benefits and pays the administrative fees incurred. The employees pay a portion of their health coverage based upon the coverage chosen and may also elect dental, vision, short-term disability, long-term disability, life insurance, and accidental death and dismemberment insurance through payroll deductions. Health insurance premium payments are contributions made on behalf of a plan participant by the state's Medicaid program.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits

Premiums paid by the Company or the trust are recorded as insurance premiums in the accompanying statement of changes in net assets available for benefits when paid.

Claim payments are recorded when paid by the third-party claims administrator.

Stop Loss Insurance

The Plan has a stop loss insurance arrangement whereby the stop loss insurance will cover the Plan's obligations for any plan participant's claims in excess of a fixed dollar amount (self-insured retention). The self-insured retention for the Company was \$80,000 and \$75,000 per covered person for the years ended December 31, 2024 and 2023, respectively. Stop loss refunds of \$841,438 and \$15,100 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

In addition, the Plan has an aggregate stop loss insurance arrangement whereby the aggregate stop loss insurance will cover the Plan's obligations if all claims exceed a fixed dollar amount. Premiums for stop loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits.

Benefit Obligations

Plan obligations at December 31, 2024 and 2023 for health claims incurred by active participants, but not reported at that date, are estimated by the Plan's management. Such estimated amounts are reported in the accompanying statement of benefit obligations. Due to the short-term nature of the reserve liability, time value of money was not used to discount future payments. As of December 31, 2024 and 2023, benefit obligations for claims that had been incurred but not paid totaled \$191,076 and \$113,010, respectively. Each of these amounts was paid in the plan year immediately following the respective period end dates noted above. It is the Plan's policy that deductions for claims are recorded when paid.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, the custodian, and actuary. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

Note 3 - Plan Administration

The Plan has entered into a service agreement with Capital Blue Cross to provide consulting and administrative services. Capital Blue Cross is responsible for determining eligibility of the claiming person, evaluating the validity of the claim, calculating the amount of the claim payable, if any, and issuing a check payable to the provider of services, or to the employee in accordance with the terms of the Plan. Capital Blue Cross charges a fee based on the number of employees participating in the Plan.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

The interest-bearing cash account is valued at carrying value, which approximates fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Tax Status

The Plan is funded through a nonqualified trust under Internal Revenue Code (IRC) 419(a). The trust files Form 1041 U.S. Income Tax Return for Estates and Trusts. Plan management believes that the Plan is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, active employees, discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 7 - Risks and Uncertainties

The Plan maintains cash in a bank deposit account which may, at times, exceed federally insured limits. The Plan has not experienced any losses in such account. The Plan believes it is not exposed to any significant credit risk on cash.

The actuarial present value of plan benefit obligations is reported based on certain assumptions, applied to historical claim information, which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 8 - Related Party Transactions

Certain plan investments are managed by UMB Bank, the custodian of the Plan and; therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for investment management and custody services are immaterial. As described in Notes 1, 2, and 3, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.
