## **Independent Auditors' Report**

To the Plan Administrator of



## Notes to Financial Statements

December 31, 2024

### Note 1 - Description of Plan

The following description of the Monahan Products, LLC 401(k) Profit Sharing Plan (the “Plan”) is only provided for general information. Participants should refer to the Summary Plan Description or Plan agreement for a more complete description of the Plan's provisions.

General – The Plan was established January 1, 2010 and is a defined contribution plan with a salary reduction feature under Internal Revenue Code Section 401(a). The Plan Administrator/Sponsor is Monahan Products, LLC. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator oversees governance of the plan as well as determines the appropriateness of the Plan's investment offerings and monitors investment performance.

SECURE Act 2.0 - On December 29, 2022, the Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act was signed into law. The SECURE 2.0 Act contains dozens of new retirement-related provisions with effective dates ranging from January 1, 2024 through 2027. Plan management has evaluated the various provisions available and is determining which provisions to adopt.

Eligibility – All employees of the Company, except union and leased employees, residents of Puerto Rico, are eligible for the plan upon attaining age 21. In order to be eligible to receive an employer match contribution, participants age 21 years or older, must have completed a year of service. However, in order to be eligible to receive a nonelective profit sharing contribution, participants age 21 years or older, must have completed 501 hours of service during the plan year or be employed on the last day of the plan year. If a participant's employment terminates due to death, disability, or retirement, the participant will be eligible for the nonelective profit sharing contribution in the year of death, disability or retirement regardless of service hours or active employment.

Participant Contributions – Participants, at their option, can defer up to 100% of their eligible compensation on a pre-tax basis, not to exceed the IRS annual limit. Participants age 50 and over may voluntarily contribute catch up contributions subject to IRS limits. Salary deferrals are not subject to federal income taxes until withdrawn from the Plan in accordance with Section 401(a) of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified pension plans (rollover contributions). In addition, the Plan allows for Roth deferrals, which are treated as post-tax deferrals. These contributions are subject to the same deferral limits as pre-tax contributions.

Employer Contributions – The Plan allows an annual discretionary matching contribution of elective pre-tax and Roth salary deferrals and catch-up contributions. In addition, the Company may elect to make a discretionary profit-sharing contribution to the Plan. There was a discretionary matching contribution of \$352,077 for the year ended December 31, 2024, which has been recorded as a receivable in the accompanying statement of net assets available for benefits. There was no profit-sharing contribution for the year ended December 31, 2024.

## Note 1 - Description of Plan (Cont.)

Vesting – Participants are immediately vested in their contributions, including rollover contributions plus actual earnings thereon. Employer matching and profit-sharing contributions and actual earnings vest in accordance with the following schedule:

If a participant's employment terminates due to death, disability or retirement, the participant's employer contribution account becomes 100% vested.

Participant Accounts – Each participant's account is credited with the participant's contribution and an allocation of the Company's discretionary contributions, if any, and plan earnings (losses) (based on participant's investment election and account balance) and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investment Options – All assets of the Plan are participant directed. Participants have the option of directing the investment of their contributions, as well as any employer contributions into various shares of registered investment companies or a collective investment trust offered by the Plan.

Payment of Benefits – Plan benefits are available at normal retirement age (age 65), deferred retirement, disability retirement, death, or termination of employment. A participant must receive the vested portion of their account as a lump-sum payment. If the amount of a terminated participant's account is \$7,000 or less, the plan administrator may distribute the vested account without the terminated participant's consent according to the provisions of the Plan.

In-Service Withdrawals – The Plan allows for annual in-service withdrawals from the vested portion of a participant's account upon the participant's attainment of age 59½. However, rollover contributions may be withdrawn at any time.

Notes Receivable from Participants – Participants may borrow an amount up to 50% of their vested account balance. The maximum loan amount is \$50,000, reduced by the highest outstanding loan balance in the preceding twelve-month period. Repayment terms may not exceed five years, although a loan for the purchase of a principal residence may be repaid over a longer term. Each borrowing is evidenced by a note bearing interest at a prevailing rate as determined by the Plan Administrator ranging from 4.25% to 9.50%. The notes are secured by the vested balance in the participant's account. Principal and interest payments are credited to the borrowing participant's account. Principal and interest are paid in level amortization payments made through payroll deductions. Loans will become due and payable in full upon the participant's death, retirement or other termination of employment with the Company.

Forfeited Accounts – Forfeited balances of terminated participants' non-vested accounts are used to reduce future employer contributions and pay plan administrative expenses. During 2024 and 2023, the Company utilized \$7,893 and \$33 respectively, of forfeited, nonvested amounts to reduce employer matching contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,455 and \$7,893, respectively.

## **Note 1 - Description of Plan (Cont.)**

Revenue Sharing Credit – For certain investments in the Plan revenue sharing credits are generated and received by Empower Trust Company, LLC, "the custodian", the custodian is returning that revenue share back to the Plan and the Plan in turn returns that revenue to the participants who are invested in those funds through an offset of the administrative recordkeeping fees. Credits issued to participants during the year ended December 31, 2024 totaled \$29,138 and are reported net of related plan administrative expenses in the accompanying statement of changes in net assets available for benefits.

## **Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting – The accompanying financial statements of the Plan are prepared using the accrual method of accounting, except that benefit payments are recorded upon distribution.

Accounting Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Fair Value Measurements – The Plan follows the provisions of the Financial Accounting Standard Board's ("FASB") Accounting Standards Codification ("ASC") Topic 820, "Fair Value Measurements and Disclosures" ("ASC Topic 820"), for assets and liabilities that are measured and recorded at fair value on a recurring basis, and to determine fair value disclosures. This standard defines fair value, establishes a framework for measuring fair value, and requires disclosures about fair value measurements. Investments measured using the net asset value ("NAV") practical expedient are exempt from categorization within the fair value hierarchy (see Note 4).

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments for a period of 90 days and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Therefore, no allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value, fair value is the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies.

Net investment appreciation and depreciation reflected in the statement of changes in net assets available for benefits include the realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held during the year (see Note 3).

Purchases and sales of securities are recorded on a trade-date basis, interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date.

Payment of Benefits – Benefit payments to participants are recorded upon distribution.

Plan Administrative Expenses – The Plan's administrative expenses are primarily paid by the Company and by the Plan from the participants' forfeited accounts. Fees related to the administration of notes receivables from participants and participant withdrawals are charged directly to the participant's account and are included in administrative expenses, while expenses for items such as recordkeeping fees are allocated to participants accounts. Investment related fees are included in the net appreciation/depreciation of the fair value of investments.

## Note 2 – Summary of Significant Accounting Policies (Cont.)

Evaluation of Subsequent Events – Management has evaluated subsequent events involving the Plan for potential recognition or disclosure in the accompanying financial statements. Subsequent events are events or transactions that occurred after December 31, 2024 up through October 14, 2025, the date the accompanying financial statements were available to be issued.

## Note 3 – Certified Investment Information

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023 and the net appreciation in the fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by the Plan's Custodian, Empower Trust Company, LLC.

## Note 4 – Fair Value Measurements

FASB ASC 820 "Fair Value Measurement" provides a framework for measuring fair value. The framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels, described as follows:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

Level 2 inputs consist of observable inputs other than quoted prices for identical assets (i.e., Level 1 inputs).

Level 3 inputs are unobservable and have the lowest priority.

#### Note 4 – Fair Value Measurements (Cont.)

The Plan uses appropriate valuation techniques based on available inputs to measure the fair values of its investments. When available the plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments when Level 1 inputs are not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

There are no Plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for investments measured at fair value.

Shares of Registered Investment Companies (mutual funds) –Valued at the daily closing prices, as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust – This investment, a stable value fund, is a public investment vehicle valued at the NAV of units of the fund. The NAV, as provided by the administrator of the fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund less its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

#### Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of a complete or partial plan termination, participants will become 100% vested in their accounts, and participants' accounts will be distributed to participants in accordance with the Plan's provision.

#### Note 6 - Income Tax Status

The Plan Sponsor on March 8, 2021, adopted a pre-approved plan document, the Angell Pension Group, Inc. Volume Submitter Defined Contribution Plan. The pre-approved plan document has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believes the Plan is qualified and the related trust is tax-exempt.

#### Note 7 – Party-In-Interest Transactions

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts and these transactions are party-in-interest transactions. All of the party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### Note 8 – Investment Risks and Uncertainties

The Plan provides for investment options in various mutual funds and a collective investment trust, which are exposed to various risks, such as interest rate, credit risk and market risk. Due to the level of risk associated with certain investment securities, and the level of uncertainty related to changes in the value of these investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.


