## Independent Auditors' Report

To the Plan Administrator and Plan Custodians  
A&A Trucking, Inc. / General Materials Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of A&A Trucking, Inc. / General Materials Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). #### NOTE A--DESCRIPTION OF THE PLAN

The following description of the A&A Trucking Inc. / General Materials Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: Employees of A&A Trucking, Inc. and General Materials, Inc. (collectively the "Plan Sponsor") are allowed to participate in the Plan. The Plan is a defined contribution 401(k) and profit-sharing plan with a cash or deferred arrangement covering all employees who are 18 years of age or older and have completed one month of service, as defined in the Plan agreement. The plan agreement was adopted on October 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each participant can make pre-tax contributions up to the maximum amount allowed by the Internal Revenue Service (IRS). The IRS' limit was \$23,000 for 2024. Plan participants age 50 and older were eligible to make catch-up contributions of an additional \$7,500 to the Plan for 2024. The Plan also permits participants to make rollover contributions from other qualified plans.

During each Plan year, the Plan Sponsor may make a matching contribution to the participants' accounts. Although it is the intent of the Plan Sponsor to continue making such contributions, the Plan Sponsor is not required to do so. The Plan Sponsor has the right to revoke, suspend, or modify its obligation to make matching contributions upon giving proper notice to all participants at any time during the Plan year. During 2024, the Plan Sponsor matched 5% of the amount contributed by a participant.

In addition to the matching contributions, the Plan Sponsor may make a discretionary profit-sharing contribution that will be allocated using a uniform points allocation-based ratio. Participants receive two points for each year of service, determined in the same manner as the Plan Sponsor contributions vest to the participants. The Plan Sponsor did not make a discretionary match for the year ended December 31, 2024.

Participant Accounts and Investment Options: Participants direct the investment of their contributions into various mutual funds and a guaranteed investment contract fund offered by the Plan. Each participant's account is credited with the participant's contribution, an allocation of the Plan Sponsor's contributions and Plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participant contributions to the Plan and earnings thereon are fully vested at all times. Vesting of Plan Sponsor nonelective contributions is based upon the years of service with the Plan Sponsor as follows:

Forfeitures of nonvested employer contributions are used to pay expenses of the Plan. There was approximately \$6,900 of forfeitures incurred during the year ended December 31, 2024.

Payment of Benefits: Upon termination of employment for reasons other than death, disability, or retirement, the participant is entitled to receive a lump sum payment equal to his or her vested interest or may rollover their vested account balance into an individual retirement account, individual retirement annuity or another employer's tax qualified plan. If the participant's vested benefit in the Plan exceeds \$1,000, the participant must consent to the distribution before it can be made. Participants that have a vested benefit that does not exceed \$1,000 will receive a lump sum payment as soon as practicable following the event entitling the participant to a distribution. Certain early distributions made upon termination of employment may be subject to a penalty.

### NOTE A--DESCRIPTION OF THE PLAN--CONTINUED

Payment of Benefits--Continued: Upon retirement at age 62, retirement due to disability or the death of the participant, the participant or participant's designated beneficiary is entitled to receive the participant's entire account balance. All participants must begin receiving benefit payments upon reaching age 70 ½. Such benefits may be paid in a single lump sum or as an annuity, based on the terms defined in the Plan agreement.

Participants that are employed with the Plan Sponsor that have reached age 59 ½ may receive an in-service distribution of their account balance that is attributable to the participant's contributions to the Plan. In-service hardship distributions must be for a minimum of \$500.

As of December 31, 2024, net assets available for benefits included approximately \$152,000, relating to former participants who have elected, for present time, to leave their balances intact with the Plan.

Notes Receivable from Participants: Participants may borrow from their fund accounts up to a minimum equal to or lesser of \$50,000 or 50% of their vested account balance. The notes receivable are secured by the balance in the participant's account and bear interest at reasonable rates determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan have been prepared using the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits: Benefits are recorded as expenses when paid.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--CONTINUED

Administrative Expenses: Certain administrative functions of the Plan are performed by employees of the Plan Sponsor. Neither the employees nor the Plan Sponsor receives any compensation from the Plan for these services. Certain administrative expenses of the Plan are paid by the Plan Sponsor. Account transaction costs are deducted from participant accounts. Administrative fees for services are first paid with available forfeitures, with any fees in excess of forfeitures paid from the assets of the funds and therefore reduce the overall return offered by the funds.

Income Tax Status: The Plan Administrator believes the Plan is designed and is currently operated in compliance with applicable requirements of the Internal Revenue Code and therefore is qualified and its related trust tax-exempt. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if an uncertain position more likely than not would fail to be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits in progress for any tax periods.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants represent participant loans that are recorded at their unpaid balance plus any accrued but unpaid interest. Interest income on notes receivable from participant is recorded when it is earned. Related fees are recorded as administrative expenses and are expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant's loan balance is reduced and a benefit payment is recorded.

Subsequent Events: Plan management has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued and determined that there were no subsequent events requiring accrual or disclosure.

### NOTE C--STABLE VALUE FUND

The Plan invests in the T Rowe Price Stable Value Common Trust Fund whose underlying assets are fully benefit-responsive investment contracts. This stable value fund seeks to provide preservation of principal and provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The underlying investments of the stable value fund consist of conventional guaranteed investment contracts (GICs) and synthetic guaranteed investment contracts (“wrap contracts”) and cash equivalents.

The GICs are typically issued with a fixed crediting rate and a fixed maturity date that does not change over the life of the contract. Whereas, wrap contracts typically reset on a monthly or quarterly basis as negotiated with the issuer and do not have a final stated maturity date. Gains and losses on the underlying portfolio are amortized over the duration of the investment, through adjustments to the future interest crediting rate. A number of factors can influence future crediting rates of wrap contracts, which may include but are not limited to: portfolio cash flows, underlying portfolio performance, current market interest rates for reinvestment, duration posture, change in credit ratings, default or bankruptcy by an asset or wrap issuer, the unexpected receipt of principal and interest payments, extraordinary withdrawals and certain wrap contract terms, including wrap fees.

There are no participant redemption restrictions for these investments. A 12-month redemption notice period is applicable only to the Plan.

### NOTE D--FAIR VALUE MEASUREMENTS

FASB ASC 820-10-35-39 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10-35-39 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE D--FAIR VALUE MEASUREMENTS--CONTINUED

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded and considered Level 1 investments.

*Stable value fund*: A stable value fund is a form of common collective trust fund which is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of units of the bank collective trust. The net asset value, or contract value, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE E--INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (FMTC), the custodian of the Plan for the year ended December 31, 2024 and 2023 has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

The Plan's independent auditors did not perform audit procedures with respect to this information, except for comparing such information per the custodian's certified statements to the related information included in the financial statements.

### NOTE F--TRANSACTIONS WITH PARTIES-IN-INTEREST

Notes receivable from participants, as well as, certain Plan investments were managed by FMTC, which also served as the Plan's custodian and, therefore, these transactions qualify as party-in-interest transactions under ERISA. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

### NOTE G--INVESTMENT CONCENTRATION, RISK, AND UNCERTAINTIES

As of December 31, 2024, approximately 60% of Plan assets consisted of two mutual fund investments.

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

## Independent Auditors' Report

To the Plan Administrator and Plan Custodians

#### NOTE A--DESCRIPTION OF THE PLAN

The following description of the A&A Trucking, Inc. / General Materials Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: Employees of A&A Trucking, Inc. and General Materials, Inc. (collectively the "Plan Sponsor") are allowed to participate in the Plan. The Plan is a defined contribution 401(k) and profit-sharing plan with a cash or deferred arrangement covering all employees who are 18 years of age or older and have completed one month of service, as defined in the Plan agreement. The plan agreement was adopted on October 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each participant can make pre-tax contributions up to the maximum amount allowed by the Internal Revenue Service (IRS). The IRS' limit was \$22,500 for 2023. Plan participants age 50 and older were eligible to make catch-up contributions of an additional \$7,500 to the Plan for 2023. The Plan also permits participants to make rollover contributions from other qualified plans.

During each Plan year, the Plan Sponsor may make a matching contribution to the participants' accounts. Although it is the intent of the Plan Sponsor to continue making such contributions, the Plan Sponsor is not required to do so. The Plan Sponsor has the right to revoke, suspend, or modify its obligation to make matching contributions upon giving proper notice to all participants at any time during the Plan year. During 2023, the Plan Sponsor matched 5% of the amount contributed by a participant.

In addition to the matching contributions, the Plan Sponsor may make a discretionary profit-sharing contribution that will be allocated using a uniform points allocation-based ratio. Participants receive two points for each year of service, determined in the same manner as the Plan Sponsor contributions vest to the participants. The Plan Sponsor did not make a discretionary match for the three months ended December 31, 2023.

Participant Accounts and Investment Options: Participants direct the investment of their contributions into various mutual funds and a guaranteed investment contract fund offered by the Plan. Each participant's account is credited with the participant's contribution, an allocation of the Plan Sponsor's contributions and Plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participant contributions to the Plan and earnings thereon are fully vested at all times. Vesting of Plan Sponsor nonelective contributions is based upon the years of service with the Plan Sponsor as follows:

Vesting of Plan Sponsor matching contributions is based upon the years of service with the Plan Sponsor as follows:

Two years	50%
Three years	75%
Four years or more	100%

Forfeitures of nonvested employer contributions are used to pay expenses of the Plan. There was approximately \$2,200 of forfeitures incurred during the year ended December 31, 2023.

Payment of Benefits: Upon termination of employment for reasons other than death, disability, or retirement, the participant is entitled to receive a lump sum payment equal to his or her vested interest or may rollover their vested account balance into an individual retirement account, individual retirement annuity or another employer's tax qualified plan. If the participant's vested benefit in the Plan exceeds \$1,000, the participant must consent to the distribution before it can be made. Participants that have a vested benefit that does not exceed \$1,000 will receive a lump sum payment as soon as practicable following the event entitling the participant to a distribution. Certain early distributions made upon termination of employment may be subject to a penalty.

### NOTE A--DESCRIPTION OF THE PLAN--CONTINUED

Payment of Benefits--Continued: Upon retirement at age 62, retirement due to disability or the death of the participant, the participant or participant's designated beneficiary is entitled to receive the participant's entire account balance. All participants must begin receiving benefit payments upon reaching age 70 ½. Such benefits may be paid in a single lump sum or as an annuity, based on the terms defined in the Plan agreement.

Participants that are employed with the Plan Sponsor that have reached age 59 ½ may receive an in-service distribution of their account balance that is attributable to the participant's contributions to the Plan. In-service hardship distributions must be for a minimum of \$500.

As of December 31, 2023, net assets available for benefits included approximately \$198,000, relating to former participants who have elected, for present time, to leave their balances intact with the Plan.

Notes Receivable from Participants: Participants may borrow from their fund accounts up to a minimum equal to or lesser of \$50,000 or 50% of their vested account balance. The notes receivable are secured by the balance in the participant's account and bear interest at reasonable rates determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan have been prepared using the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits: Benefits are recorded as expenses when paid.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--CONTINUED

Administrative Expenses: Certain administrative functions of the Plan are performed by employees of the Plan Sponsor. Neither the employees nor the Plan Sponsor receives any compensation from the Plan for these services. Certain administrative expenses of the Plan are paid by the Plan Sponsor. Account transaction costs are deducted from participant accounts. Administrative fees for services are first paid with available forfeitures, with any fees in excess of forfeitures paid from the assets of the funds and therefore reduce the overall return offered by the funds.

Income Tax Status: The Plan Administrator believes the Plan is designed and is currently operated in compliance with applicable requirements of the Internal Revenue Code and therefore is qualified and its related trust tax-exempt. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if an uncertain position more likely than not would fail to be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits in progress for any tax periods.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants represent participant loans that are recorded at their unpaid balance plus any accrued but unpaid interest. Interest income on notes receivable from participant is recorded when it is earned. Related fees are recorded as administrative expenses and are expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant's loan balance is reduced and a benefit payment is recorded.

Subsequent Events: Plan management has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued and determined that there were no subsequent events requiring accrual or disclosure.

### NOTE C--STABLE VALUE FUND

The Plan invests in the T Rowe Price Stable Value Common Trust Fund whose underlying assets are fully benefit-responsive investment contracts. This stable value fund seeks to provide preservation of principal and provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The underlying investments of the stable value fund consist of conventional guaranteed investment contracts (GICs) and synthetic guaranteed investment contracts (“wrap contracts”) and cash equivalents.

The GICs are typically issued with a fixed crediting rate and a fixed maturity date that does not change over the life of the contract. Whereas, wrap contracts typically reset on a monthly or quarterly basis as negotiated with the issuer and do not have a final stated maturity date. Gains and losses on the underlying portfolio are amortized over the duration of the investment, through adjustments to the future interest crediting rate. A number of factors can influence future crediting rates of wrap contracts, which may include but are not limited to: portfolio cash flows, underlying portfolio performance, current market interest rates for reinvestment, duration posture, change in credit ratings, default or bankruptcy by an asset or wrap issuer, the unexpected receipt of principal and interest payments, extraordinary withdrawals and certain wrap contract terms, including wrap fees.

There are no participant redemption restrictions for these investments. A 12-month redemption notice period is applicable only to the Plan.

### NOTE D--FAIR VALUE MEASUREMENTS

FASB ASC 820-10-35-39 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10-35-39 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE D--FAIR VALUE MEASUREMENTS--CONTINUED

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded and considered Level 1 investments.

*Stable value fund*: A stable value fund is a form of common collective trust fund which is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of units of the bank collective trust. The net asset value, or contract value, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE F--TRANSACTIONS WITH PARTIES-IN-INTEREST

Notes receivable from participants, as well as, certain Plan investments were managed by FMTC, which also served as the Plan's custodian and, therefore, these transactions qualify as party-in-interest transactions under ERISA. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

NOTE G--INVESTMENT CONCENTRATION, RISK, AND UNCERTAINTIES

As of December 31, 2023, approximately 64% of Plan assets consisted of two mutual fund investments.

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.
