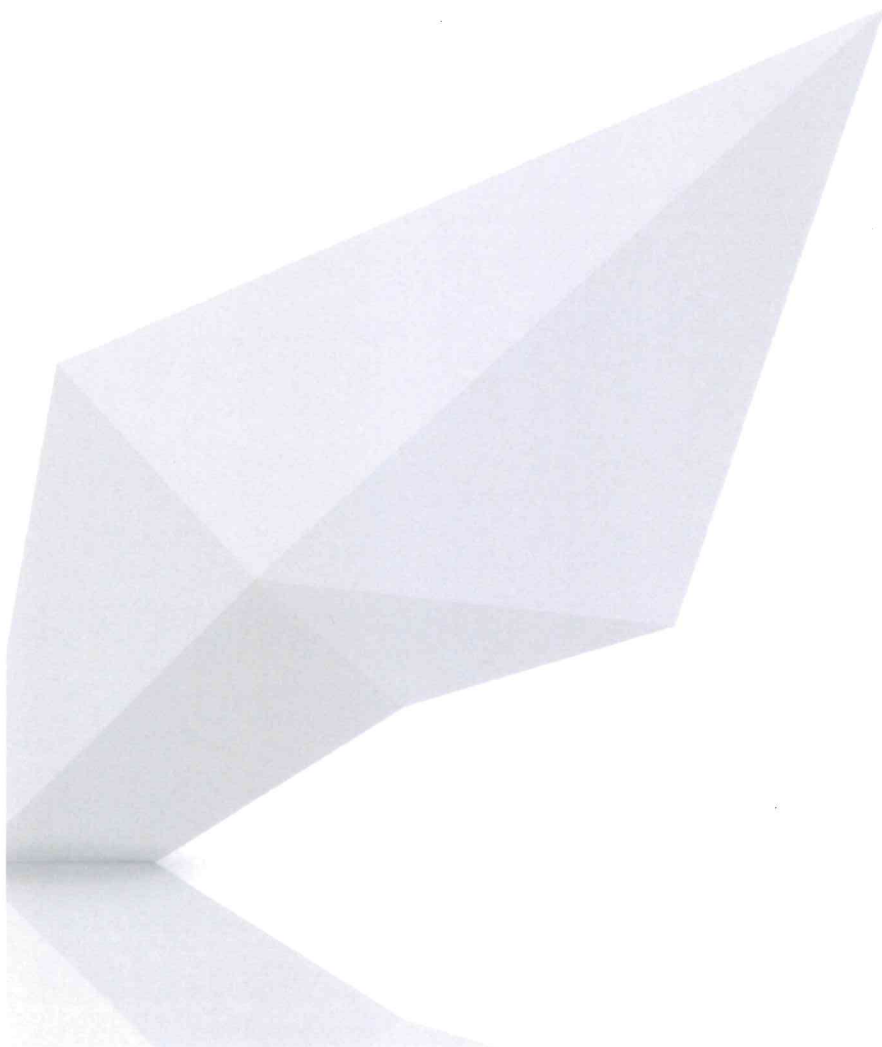

## Notes to Financial Statements

---

### Note 1: Description of Plan

The following description of the Gongos, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan which covers substantially all employees of Gongos, LLC (the "Company" and "Plan Sponsor"), meeting the eligibility requirements discussed below. The Plan is a safe harbor plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Management of the Company is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### SECURE ACT 2.0

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. All provisions of SECURE 2.0 have been and will continue to be evaluated and implemented by plan management in accordance with future regulations and guidance, and the Plan will be amended, as needed.

#### Eligibility

Except for collectively bargained employees, leased employees, and nonresident aliens with no U.S. source income, employees who attain the age of 21 are immediately eligible to participate in the plan as there is no minimum service requirement. Upon meeting the applicable requirement, a participant is eligible to make employee contributions and receive safe harbor Company matching contributions and discretionary Company matching contributions. A participant is eligible to receive a discretionary Company contribution made by the Company if the participant meets the requirement noted below.

#### Contributions

Participants may voluntarily contribute up to 100% of their compensation, as defined by the Plan, not to exceed Internal Revenue Service ("IRS") limitations. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees may directly "roll over" their assets from a qualified plan at a previous Company and transfer the assets into their Plan account.

The Company makes safe harbor contributions and may make discretionary matching contributions to all eligible participants of the Plan. The Company made safe harbor contributions equal to 100% of the employees' elective deferrals up to 3% of their compensation and then 50% of employees' elective deferrals between 3% and 5% of their compensation. Total safe harbor contributions for the Plan year ended December 31, 2024 were \$493,439. Additional discretionary matching contributions were not provided during the year ended December 31, 2024.

The Company may provide additional discretionary Company discretionary non-elective contribution to participants meeting the general eligibility requirements discussed above, as long as they are employed by the Plan Sponsor on the last day of the Plan year. During the year ended December 31, 2024, the Plan Sponsor did not provide discretionary contributions.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's safe harbor and discretionary matching contribution, an allocation of the Company's discretionary non-elective contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participant contributions, Company safe harbor matching contributions, Company discretionary matching contributions, and Company discretionary non-elective contributions and earnings thereon are 100% vested at the date of contribution.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the total vested account balance. A maximum of three loans are allowed outstanding at any time. The notes are secured by the vested balance in the participant's account and bear interest at a rate set by the Plan trustee in accordance with local prevailing rates for similar types of loans, plus 2%. Principal and interest payments are made through payroll deductions over a term not to exceed five years, except for home purchase loan. Loans are only permitted if certain hardship criteria are met. Interest rates on the loans outstanding as of December 31, 2024 ranged from 6.50% - 10.50%.

#### **Payment of Benefits**

Distributions are allowed upon retirement, attainment of age 59 ½, disability or death of the employee, as well as termination of service with the Company. A participant or their beneficiary may elect to receive a lump-sum distribution of their total vested account balance. If a participant is no longer employed by the Company, they may be subject to various force-out provisions depending on the participant's account balance upon the date of valuation after termination.

### **Note 1: Description of Plan (Continued)**

#### **Forfeitures**

There were no unallocated forfeitures as of December 31, 2024 and 2023. Forfeitures are used to reduce future Company contributions, restore forfeited account balances of participants who are rehired, or to pay administrative expenses of the Plan in accordance with the Plan document.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded at December 31, 2024 or 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

### **Note 2: Summary of Significant Accounting Policies (Continued)**

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

#### **Subsequent Events**

The Company has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Information Prepared and Certified by the Custodian**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by John Hancock Life Insurance Company, the Custodian of the Plan.

### **Note 4: Fair Value Measurements**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Pooled Separate Accounts:* Valued at the fair value as published in the John Hancock statements which takes into consideration the fair value of the John Hancock sub accounts. The fair value of the pooled separate accounts consists of the number of units held by the Plan multiplied by the closing unit value quoted by the fund.

*Guaranteed Interest Accounts:* Valued at fair value, which is determined by multiplying book value, which represents contributions made under the contract, plus earnings, less distributions and administrative expenses, by a formula that incorporates prevailing interest rates, as defined in the group annuity contract.

### Note 5: Party-in-Interest Transactions

Certain plan assets are managed by John Hancock Life Insurance Company, the Custodian of the Plan, and, therefore, these transactions qualify as party-in-interest transactions. The Custodian also provided record keeping services for the Plan.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### Note 6: Tax Status

The Company adopted a nonstandard pre-approved document with an IRS notification letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
