Opinion

We have audited the financial statements of MidWestOne Financial Group, Inc. Note 1 - Description of Plan

The following brief description of the MidWestOne Financial Group, Inc. Employee Stock Ownership Plan and Trust (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is an employee stock ownership plan sponsored by MidWestOne Financial Group, Inc. and its wholly-owned subsidiaries, MidWestOne Bank and MidWestOne Insurance Services (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the Internal Revenue Code (IRC), as amended.

The Plan purchases MidWestOne Financial Group, Inc. common stock and holds the stock in a trust established under the Plan. As of December 31, 2024 and 2023, all common stock owned by the Plan was allocated to participant accounts.

Eligibility

Employees of the Company who have attained 18 years of age and have completed one year of service of at least 1,000 hours are eligible to participate in the Plan.

Entry Date

Employees enter the Plan on the first day of January or July coinciding with or following the date they satisfy the Plan's eligibility requirements.

Employer Contributions and Dividends on Company Stock

Employer contributions and dividends on common stock are determined at the discretion of the Company's Board of Directors. Participants must have completed 1,000 hours of service and be actively employed on the last day of the year to receive an allocation of the contribution. For the year ended December 31, 2024, the Company made a discretionary contribution of \$1,030,795.

Participant Accounts

Each participant's account is credited with an allocation of the Company's contributions and Plan earnings or losses and charged with an allocation of administrative expenses. Company contributions to the Plan are allocated based on participant compensation in relation to total compensation for all participants. Plan earnings or losses and most administrative expenses are allocated to the participants based on the ratio each participant's account balance bears to the total account balance of all participants. Certain administrative expenses attributable to a specific participant are allocated directly to that participant's account. The total annual addition made to a participant's account is subject to a limit as specified in the Plan and to the maximum allowed by the IRC.

Vesting

Vesting is based on years of credited service as set forth in the following table:

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$108,767 and \$29,166, respectively. These accounts will be used to reduce future employer contributions or offset plan expenses. During the year ended December 31, 2024, no forfeited nonvested account balances were used.

Diversification

Participants who have reached the age of 55 and have at least 10 years of participation in the Plan may elect to diversify a portion of their account balance that is invested in Company stock. The participant has the option of investment diversification through the distribution of a portion of the account balance or the direct transfer of a portion of the account balance to another qualified plan.

Payment of Benefits

For all terminating participants with a vested balance of \$1,000 or less, benefits are paid in a lump sum payment.

Distributions of remaining benefits are normally made in cash or whole shares of common stock of the Company with the balance representing fractional shares paid in cash. On termination of service, the trustees may distribute a lump-sum amount for the vested portion of the participant's account or make installment payments in specified circumstances. A participant who attains the age of 62 and remains employed by the Company may elect to receive a distribution of up to 25% of their account balance.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to the participant's account. For any matter to be submitted to a vote of stockholders, participants are to provide voting directions to the trustee. With respect to shares of Company stock for which the trustee does not receive timely direction, the trustee is to vote such shares in the same manner and in the same proportion as the shares for which timely instructions were given.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the ERISA. In the event of Plan termination, participants would become 100% vested and the accounts would be paid in the same manner as normal participant retirement or termination.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Unrealized appreciation or depreciation of the MidWestOne Financial Group, Inc. common stock is reflected in the Plan's financial statements. Purchase and sales of securities are recorded on a trade date basis. Dividend income is accrued on the ex-dividend date. As of December 31, 2024 and 2023, the Plan owned 2.1% and 3.0%, respectively, of the outstanding common stock of the Company.

The cash management accounts at December 31, 2023 consisted solely of an investment in MidWestOne Bank Money Market fund.

The classification of investment earnings (losses) reported above and in the statement of changes in net assets available for benefits may differ from the classification of earnings (losses) on Form 5500 due to different reporting requirements on Form 5500.

Payment of Benefits

Benefits payments to participants are recorded when distribution. Amounts allocated accounts of persons who have elected to withdraw from the Plan, but have not yet been paid, were \$-0- and \$106,867 at December 31, 2024 and 2023, respectively.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided in the Plan document. Employees of the Company provide administrative and management services to the Plan without cost to the Plan. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

Note 3 - Investment in MidWestOne Financial Group, Inc. Common Stock

The Plan's investment in MidWestOne Financial Group, Inc. common stock, which was all allocated to participants, at December 31, 2024 and 2023 is as follows:

During 2024, the Plan purchased 39,716 shares of common stock for \$936,185. The Plan sold 62,448 shares of common stock for \$1,574,253. The Plan had distributions in kind of 3,360 shares of common stock for \$74,822.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

MidWestOne Financial Group, Inc. common stock – Valued at the closing price reported on the active market on which the security is traded.

Cash management fund – Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisors, the custodian and other third parties.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by letter dated May 15, 2014, that the Plan was designed in accordance with the applicable regulation of the IRC. Subsequent to the issuance of this determination letter, the Plan was amended. However, the Company and plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related Party and Party-in-Interest Transactions

American Trust Retirement, the Plan’s third-party administrator, and MidWestOne Trust Services, the custodian as defined by the Plan, invest contributions, interest and dividends received and make distributions to participants. As described in Note 2, the Plan paid certain expenses related to Plan operations to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

The Plan received dividends on MidWestOne Financial Group, Inc. common stock of \$449,878, for the year ended December 31, 2024. The Plan held investments in MidWestOne Financial Group, Inc. common stock of \$12,917,710 and \$12,638,174, as of December 31, 2024 and 2023, respectively. The Plan had contributions receivable from MidWestOne Financial Group, Inc. of \$1,030,795 and \$-0- as of December 31, 2024 and 2023, respectively. The Plan held cash management fund accounts with MidWestOne Financial Group, Inc. of \$-0- and \$631,338 as of December 31, 2024 and 2023, respectively.

Note 7 - Risks and Uncertainties

The Plan’s investment in MidWestOne Financial Group, Inc. common stock is exposed to various market risks. Market risks include global events which could impact the value of investments, such as a pandemic or international conflict. Due to the level of risk associated with this investment, it is at least reasonably possible that changes in the value of the investment will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
